INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
Bobbie Noonan's Child Care 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bobbie Noonan's Child Care 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Bobbie Noonan's Child Care 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 Description and Purpose of 401(k) Savings Plan

The inception date of the Bobbie Noonan's Child Care 401(k) Plan (the "Plan") is September 1, 1996. The Plan is a salary reduction plan allowing participants to reduce their compensation and have these amounts contributed to the plan on their behalf. Individual accounts are maintained for each participant to which all contributions are credited. A participant's benefit under such plan is based solely on the fair market value of his or her account balance. The purpose of the plan is to account for resources to be used for retirement annuity or lump sum payments of appropriate amounts at times in the future. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all full-time employees of the Company who are age twenty-one or older except for employees covered under a collective bargaining agreement. Participants are eligible for employer contributions once they have one year of service. Participants can elect to begin deferrals upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. *Contributions.* Each year participants may contribute as much of their pretax annual compensation, defined in the Plan, as they would like up to the maximum allowed under code section 401(k). The maximum allowable contribution per participant for 2024 was \$23,000 except for participants over fifty years of age who are allowed an additional \$7,500. Company contributions are at the discretion of the owners of the Company. The Company contributed 2 1/2% percent of each participant's base compensation in 2024 and 2023. Contributions are subject to certain limitations.
3. *Participant Accounts.* Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or losses, and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings, losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Investment Options.* Participants direct the investment of their contributions as well as the Company contributions into various investment options offered by the Plan. These investment alternatives and their related market values as of December 31, 2024 are identified in the Schedule of Assets (Held at End of Year). Participants may change their investment options online throughout the year.

5. *Notes Receivable from Participants.* During 2015, the loan program was eliminated and no new loans were to be issued. Existing loans are in default and will remain in effect until a distributable event occurs (see Note 5). The loans are secured by the balance in the participant's account and require principal and interest payments quarterly at prevailing interest rates.
6. *Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on three years of continuous service. A participant is 100 percent vested in the Company's contributions after three years of credited service.
7. *Payment of Benefits.* On termination of service due to retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity. On termination of service due to death or disability, a participant becomes 100% vested and may elect to receive either a lump-sum amount or an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
8. *Forfeited Accounts.* Participants who terminate their employment prior to completing three years of service forfeit all employer contributions. These forfeitures are used to reduce future employer contributions. In 2024, employer contributions were reduced by forfeitures in the amount of \$5,059. The forfeited nonvested accounts totaled \$5,384 as of December 31, 2024 and \$7,807 as of December 31, 2023.

Note 2 Summary of Significant Accounting Policies

1. *Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.
2. *Use of Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
3. *Investment Valuation and Income Recognition.* The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Participant loans are valued at their outstanding balances, which approximate fair value. See Note 4 for discussion of fair value measurements.

3. *Investment Valuation and Income Recognition - continued.* Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.
4. *Payment of Benefits.* Benefits are recorded when paid. A participant who reaches age 59½ and who is actively employed by the Company may elect to withdraw all or a portion of the participant's salary deferral contribution account and all or a portion of the participant's employer contribution account if the participant has a 100% vested interest in the account.
5. *Operating Expenses.* Certain expenses of maintaining the Plan, such as audit fees, are paid by the Company and are therefore excluded from these financial statements. Such expenses are not material to the Plan.

Note 3 Asset Certification

Variable Annuity Life Insurance Company is one of the trustees of the Plan and has certified that the assets held by them and managed for the Plan as of December 31, 2024 and 2023, and the related transactions executed for the year ended 2024 as reflected in the financial statements are complete and accurate.

Ameritas Life Insurance Corp. is also one of the trustees of the Plan and has certified that the assets held by them and managed for the Plan as of December 31, 2024 and 2023, and the related transactions executed for the year ended 2024 as reflected in the financial statements are complete and accurate.

Note 4 Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Note 6 Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Variable Annuity Life Insurance Company and Ameritas Life Insurance Corp. Variable Annuity Life Insurance Company and Ameritas Life Insurance Corp. are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

During 2024, the Company terminated more than 20% of their workforce due to the sale of three divisions. As a result, the Company declared a partial plan termination. The participants affected by this partial plan termination automatically became 100% vested in all employer contributions.

Note 8 Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Schedule C, Line 2(h) Formula Description

Description of Unit Value Calculations

Separate account investments are record kept using unit values.

The pooled separate accounts are invested in mutual funds at NAV. The allocation of these funds is based on the units and unit value for each product and plan invested in the pooled separate account.

Both the number of units, and unit value is available for any plan's funds and can be produced from the system. When multiplied, these will balance to the fair value disclosed on trust reports.

The unit value can and does vary by contract depending on the product invested in. The unit value is determined under the following formula, and is the same calculation for all contracts invested in the pooled separate accounts.

It is through this calculation of the unit value that both earnings and expenses are applied.

Industry Standard Method – Unit Value Calculation

t = current business date

t-1 = prior business date

NAV = Net asset value provided by mutual fund company

MTD daily dividend factor(t) = dividends month to date as provided by the mutual fund company

Declared dividend rate(t) = as provided by the mutual fund company

Short and long term capital gains (t) = S<(t) = as provided by the mutual fund company

Gross Investment Factor (GIF) = daily rate change in the NAV including dividends and capital gains

Daily Expense Factor = the expense rate specific to a contract

Net Investment Factor = the daily rate change in the gross investment factor after application of contract specific expenses

Unit Price = the contract specific price in which units are purchased and redeemed for a specific fund

In order to ensure that each contract has a correct proportionate value of the underlying pooled separate account, each contract's units are multiplied by their contract's unit value and summed across all contracts invested in a particular mutual fund. This is then balanced to the pooled separate account and to the mutual fund company on a daily basis.

The Daily Expense Factor is based on the provisions of the contract, with all investments held by Ameritas Life Insurance Corp being charged the same annualized rate.
