## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the Steel Equipment Specialists LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

#### **Note 1. Summary of Significant Accounting Policies**

**Basis of Accounting** – The Steel Equipment Specialists LLC 401(k) Plan ("Plan") financial statements are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – All investments of the Plan are in mutual funds, or fixed annuities held by Empower Trust Company, LLC, as directed by the participant. These investments are stated at their quoted closing market price reported by Empower Trust Company, LLC, Custodian of the Plan. These amounts are not adjusted for market volatility from December 31, 2024 to the date of our report.

**Purchases and sales of mutual funds, fixed annuities, and common/collective trusts** are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Administrative Expenses** – The Plan is responsible for payment of certain administrative fees; however, Steel Equipment Specialists LLC ("Company"), the plan sponsor, at its discretion, may assume certain fees.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – The Plan has evaluated subsequent events through July 17, 2025, which is the date the financial statements were available to be issued.

#### **Note 2. Description of Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan covering all U.S. based full-time employees of the Company. Effective January 1, 2006, employees automatically enroll in the plan with a 3% deferral on the first day of the pay period following 90 days of service. Employees must submit a form to opt out of the 3% deferral. Employees become eligible to participate in the Plan following attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective October 1, 1985.

**Note 2. Description of Plan (Continued)**

Contributions:

The Company allows participants to make both pre-tax contributions and Roth elective contributions in any amount up to the limitations allowed by the Internal Revenue Code ("IRC"). The Company makes annual discretionary matching contributions. During 2024 and 2023, the Company's contributions were equal to 100% of amounts (up to 3% of compensation subject to IRC limitations) and 50% of amounts (on the next 2% of compensation subject to IRC limitations) contributed by participants. If needed, an accrual is established at the end of the year to assure the Company has matched individual contributions. As of December 31, 2024 and 2023 the Company has accrued employer contributions of \$66,568 and \$0, respectively, to ensure the 100% match on 3% and 50% on the next 2% of compensation is made both by pay and in total.

In addition, the Company has the right to make additional discretionary contributions to the Plan. These contributions shall be unrelated to any employee contributions made during the Plan year and shall be distributed to employees on a pro rata basis of compensation, as defined and subject to IRC limitations. No discretionary contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts:

Participants' accounts are credited with their contributions and the Company's contribution along with an allocation of investment income and administrative expenses. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting:

A participant has a 100% non-forfeitable vested interest in his/her portion of salary deferrals and profit-sharing contributions. Vesting in the Company's matching contribution is based on years of continuous service as follows:

**Note 2. Description of Plan (Continued)**

Forfeitures:

Forfeitures may first be used to pay plan related expenses. Any forfeitures left after paying plan expenses are used to offset company contributions. At December 31, 2024 and 2023, unutilized forfeited non-vested accounts were immaterial. During 2024 and 2023, there were no reductions to employer contributions from forfeited non-vested accounts.

Payment of Benefits:

A participant or his/her beneficiary, upon termination, death, disability, or retirement, receives his/her vested interest in his/her account in the form of cash or an annuity. Additionally, the Plan has provisions for an active participant to make hardship withdrawals from his/her account, subject to limitations and restrictions.

Investment Fund Options:

Investment alternatives include various mutual funds, fixed annuity and common/collective trusts. The participant may select from among the various available alternatives and change that selection at any time.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants shall be fully vested in their accounts and will receive a total distribution of the balances in their respective accounts.

**Note 4. Federal Income Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for assets of the Plan measured at fair value at December 31, 2024 and 2023.

- Mutual Funds: Valued at their quoted closing market prices in active markets for identical investments and classified as Level 1.
- Fixed Annuity: Valued daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider and classified as Level 2.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There has been no change in methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
