### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Venminder 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of March 1, 2025, December 31, 2024, and December 31, 2023, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to March 1, 2025, and for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1—Description of the Plan

The following description of the Venminder 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan was a defined contribution plan covering all eligible employees of Venminder, Inc. (the "Company" or "Employer"). Employees must have attained age 18 to be eligible to participate in the Plan. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company was acquired by Ncontracts LLC in September 2024 and all employees of the Company became employees of Ncontracts LLC by January 1, 2025. As a result, there were no contributions made to the Plan subsequent to December 31, 2024. Effective as of the end of day March 1, 2025, the Plan was merged into the Ncontracts 401(k) Plan and all participant balances were transferred.

*Administration* – The Plan Sponsor had designated certain employees, who served without additional compensation, to administer the Plan. The Plan administrator had the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and could designate one or more individuals to perform those responsibilities.

*Contributions* – Participants could elect to contribute, on a pre-tax or Roth after-tax basis, up to the maximum compensation permissible under the Internal Revenue Code ("IRC"). The Plan provided for newly eligible employees to be automatically enrolled into the Plan. For those eligible employees who were automatically enrolled, a pre-tax deferral in the amount of 3% of eligible compensation was contributed to the Plan unless the employee elected a different percentage or elected to not contribute to the Plan. This automatic deferral percentage was increased by 1% annually unless otherwise elected or until a deferral of 6% was met.

The Company could make discretionary contributions to the Plan. For the 2024 Plan year, the Company made a discretionary matching contribution equal to 50% of the first 6% of compensation each eligible participant contributed to the Plan. No other additional discretionary contributions were made for the 2024 Plan year. Participants could also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Contributions were subject to certain limitations.

*Participant Accounts* – Individual accounts were maintained for each Plan participant. Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings, as applicable. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, specific participant transaction costs or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

*Vesting* – Effective January 1, 2023, participants were immediately vested in their entire account balance.

*Investment Options* – Upon enrollment in the Plan, participants could direct the investment of their accounts into various investment options offered by the Plan. They could change their investment options among those investments provided at any time during the Plan year.

*Notes Receivable from Participants* – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Generally, the term of the loan could not exceed five years. However, if the loan was for the purchase of a participant's principal residence, the Plan administrator could permit a longer term. The loans were secured by the balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest was repaid ratably through payroll deductions.

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Upon termination of service or attaining normal retirement age, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments not exceeding the participant's life expectancy. In-service and hardship withdrawals were also allowed as defined in the Plan agreement.

*Forfeited Accounts* – The non-vested portion of former participants' accounts could be used to pay administrative expenses of the Plan or to reduce the amount of employer contributions. Forfeiture activity was inconsequential for the period from January 1, 2025 to March 1, 2025, and for the Plan year ended December 31, 2024.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value as discussed in Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Payments of Benefits* – Benefits are recorded when paid. There were no benefits payments requested and not year disbursed as of March 1, 2025, December 31, 2024, and December 31, 2023.

*Administrative Expenses* – Administrative expenses of the Plan are paid by the Company or Plan participants, as defined in the Plan agreement.

*Investment Management Fees and Operating Expenses* – Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of investments.

*Corrective Distributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the IRC, and related earnings thereon, that are required to be refunded prior to December 31 of the subsequent year.

### **Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company ("Voya"), a qualified institution, has certified to the completeness and accuracy of the following data included in the accompany financial statements.

- Investments at fair value, and investments at contract value as shown in the statements of net assets available for benefits as of December 31, 2024, and December 31, 2023.
- Net appreciation (depreciation) in fair value of investments, and interest and dividends as shown in the statements of changes in net assets available for benefits for the period January 1, 2025 to March 1, 2025, and for the year ended December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements.

### **Note 4—Fair value measurements**

U.S. GAAP provides the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at March 1, 2025, December 31, 2024, and December 31, 2023:

*Pooled Separate Accounts ("PSAs")* – Valued at the net asset value ("NAV") of units held by the Plan at year end provided by the issuer of the account. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised, primarily, of shares of mutual funds at December 31, 2024 and 2023, respectively. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. The investments were redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. All investments were liquidated as of March 1, 2025.

The preceding method described could have produced a fair value calculation that was not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

#### **Note 5—Fully benefit-responsive investment contract**

The Plan had a fully benefit-responsive investment contract with Voya. Voya maintained the contributions in a general account. Specific securities within the general account were not attributed to the investment contract with the Plan. The general account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract was included in the financial statements at contract value as reported to the Plan by Voya. Contract value was the relevant measurement attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Voya's determination of credited interest rates reflected a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment could apply to amounts withdrawn at the request of the contract holder. The guaranteed investment contract did not permit Voya to terminate the agreement prior to a breach of the contract terms by the investor.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The contract was terminated and the investment liquidated as of March 1, 2025.

#### **Note 6—Related party and party-in-interest transactions**

Certain administrative services were provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan were paid by the Company. The Plan had entered into various service agreements with parties-in-interest. It invested in pooled separate accounts and a guaranteed investment contract managed by Voya, the custodian of the Plan. These transactions as well as notes receivable from participants and related activity qualified as party-in-interest.

#### **Note 7—Income tax status**

The Internal Revenue Service ("IRS") ruled on June 30, 2020, that the pre-approved plan, upon which the Plan was based, is designed in accordance with applicable sections of the IRC. The Plan had been amended since receipt of the determination letter. However, the Plan administrator believes the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 1, 2025, December 31, 2024, and December 31, 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
