**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Chrome Deposit Corporation 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of Chrome Deposit Corporation (“the Company”) who are age 18 and who have been employed at least six months. The Plan was established January 1, 1985 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended.

Contributions: Participants may contribute a portion of their eligible compensation, subject to certain limitations imposed by the Internal Revenue Code. For participants not covered under a Collective Bargaining Agreement (“CBA”), the Company contributes a Safe Harbor match of 100% of employee deferrals up to 3% of eligible compensation and 50% of employee deferrals exceeding 3% but no more than 6% of eligible compensation. For participants covered under a CBA, the Company contributes Non-Safe Harbor Matching Contributions. The employer makes a matching contribution for collective bargaining (union) employees as determined under the current collective bargaining agreement limited to \$1,200 per participant for Portage. Additionally, the Portage union employees are eligible for an additional Company contribution as defined in the Portage CBA. The Company contributed \$1,400 per participant as the additional contribution for the Portage location union employees in 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on the participant’s eligibility and the participant’s compensation, contributions, and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Retirement, Death, and Disability: A participant is entitled to 100% of their account balance upon retirement, death, or disability.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 from their accounts up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms for note receivable from participants range from one to five years or longer under certain provisions of the Plan. Notes receivable from participants are secured by the vested balance in the participant’s account and bear interest at prime rate plus 1.00% when not in default. Principal and interest are repaid through payroll deductions.

Vesting: Participants’ voluntary contributions are 100% vested immediately upon entering the Plan. The Company’s Safe Harbor matching contributions are 100% vested after two years of service. The Company’s Non-Safe Harbor matching contributions vest at 20% per year beginning after two years of service and are 100% vested upon six years of service.

Administrative Expenses: The Plan’s recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

Payment of Benefits: On termination of service, the participant may choose to receive a lump-sum payment or a partial withdrawal. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2 or for hardship purposes.

Forfeitures: On the date a terminated participant receives or is deemed to receive a distribution, the portion of the participant's employer contributions that was not fully vested is forfeited. During 2024, approximately \$86,000 of forfeitures were used to offset employer contributions. Forfeitures are used to reduce any future employer contributions. There were \$5,087 and \$77,573 of forfeitures available to offset future contributions at December 31, 2024 and 2023, respectively.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Risks and Uncertainties: The Plan provides for various investments that, in general, are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility risks. Due to the level of risk and uncertainty associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the participants' individual account balances.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Benefit Payments: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Benefits are recorded when paid.

**NOTE 3 - INCOME TAX STATUS**

The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020 indicating that the volume submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 4 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

**NOTE 5 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework provides a fair value hierarchy that prioritizes the inputs using valuation techniques used to measure fair value.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following description of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Stable value and collective trusts:* The fair values of participation units held in stable value and collective trusts are based on the net asset values per unit as reported by the fund managers. The stable value and collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Professional services for the audit of the Plan and administrative services provided by the custodians were paid by the Company. The Plan pays FuturePlan by Ascensus administrator fees for acting as a contract administrator for the Plan.

Empower Trust Company, LLC is the Plan's service provider and, therefore, the Plan's payment of record keeping fees, and investment management fees qualify as party-in-interest transactions. During the year, the Plan also paid investment management fees to CapFinancial Partners, LLC and Empower Advisory Group, LLC.

Notes receivable from participants also reflect party-in-interest transactions.
