To the Participants in and Administrator of

Audit Report

We have performed audits of the accompanying financial statements of Pacific Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Pacific Companies 401(k) Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pacific Companies 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTE A – DESCRIPTION OF PLAN

The following description of the Pacific Companies 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan became effective January 1, 1994 with approval of the Board of Directors of Camelback Systems, Inc. (Plan Sponsor) as a multiple-employer plan for the exclusive benefit of the employees of Camelback Systems, Inc. and related adopting employers (collectively referenced as the “Company”). The Plan is a defined contribution plan covering all eligible employees of the Company that have completed at least one month of service during eligibility computation period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to 90% of annual compensation (as defined in the Plan) up to the limits defined by law. There are two types of contributions: pre-tax deferrals and Roth contributions deferred to the Plan on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Employers of the Plan may make discretionary matching and discretionary non-elective contributions each year to the Plan. For the year ended December 31, 2024, employer discretionary matching contributions totaled approximately \$261,918. Contributions are subject to certain limitations as defined by the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employers’ discretionary matching contributions and discretionary non-elective contributions portions of participant accounts, plus actual earnings thereon, is based on years of credited service. A participant becomes 100% vested after two years of credited service, as defined, upon reaching normal retirement age, as defined, or upon death or disability.

Payment of Benefits – Upon a participant’s termination of service due to death, disability, attaining normal retirement age, as defined, or for any other reason, a participant may elect to receive a lump-sum payment or installment payments, as defined, in an amount equal to the value of the participant’s vested interest in his or her account.

Notes Receivable from Participant – Subject to certain limitations in the plan document, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024, participant loans have interest rates ranging from 5.50% to 8.00%.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements. Interest income is recorded on the accrual basis. Net change in fair value of investments includes realized and unrealized gains and losses on investments.

Notes Receivable – Certain investments of the Plan are interests in unrelated third-party notes receivable secured by deeds of trust backed by real property and personal guarantees of the borrowers. The real estate securing the notes receivable is in multiple states and includes a diversified mix of land, triple net deals, shopping centers, commercial, industrial, and non-owner-occupied residential property. The real estate may be held for resale, under improvement, or new construction, and may also be income producing real estate. The notes receivable bear interest at rates ranging from 9.00% to 12.00%. The notes receivable typically require monthly payments, either interest only or amortized principal plus interest, with remaining principal and any accrued interest due upon maturity. The promissory notes contain a provision to convert to month-to-month terms at maturity at the election of the trustee, which is allowed on a case-by-case basis. Payments received on past due notes receivable are generally first applied to penalties and costs, then to any unpaid interest, and lastly to the unpaid principal balance. The Plan's interest in the notes receivable is regularly a first beneficiary trust position in the collateralized real property of the notes receivable.

Equity Investments – Partnership Interest – The Plan has interests in equity investments which are in limited liability companies. The assets of the limited liability companies consist of undeveloped land and commercial property, which have been recorded at fair value.

Equity Investments – Stock Fund – The Plan has an equity investment in a limited partnership. The assets of the limited partnership consist of debt and equity securities, which have been recorded at fair value.

Payment of Benefits – Benefits are recorded when paid.

Administration Expenses – Certain administrative expenses of maintaining the Plan are paid by the Company. Fees related to distribution and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan's sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of whole or partial plan termination; participants would become fully vested as to the amount credited to their accounts after deductions for estimated liquidation and distribution expenses.

NOTE D – RISKS AND UNCERTAINTIES

The Plan invests in percentage interests in notes receivable, which are secured by real property. These investments are exposed to various risks, such as fluctuations in the real estate market and the creditworthiness of borrowers. Due to the risks associated with these investments, it is possible that market changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE E – TAX STATUS

The Plan uses a non-standardized pre-approved plan document sponsored by CCH Incorporated DBA FTWilliam Com and has received an advisory letter dated June 30, 2020 from the Internal Revenue Service which states that the non-standardized pre-approved plan's form satisfies the applicable provisions of the Internal Revenue Code. The non-standardized pre-approved plan's opinion letter has been relied upon by the Plan. The Plan administrator believes the Plan is being operated in compliance with the applicable requirement of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods in progress.

The Department of Labor (DOL) began an audit of the Plan for plan years 2018-2020 in May 2021 and the Plan administrator received a summary findings letter on February 10, 2023. On March 2, 2023, the Plan's legal counsel responded to the DOL's letter and Plan management and legal counsel believe the Plan is designed and is currently being operated in compliance with the applicable regulatory requirements.

The Plan received another summary findings letter from the DOL on April 18, 2024. On April 30, 2024, the Plan's legal counsel responded to the DOL's letter and Plan management and legal counsel believe the Plan is designed and is currently being operated in compliance with the applicable regulatory requirements.

On December 20, 2024, the Plan submitted Form 5330 to pay excise taxes relating to the deposit of Plan monies into a newly established bank account in the Plan Sponsor's name.

NOTE F – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) *820 Fair Value Measurements and Disclosures* (ASC 820), provides the framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Notes receivable – The fair value of each note receivable is based upon the ability of the Plan to collect the Plan’s percentage interest in the total loan proceeds issued to the borrower. If management considers default to be probable, the fair value determination also considers the marketability of the real estate securing the loan, as discussed below.

Equity Investments – Partnership Interest – The fair value of each partnership interest investment is based upon management’s review of the marketability of the percentage interest in the partnership interest investment and the ability of the Plan to sell a percentage interest in a certain partnership interest investment in a market transaction. The fair value determination also considers management’s review of each company’s assets (previously consisting mainly of undeveloped land and commercial property), the marketability of the property which includes review of the specific characteristics of the properties and estimated values by a real estate broker using prices and other relevant information generated by market transactions involving comparable real property. The property has been sold and partnership holdings now consist of cash holdings.

Equity Investments – Stock Fund – The fair value of partial ownership interest in a limited partnership, which invests in debt and equity securities in multiple markets, is based on the fair value of the underlying investments held by the limited partnership, as reported in the audited financial statements of the limited partnership.

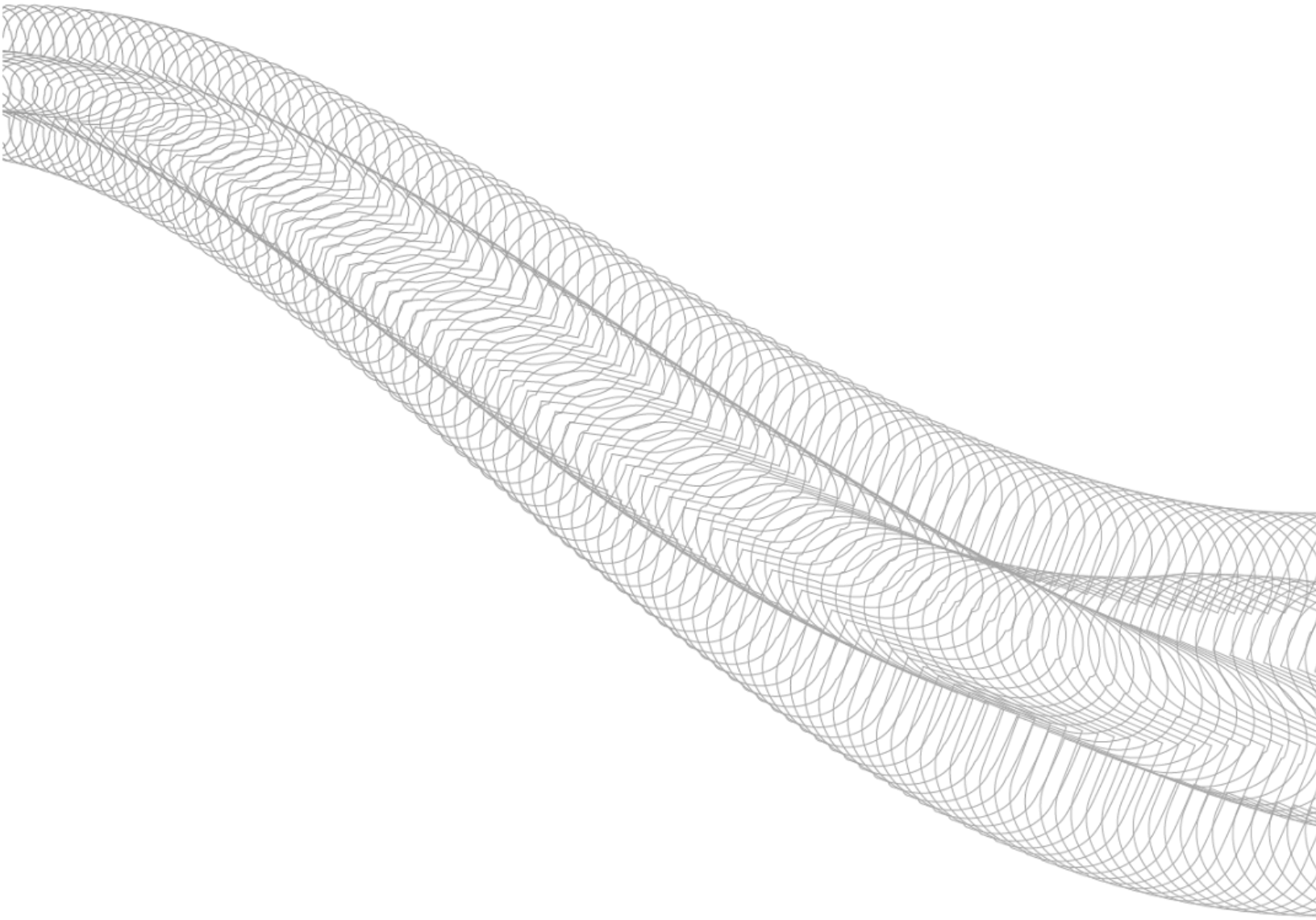
