### Report on the Audit of the Financial Statements

#### *Opinion*

We have audited the accompanying financial statements of Kraus-Anderson, Incorporated Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Kraus-Anderson, Incorporated Health and Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Kraus-Anderson, Incorporated Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 30, 1981, and was most recently restated effective January 1, 2024. The Plan provides medical, dental, life and long-term disability benefits to employees and their eligible dependents. The Plan also allows participants to elect pre-tax salary reductions subject to the requirements of Internal Revenue Code (IRC) §125, which can be applied towards group coverage or health care costs. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan covers employees of Kraus-Anderson, Incorporated (the Plan Sponsor) including divisions and subsidiary companies (collectively, the Company). The Plan is funded by Company and employee contributions through the Kraus-Anderson, Incorporated Voluntary Employees' Beneficiary Association Trust (VEBA).

Effective January 1, 2024, the Plan was restated and the following changes were made as a result of that restatement:

- Name of the Plan changed to Kraus-Anderson, Incorporated Health and Welfare Plan (formerly known as Kraus-Anderson, Incorporated Health Care Plan).
- Short-term disability changed from a voluntary option to a Company sponsored benefit.
- Coverage start date was changed to the 1<sup>st</sup> of the month following hire date.
- Added Kraus-Anderson Insurance Agency, Inc. as a participating employer.

**Plan Benefits**

All full-time employees scheduled to work an average of 30 hours per week and their covered dependents are eligible for coverage the 1<sup>st</sup> of the month following hire date (30-day waiting period prior to January 1, 2024) for medical and dental benefits, Company paid benefits (life insurance, long-term and short-term disability, accidental death and dismemberment, and the employee assistance plan) and in the health care flexible portion of the Plan. The health care flexible portion of the Plan provides expense reimbursement for doctors' services, hospital charges, prescription drugs and other medical costs. The Plan also provides these benefits to separated employees through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan does not provide post-retirement medical benefits.

**Plan Benefits (Continued)**

The Company has contracted with Health Partners to provide administrative claims payment services for medical and prescription benefits which are self-insured. Basic benefits are paid on a published schedule. The Company has entered into a contract with Lincoln Financial Group for fully insured life, accidental death and dismemberment, long-term and short-term disability under the Plan. The Company has entered into a contract with Lincoln Financial Group for fully insured voluntary vision, voluntary life, voluntary accidental death and dismemberment and voluntary critical illness. The Company has entered into a contract with Health Partners for a fully insured voluntary dental plan. The contract also includes flexible Plan provisions and the Company has contracted with Health Partners to provide administrative claims payment services for the flexible benefits.

**Funding Policy**

The Plan is funded by periodic assessments to the Company based upon actual claims incurred and premiums assessed. Such contributions provide for the payment of benefits for the self-funded portion of the Plan, administrative costs, and insurance premiums. Employees also contribute specified amounts for coverage, which are determined periodically based on the coverage elected and number of covered dependents.

**Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Cash**

Cash was held at financial institutions located in Minnesota as of December 31, 2024 and 2023. The balances in these accounts may at times exceed federally insured limits. The Plan has not experienced losses on such accounts.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Certificates of deposit are classified as held-to-maturity. The held-to-maturity certificates of deposits and money market accounts are recorded at amortized cost, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. See Note 3 for discussion of fair value measurements.

**Payment of Benefits**

Premiums paid by the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits and benefit obligations. Claim payments are recorded when paid by Health Partners. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to Health Partners in the accompanying statements of net assets available for benefits and benefit obligations.

**Administrative Expenses**

The Company pays certain administration expenses on behalf of the Plan. All other administration, claims provider, audit and legal fees are paid by the Plan. The Plan administrative fees are reported on the statements of changes in net assets available for benefits and benefit obligations.

**Benefit Obligations**

Payments for claims are recorded by the Plan when paid. Self-funded claims that have been incurred on which benefit payments have been and/or will be made subsequent to that date are labeled as "estimated claims incurred but not reported." Estimated claims incurred but not reported are based on management judgment and information available regarding claims incurred during the Plan year, claims three-month lag history, claims paid subsequent to year end, and similar restrictions on benefits and other trend factors.

**Stop-Loss Insurance**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. Premiums for stop-loss insurance are included in insurance premiums in the accompanying statements of changes in net assets available for benefits and benefit obligations. Stop-loss refunds have been netted with claims paid in the accompanying statements of changes in net assets available for benefits and benefit obligations. Total stop-loss refunds were \$59,789 and \$687,357 for the years ended December 31, 2024 and 2023, respectively.

**Risks and Uncertainties**

The Plan invests in various investment securities. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

The liability for estimated claims incurred but not reported is based on certain assumptions pertaining to health care trend rates, claims lag and historical claims data. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

*Certificate of deposit and money market account:* Carried at amortized cost. Fair value is estimated by quoted prices for similar assets in active markets (Level 2 inputs).

**NOTE 4 TAX STATUS**

The trust established under the Plan to hold the Plan's assets qualifies as a VEBA under 501(c)(9) of the IRC and, accordingly, the trust's investment income is exempt from income taxes. The trust has obtained a favorable tax exemption letter dated May 15, 1981, from the Internal Revenue Service (IRS). The Plan has been amended and restated since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

**NOTE 4 TAX STATUS (CONTINUED)**

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
