***APPENDIX II. SUMMARY OF PLAN PROVISIONS***

**A. Effective Date**

The original effective date of the Plan was October 19, 2000. The Plan was amended and restated effective January 1, 2012. The most recent plan amendment was effective June 26, 2018.

**B. Eligibility**

Employees eligible to participate in the Plan are those employees covered by Local 830. Participation in the Plan is frozen as of January 16, 2001.

**C. Normal Retirement Date**

A participant's normal retirement date is the first day of the month following or coinciding with the attainment of age 62.

**D. Retirement Benefit**

For participants who were at least 55 on January 16, 2001 and who elected to continue to participate in the Plan, \$36 times Years of Credited Service.

For all other participants, \$33 times Years of Credited Service. For this group, all accruals in the Plan were frozen as of March 31, 2001.

**E. Early Retirement Date**

A participant's early retirement date is the first day of the month following the completion of ten years of Vesting Service.

**F. Early Retirement Benefit**

Upon early retirement after turning age 55, a participant is eligible to receive a reduced monthly benefit equal to their normal retirement benefit reduced by 0.25% per month from normal retirement.

Upon early retirement before turning age 55, a participant is eligible to receive a reduced monthly benefit equal to their reduced age 55 benefit, actuarially reduced for commencement prior to age 55.

**G. Normal Form of Benefit**

Unless an alternate election is made, benefits paid to single participants will be in the form of a life annuity with 5 years guaranteed. Benefits paid to married participants will be in the form of a 50% joint & survivor annuity.

**H. Vesting**

Participants will be 100% vested after five years of service.

**I. Disability**

Participants totally and permanently disabled may receive their benefit based on service at date of disability, actuarially reduced for commencement prior to normal retirement age and offset by any Workmen's Compensation distribution.

**J. Pre-Retirement Death Benefits**

For participants who die prior to termination of employment: Same as normal retirement benefit, based on service at date of death, actuarially reduced for commencement prior to normal retirement age and the age of the beneficiary.

For participants who die after the termination of employment: Surviving spouses will receive the benefit required by the Retirement Equity Act, which is the spouse's portion of the 50% joint and survivor annuity that would have been payable had the participant terminated employment on his or her date of death, survived to their earliest possible retirement date and begun receiving benefits as a 50% joint and survivor annuity. This benefit is payable at the earliest date the participant could have retired under the Plan.
