NOTE 1 - Description of Plan

The following description of KeyBridge Technologies 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution Plan covering all full-time employees of the Company who are age twenty-one (21) or older. Plan admission is available on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Employee Contributions

Each year, participants may contribute up to 100% of the participant's compensation up to the federal limits. For the year 2024, the federal limit was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution Plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future elective deferral contributions as Roth elective deferral contributions.

Employer Contributions

The percentage of elective deferral contributions matched, if any, shall be a percentage determined by the Company's board of directors and shall apply to all eligible persons for the entire Plan year. During the year ending December 31, 2024, the Company's contribution to the Plan was \$71,682.

NOTE 1 - Description of Plan (Cont.)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A year of vesting service is achieved when an employee has at least 1,000 hours of service during the year. A participant is 100% vested after five years of credited service. The vesting Plan is as follows:

<u>Vesting Service</u>	<u>Vesting Percentage</u>
1 Year	0%
2 Years	25%
3 Years	50%
4 Years	75%
5 Years	100%

Payment of Benefits

On termination of service due to death, disability or reaching normal retirement age, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial payments not to exceed 5 years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, there were forfeitures of non-vested accounts totaled \$4,552 and \$4,039 respectively. Forfeited amounts may first be used to pay Plan expenses. Any forfeiture left after paying Plan expenses are used to offset future employer contributions. For the year ending December 31, 2024, forfeitures from nonvested accounts were included in administrative fees.

Investment Options

The assets of the Plan are allocated to the various funds at the direction of the participants. All investments are either in a general fund account (guaranteed interest account) or a registered investment company (e.g., mutual funds). The guaranteed interest account provides a guaranteed interest rate for a specified period of time as determined by the sponsor's retirement Plan. The registered investment company values are determined at the close of each business day, based on market value. All investments of the Plan are participant-directed.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies (Cont.)

Investment Valuation and Income Recognition

The Plan investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions

Excess contributions made by participants for contributions in excess of amounts allowed by the IRS are recorded as a benefit paid to participants in the year the correction was made.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through July 9, 2025, which is the date the financial statements were available to be issued. Management concluded that there are no subsequent events that have occurred that would require recognition or disclosure in the financial statements.

NOTE 3 - Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Empower Annuity Insurance Company of America (Empower Annuity). Empower Annuity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$39,514 for the year ending December 31, 2024. The Plan participants did not purchase any assets managed by the custodian during 2024.

The Company provides certain administrative services to the Plan for which no fees are charged.

NOTE 4 - Investment Contract with Insurance Company

The Plan entered into an investment contract with Empower Annuity Insurance Company of America (Empower) that is not considered benefit responsive. Empower is a broker under its trademark name Empower Trust Company (Empower). Empower is the investment manager for the investments for the Plan in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. At December 31, 2024 and 2023, investment contracts with an insurance company were \$113,317 and \$164,705 respectively.

NOTE 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 5 - Fair Value Measurements (Cont.)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The guaranteed investment contract with Empower Annuity Insurance Company: Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering credit-worthiness of the issuer.

NOTE 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7 - Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
