**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following description of the Curtis Lumber Co., Inc. Employee Savings & Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and profit sharing plan that qualifies as a cash or deferred arrangement under Section 401(k) of the Internal Revenue Code. Effective October 1, 2023, the Plan is extended to all employees of Curtis Lumber Co., Inc. (Company and Plan Sponsor) who have completed at least 30 days of service. Prior to October 1, 2023, the Plan was extended to all employees of the Company who had completed at least 90 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Contributions Receivable

Participants may elect to contribute, on a pre-tax basis (elective deferrals), from 1% to 80% of their pay up to a maximum calendar year limit. The Company may make a qualified matching contribution to the Plan on behalf of the participants equal to a discretionary percentage of the employees' salary deferrals. The matching contribution may also be limited to salary deferrals of a certain amount or a certain percentage of the employees' compensation. In 2024 and 2023, the matching contribution was 50% of employee deferrals up to 5% of employees' compensation. Employer matching contributions amounted to \$965,949 and \$1,000,079 for the years ended December 31, 2024 and 2023, respectively.

At its discretion, the Company may also contribute a profit sharing contribution to the Plan for each employee that meets the eligibility requirements. For the years ended December 31, 2024 and 2023, the Company's profit sharing contribution amounted to \$373,687 and \$378,292, respectively.

Investments

The Plan currently offers twenty-six (26) mutual funds through a regulated investment company and two (2) common collective investment trust funds. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, along with an allocation of (a) the Company's contributions, and (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The entitled benefit is the participant's account balance subject to vesting.

Vesting

Participants are immediately vested in their voluntary contribution, plus actual earnings/losses thereon. Vesting in the Company profit sharing contribution and employer matching contribution portion of individual accounts, plus earnings thereon, is based on years of continuous service. For the employer matching contribution and the profit sharing contribution, a participant becomes 100% vested after three years of service. The Company does not have an incremental vesting schedule therefore participants are fully vested after they complete the minimum years of service.

1. DESCRIPTION OF PLAN (Continued)

Vesting (Continued)

The nonvested portion of a participant's account shall be forfeited as of the end of the Plan year in which the participant has 5 or more consecutive 1-year breaks in service or at the time of distribution of the participant's vested interest, if earlier.

Forfeitures

Forfeitures are used to offset the employer contributions. During 2024 and 2023, forfeitures from nonvested accounts were \$44,180 and \$37,174, respectively. As of December 31, 2024 and 2023, the balance of forfeited nonvested accounts available to be used to reduce future employer contributions was \$48,156 and \$34,625, respectively. In 2024 and 2023, employer contributions were reduced by \$31,651 and \$49,722 from forfeited nonvested accounts, respectively.

Benefits

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for early retirement, disability, and termination benefits. The Plan provides for payments of benefits in an amount equal to the participant's vested portion of the Company contributions and investment income, plus any employee contributions and related investment income. Benefits may be paid as a lump sum payment in cash or in equal installments over a period of assumed life expectancy at the time of distribution.

Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer from the investment fund to the participant notes fund. Generally, loan terms range from several months to 5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 5 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1%. Principal and interest are paid ratably through payroll deductions, which cannot be less frequently than quarterly.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America require management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes in those assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds. The collective investment trust funds are measured using the net asset value (NAV) per share practical expedient as determined by the issuer based on current fair values of the underlying assets of the funds as of December 31, 2024 and 2023.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies into a three level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end based on quoted market prices.

Collective investment trusts: Valued based on the fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the funds.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits to terminated participants are recorded when paid.

6. PARTY-IN-INTEREST TRANSACTIONS

At December 31, 2024 and 2023, the cash reserve account was managed by State Street Bank and Trust Company, who also is the recordkeeper and trustee of the Plan. Therefore, transactions amongst this account qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have notes receivable to the Plan qualify as party-in-interest transactions.

7. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended subsequent to receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through July 17, 2025, which is the date the financial statements were available to be issued.
