### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Highpoint Community Bank Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the participant-directed portion of the Highpoint Community Bank Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits of the participant-directed investments need not extend to any statements or information related to participant-directed assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications related to the participant-directed investments from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the participant-directed certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the financial statements referred to above related to the participant-directed assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Highpoint Community Bank Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit over the participant-directed investment assets does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Highpoint Community Bank Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **1. Description of the Plan and Significant Accounting Policies**

The following description of the Highpoint Community Bank Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Highpoint Community Bank (Bank). The Plan is comprised of three components: 401(k), profit sharing, and employee stock ownership plan (ESOP). Bank employees are eligible to make employee pay deferrals to the 401(k) and to begin receiving employer matching contributions to the 401(k) portion of the Plan on the first day of the pay period that begins subsequent to their date of hire and attainment of age 21. Employees become eligible to participate in the ESOP and profit sharing portions of the Plan on the first day of the calendar quarter after attainment of age 21 and completion of one year of employment with the Bank.

A Trust Fund has been established under the Plan to hold the Plan's assets. The Bank has been appointed as trustee.

Participants direct the investment of employee and employer contributions held in the 401(k) portion of the Plan. The trustee of the Plan directs the investment of employer contributions to the profit sharing and ESOP components of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participant Accounts**

Each participant's account is credited with the participant's voluntary 401(k) contribution and allocations of the Bank's ESOP, profit sharing, and 401(k) matching contributions; Plan earnings or losses; and administrative expenses. Allocations are based on the participant's earnings or account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All of the net assets available for benefits and changes in net assets available for benefits as of December 31, 2024 and 2023 are allocated to participants.

### **1. Description of the Plan and Significant Accounting Policies (continued)**

#### **Contributions**

Participant contributions to the Plan are elective and are in the form of pretax salary reductions subject to a minimum of 1% and maximum of 75% of compensation, as defined by the Plan, during any pay period. Total annual pay deferrals are not to exceed the maximum annual amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participant contributions are deposited into the 401(k) portion of the Plan. Participants direct the investment of their contributions into various investment options offered in the 401(k) portion of the Plan.

The Bank may make matching contributions to the 401(k) portion of the Plan. Such matching contributions are determined on an annual basis. The matching contribution is calculated as 25% of participants' contributions up to 10% of participants' compensation. The Bank may also make contributions to the profit sharing and/or ESOP portions of the Plan, both of which are allocated to participant accounts based on the ratio that the participant's compensation for the Plan year bears to total compensation of all eligible participants for the Plan year, subject to certain limitations noted in the Plan agreement. Employer contributions to the ESOP and profit sharing portions of the Plan are discretionary and are determined on an annual basis.

Participants who do not have at least 1,000 hours of credited service during the Plan year are generally not eligible to receive allocations of the Bank's discretionary profit sharing and/or ESOP contributions for that year.

During the year ended December 31, 2024, there were \$99,982 of employer matching contributions to the 401(k) portion of the Plan, \$198,757 of employer profit sharing contributions, and \$191,685 of employer ESOP contributions.

During the year ended December 31, 2023, there were \$94,623 of employer matching contributions to the 401(k) portion of the Plan, \$150,000 of employer profit sharing contributions, and \$150,000 of employer ESOP contributions.

#### **Payments of Benefits**

Participants are eligible to receive Plan distributions during employment upon reaching age 59½, if enduring a financial hardship, or if amounts were rolled into the Plan from a former employer's eligible retirement plan or the Bank's former pension plan. Upon termination of employment, including retirement, death, disability, or certain other reasons defined in the Plan agreement, a participant (or their designated beneficiary in the event of death) is eligible to receive a lump-sum payment equal to the participant's vested interest in their account. Distributions from a participant's balance held in the ESOP portion of the Plan must be made entirely in whole shares of employer stock and will be equal to the fair market value of the employer stock based upon the most recent appraised value before the distribution. Any partial share of employer stock will be distributed in cash. Benefits are recorded when paid.

#### **Administrative Expenses**

Certain administrative expenses are paid by the Plan. Expenses are paid to Transamerica Retirement Solutions, the third-party administrator related to investments held in the 401(k) portion of the Plan, from participant accounts related to asset management and certain participant-initiated transactions. Certain expenses related to the overall administration of the Plan are paid by the Bank and are therefore excluded from these financial statements.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer match portion of the 401(k), profit sharing contributions, and ESOP contributions of participants' accounts are based on years of vested service. A participant is 0% vested until three years of vested service and then 100% vested after three years of vested service, as defined by the Plan.

#### **Diversification**

Participants that have reached age 55 and have completed ten or more years of participation within the Plan have the right to make an election to diversify a portion of their employer stock account by liquidating shares and transferring the value of such shares to the participant's participant-directed accounts in the Plan, as defined in the Plan agreement.

#### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$562 as of December 31, 2024 and \$579 as of December 31, 2023. Forfeited balances of profit sharing and ESOP contributions are used to offset employer contributions. Forfeited balances of 401(k) matching contributions are used to offset administrative expenses of the Plan or employer matching contributions.

#### **Hardship Withdrawals**

The Plan agreement allows for participants to make hardship withdrawals of participant deferrals and earnings thereon held in the Plan, subject to certain requirements as defined in the Plan agreement. Hardship withdrawals of employer 401(k) matching, profit sharing, or ESOP contributions are not permitted by the Plan agreement. The Plan agreement does not allow for participants to obtain loans from the Plan.

#### **Voting Rights**

The trustee will generally vote all shares of Bank stock held in the Trust Fund in accordance with the Plan agreement. Participants may direct the trustee to vote their Bank stock regarding certain major corporate transactions as required by federal law.

#### **Termination of the Plan**

Although it has not expressed any intent to do so, the Bank has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the dissolution, merger, consolidation, or reorganization of the Bank, the Plan shall terminate, and the Trust Fund shall be liquidated unless the Plan is continued by a successor to the Bank. In the event of the termination or partial termination of the Plan, the accrued benefit of each affected participant shall become 100% vested in their account.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results could differ from those estimates.

#### **Basis of Accounting**

The financial statements have been presented on the accrual basis of accounting in accordance with U.S. GAAP.

#### **Valuation of Investments**

One of the investments held by the Plan is the Invesco Stable Value Trust Return Opportunities Fund, which is an insurance company product held in a pooled separate account. The fair value of the pooled separate account is based on the fair value of the underlying assets owned by the pooled separate account which are generally based on observable inputs. The net asset value (NAV) per share is used for determining the fair value of the pooled separate account. See Fair Value Measurements section for information regarding the valuation of other investments.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The change in the difference between fair value and the cost of investments held is combined with realized gains and losses on the sale of investments and reported in the statements of changes in net assets available for benefits as net realized and unrealized appreciation or depreciation in the fair value of investments on an annual basis. Realized gains and losses on the sale of investments represent the difference between the proceeds received and the original cost of investments sold.

#### **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

#### Fair Value Measurements (continued)

- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Money market and certificates of deposit: Valued at cost, which approximates fair value.
- Mutual funds, common stocks, corporate bonds, and U.S. Government agency bonds: Valued using quoted market prices.
- Employer common stock: Valued using a third-party appraisal.

#### Subsequent Events

Plan management has evaluated subsequent events for potential recognition and disclosure in the financial statements through June 3, 2025, which is the date the financial statements were available to be issued.

### 2. Federal Income Taxes

The Plan received an opinion letter from the Internal Revenue Service dated January 12, 2017 stating that the Plan is qualified under Section 401 of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust are tax-exempt. Therefore, there is no provision for income taxes in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. The plan administrator does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

Reliance Trust Company held the participant-directed investment assets and executed related transactions as of and for the years ended December 31, 2024 and 2023. This certified investment information has not been audited by independent accountants.

The employer common stock held by the Plan represents shares of Bank stock and is reported at fair value based upon an annual independent appraisal. This appraisal was based upon a weighted average of the earnings value method, equity base method, and actual market transactions in the stock. The appraisal took into account historical and current Bank performance, earnings per share data, cash flow and net income, return on assets, return on equity, fair value of the Bank assets and liabilities, as well as a discount for lack of marketability.

Plan management accumulates the data for the appraiser from the financial statements of the Plan and the Bank.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

### 5. Investment in Pooled Separate Account

The Plan holds an investment with Transamerica Life Insurance Company, an affiliate of the Plan's participant-directed investments third party administrator, with a NAV of \$149,688 as of December 31, 2024 and \$154,207 as of December 31, 2023. The Plan custodian maintains the contributions in a pooled separate account which is subsequently invested in one underlying mutual fund traded on an established market. The pooled separate account, an Invesco Stable Value Trust Return Opportunities Fund, is valued daily using publicly available quoted market prices, and participants bear the investment risks. There are no unfunded commitments related to the investment, and the redemption frequency and redemption notice period are both on a daily basis. Participants may generally transfer units out of the pooled separate account at any time. In the event of full or partial contract discontinuance, a hold period of 365 days or more may apply.

As described in Note 1, the NAV is the relevant measurement attribute for this investment. NAV, as reported to the Plan by Reliance Trust Company, represents the principal invested plus investment gain or loss.

### **6. Transactions with Parties-in-Interest**

Administrative expenses paid by the Bank include payments to the Plan's third-party administrators, including Transamerica Retirement Solutions and Watkins Ross, legal counsel, and auditor for services to the Plan. These administrative expenses are considered party-in-interest transactions.

The custodians of the nonparticipant-directed investments of the Plan, Northern Trust Co. and Continental Stock Transfer and Trust, are considered parties-in-interest to the Plan. Mesirow Financial Inc. provides investment monitoring services to the Plan and is also a party-in-interest to the Plan.

Purchases and sales of Bank common stock constitute transactions with a party-in-interest to the Plan. During the year ended December 31, 2024, the Plan purchased 794 shares of Bank common stock (4,509 shares during the year ended December 31, 2023). There were no shares of common stock sold during the year ended December 31, 2024 (465 shares sold during 2023). During the year ended December 31, 2024, there were 11,936 shares distributed to a participant through a rollover to an external account (3,547 shares during the year ended December 31, 2023).

The Plan holds investments in certain managed funds of the custodian related to investments held in the participant-directed portion of the Plan. These funds totaled \$149,688 as of December 31, 2024 and \$154,207 as of December 31, 2023.

### **7. Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.


