INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

Opinion

We have audited the accompanying financial statements of Mutual Benefit Association Insurance Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 (in liquidation), and the statement of net assets available for benefits (modified cash basis) as of December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 (in liquidation), and the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Mutual Benefit Association Insurance Fund (modified cash basis) as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024 (in liquidation) and December 31, 2023 (ongoing), in accordance with the modified cash basis of accounting described in Note B.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mutual Benefit Association Insurance Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note G to the financial statements, the Board of Trustees of Mutual Benefit Association Insurance Fund approved a plan of liquidation on January 25, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mutual Benefit Association Insurance Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. NOTE A - DESCRIPTION OF PLAN -

General

The Mutual Benefit Association Insurance Fund (the "Plan") was established to provide income protection, through establishment of a benefit fund, by payment of definite amounts to members of the association when entitled by reason of disability from sickness, accident, or other causes. Disability shall mean inability to work by reason of illness or accidental injury. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Members participate in the Plan by voluntarily contributing 25 cents (\$0.25) per month to the Plan. The Plan is no longer receiving member contributions after December 31, 2021.

Benefits

Benefit payments begin on the first day that a member becomes disabled, provided the disability lasts at least seven days and shall be paid at a rate of six dollars (\$6.00) per day for the duration of disability period. However, no more than a maximum benefit of \$720.00 shall be paid for any single disability claim. Effective January 1, 2022, no benefits will be paid for new disability claims originating after December 31, 2021, and all claims must have been received before June 30, 2022 to qualify for payment. On April 1, 2024, the Plan issued liquidating distribution checks to its remaining 598 members in the amount of \$200.00 per individual.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES -

Basis of Accounting

The Plan's financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. This basis of accounting differs from accounting principles generally accepted in the United States of America (GAAP) in that certain revenues are recognized when received rather than earned and certain expenses are recognized when paid rather than when the obligation is incurred. However, similar to financial statements prepared in accordance with GAAP, these financial statements reflect investments reported at fair market value. The accompanying financial statements are not intended to present the Plan's financial position and results of operations in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform to the presentation of the 2024 financial statements. These reclassifications had no effect on the previously reported net assets available for benefits for the year ended December 31, 2023.

Subsequent Events

The Plan has evaluated all subsequent events through July 16, 2025, which is the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS -

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Interest-bearing cash is valued at the daily closing unit/share price of one dollar (\$1.00).

There were no significant transfers into or out of level 1 investments during the year ended December 31, 2023. All remaining investments were liquidated during the year ended December 31, 2024 to facilitate termination of the Plan.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

NOTE D - CONCENTRATION OF CREDIT RISK -

The Plan maintains its cash accounts in various financial institutions located in Cincinnati, Ohio. Cash balances on deposit are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000.00. Management believes that its cash accounts are fully insured as of December 31, 2024 and 2023.

The Plan covers participants in the greater Cincinnati, Ohio geographical area and previously received voluntary contributions from employees of the Cincinnati Gas and Electric Company, Cinergy, its Successors and Subsidiaries primarily located in this area.

NOTE E - TAX STATUS -

The Plan and Trust together obtained its latest determination letter on March 24, 1941, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code, Section 501(c)(9). Although the Plan has been amended since receiving the determination letter, the Board of Trustees and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe that the Plan and the related Trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS -

The Plan pays administrative expenses consisting primarily of reimbursement for meeting expenses to the Mutual Benefit Association Activity Fund (the "Activity Fund"), which is considered a related party. These expenses are reported as administrative expenses on the statements of changes in net assets available for benefits (modified cash basis). During the years ended December 31, 2024 and 2023, the Plan paid \$142.82 and \$624.13, respectively, to the Activity Fund. The Plan also received reimbursements from the Activity Fund related to joint meeting expenses, shared office expenses, and professional fees in the amount of \$1,648.87 in 2024 and \$150.28 in 2023.

The Plan also pays administrative expenses related to plan operations to various service providers and individuals, including the Administrative Managers of Compliance, Administration, and Storage. These transactions are considered party-in-interest transactions under ERISA.

NOTE G - PLAN TERMINATION -

The Board of Trustees adopted a formal resolution to terminate the Plan on January 25, 2024. Therefore, the Plan is no longer operating as a going concern. All members who have made contributions to the Plan as of December 31, 2021, will remain a member of the Plan as long as they continue to satisfy the general eligibility requirements. Termination of the Plan shall not permit any part of Plan assets to be used for or diverted to purposes other than the exclusive benefit of the members.

In accordance with terms of the By-Laws of the Mutual Benefit Association and the Plan Agreement and Declaration of Trust of the Mutual Benefit Association Insurance Fund, in the event that termination of the Trust Fund is approved, the Trustees shall 1) make provisions out of the Trust Fund for the payment of expenses incurred up to the date of termination and the expenses incident to such termination; 2) arrange for a final audit and report of their transactions and accounts, for the purpose of termination of their Directorship/Trusteeship; and 3) continue to apply the Trust Fund to the obligations and purposes of the Plan and distribute and apply any remaining surplus in accordance with terms of the Plan.

On April 1, 2024, the Plan issued liquidating distributions totaling \$119,600.00 to its remaining 598 members. In the opinion of the Board of Trustees, these distributions were calculated on an equitable basis in accordance with terms of the Resolution to Dissolve the Mutual Benefit Association Insurance Fund. All remaining Plan assets were disbursed prior to December 31, 2024, and the Plan has permanently ceased operations.
