No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility future events affecting them may differ significantly from those expected.

The most sensitive accounting estimates affecting the financial statements are the valuation of investments and investment transactions. These values are certified by Ascensus, LLC the trustee and custodian of the Plan, as complete and accurate.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. We identified no particularly sensitive financial statement disclosures.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Other Audit Findings or Issue

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

Note 1 – Description of the Plan

The following brief description of Meaningful Day Services, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan instrument for complete information.

General

The Plan is a defined contribution plan established on January 1, 2006 covering substantially all eligible employees of Meaningful Day Services, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Full-time employees who are at least 21 years of age are eligible to participate in the Plan once they complete one year of service with 1,000 hours. Part-time employees are eligible to enroll in the Plan once they reach three consecutive years of service with at least 500 hours in each year. All eligible participants enter the Plan on the first day of the month after becoming eligible. Once employees meet the eligibility requirements they are auto-enrolled at a 6% pretax deferral rate unless they opt out of participation. The Plan also has an auto escalation provision to increase the deferral percentage by 1% each year up to a maximum of 10%. Participants may also elect to make Roth contributions.

Contributions

Each year, participants may contribute up to a maximum amount of their pretax or after-tax annual compensation, as defined by the Internal Revenue Service (IRS) and recorded in the plan document. Participants who have attained age 50 before the end of the plan year may make additional catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified plans. For the years ended December 31, 2024 and 2023, the Plan had an auto-enroll pretax deferral percentage of 6%. Each year the Company may make discretionary matching contributions of each employee's elective salary deferrals up to a percentage of eligible compensation as determined by management. The Company made matching contributions of 20% of employee deferrals up to 5% of eligible compensation for the years ended December 31, 2024 and 2023. The Company may also make discretionary profit sharing contributions as determined by management. Employees must be employed on the last day of the plan year and have a minimum of 1,000 hours of service during the year in order to receive an allocation of any discretionary profit sharing contributions. The Company did not make any discretionary employer contributions in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, if any, allocations of plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant account balances or earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 – Description of the Plan (Continued)

Vesting

Participants are immediately vested in all pretax and after tax deferral contributions and rollover contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings (losses) thereon is based on years of continuous service. Participants become fully vested in the event of death, disability, retirement, or plan termination. Otherwise a participant will become vested in the Company's contribution according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 year	0%
Greater than 1 year, but less than 2 years	20%
Greater than 2 years, but less than 3 years	40%
Greater than 3 years, but less than 4 years	60%
Greater than 4 years, but less than 5 years	80%

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts may be used to pay administrative expenses, reduce future discretionary matching and profit sharing contributions, or are reallocated as an additional employer contribution. Forfeited vested accounts totaled \$1,524 and \$932 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$12,349 of forfeitures were used to pay administrative expenses.

Investment Options

Upon enrollment in the Plan, participants are able to invest in a variety of investment choices as more fully described in the plan document. Participants may change their investment options at any time during the year.

Notes Receivable from Participants

Through December 31, 2024, participant loans were not allowed under the Plan. See Note 9.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may receive benefits based on the participant's vested account balance. Benefits may only be paid in a lump sum. The Plan allows in-service distributions once a participant reaches age 59-1/2, and also allows hardship distributions from fully vested account balances as outlined in the plan document. Involuntary cash force-outs are allowed for account balances under \$5,000 excluding rollover balances.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), which requires management to make estimates and assumptions affecting certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated by management through July 21, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

Note 3 – Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Note 4 – Tax Status

The IRS determined the prototype plan used by the Plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code, as indicated in a letter dated June 30, 2020. The Plan was most recently restated on January 1, 2022. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position which more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by jurisdictions; however, there are currently no audits in progress for any tax periods in progress.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Note 6 – Certified Information

At December 31, 2024 and 2023, the Plan's investments were maintained by Ascensus, LLC (the trustee and custodian). Vanguard is the Plan's recordkeeper. The custodian supplied the plan administrator with a certification as to the completeness and accuracy of all information relating to investments as of December 31, 2024 and 2023, and income and expenses on such investments for the year ended December 31, 2024. The certified information includes total investments of \$2,476,111 and \$2,212,572 at December 31, 2024 and 2023, respectively, which diverges from the statements of net assets available for benefits by the values of the employer and employee receivables. The certified information also includes the activity reported on the statement of changes in net assets available for benefits for the year ended December 31, 2024 except for the impact of the employee and employer receivables on contribution income.

Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds certain investment funds managed by the plan trustee. Such investments and the Plan's payment of fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some professional fees for the administration and audit of the Plan are paid directly by the Company.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to numerous risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Subsequent Event

Effective January 31, 2025, the Plan allows for participants loans from the Plan.
