Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lifetime Products, Inc. 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) DESCRIPTION OF THE PLAN

The following description of the Lifetime Products, Inc. (Lifetime or the Company) 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all full-time employees of Lifetime who have completed sixty days of entry service and who are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent enactments. From time to time the Plan has been restated and amended. Principal Life Insurance Company (Principal) is the custodian of the Plan's assets. Lifetime is the Plan sponsor and oversees administration of the Plan.

(b) Contributions

Employees may elect under a salary reduction agreement to contribute to the Plan up to 100 percent of before-tax, gross compensation. Contributions are limited by the Internal Revenue Code, which establishes a maximum contribution amount of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants age 50 and over may contribute an additional \$7,500 for the years ended December 31, 2024 and 2023.

The employer contributes 50 percent of the first 6 percent of before-tax, gross compensation that a participant contributes to the Plan.

(c) Participants' Accounts

Each participant's account is credited with (a) the employee's contribution, (b) the employer's contribution, and (c) an allocation of the Plan's earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Allocation of Earnings

The net increase or decrease in the value of each investment fund attributed to interest, changes in market value, expenses, and gains and losses realized from the sale of assets is allocated to employees' accounts based upon relative fund account balances.

(e) Investment of Contributions

For both employer and employee contributions, participants may designate how his or her account balance is allocated into one or more registered investment companies, various pooled separate investment accounts, or a collective investment trust.

(1) DESCRIPTION OF THE PLAN (CONTINUED)

(f) Vesting and Benefits

Employee contributions and earnings thereon are 100 percent vested. Employer matching contributions for participants vest at a rate of 20 percent after two years and an additional 20 percent for each year of service thereafter from the date of hire. A participant is, therefore, 100 percent vested after six years of such service. Employees also become fully vested upon attaining normal retirement age or upon death or disability.

(g) Distribution of Benefits

Benefits are distributed upon retirement, disability, death, or termination of employment. Under certain circumstances, such as in the event of undue hardship, an employee may withdraw his or her contributions prior to the occurrence of these events.

(h) Forfeitures

The Plan provides for the nonvested portion of employer contributions and earnings forfeited by employees to be accumulated by the Plan to either offset the cost of the employer contribution or offset the cost associated with administering the Plan. Plan forfeitures were used to offset the cost associated with the employer matching contributions to the Plan in the amounts of \$169,201 and \$189,260 during 2024 and 2023, respectively. The forfeiture balance totaled \$401 and \$0 for the years ended December 31, 2024 and 2023, respectively.

(i) Plan Termination

Although it has not expressed any intent to do so, Lifetime has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

(a) Basis of Presentation

The Plan's financial statements are presented on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value or net asset value where permitted. See Notes 3, 4 and 5 for more information regarding investment valuation.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

(c) *Risks and Uncertainties*

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(d) *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

(e) *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) *Subsequent Events*

Subsequent events have been evaluated through June 18, 2025, the date the financial statements were available to be issued, and there were no matters that materially affect the carrying amounts of the net assets available for benefits as of December 31, 2024.

(3) FAIR VALUE OF INVESTMENTS

ASC 820, *Fair Value Measurements and Disclosures (ASC 820)*, defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities

Level 2 - Quoted prices for identical or similar assets or liabilities in markets that are not considered to be active or identical or similar financial instruments for which all significant inputs are observable, either directly or indirectly

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. In periods of market inactivity, the observability of prices and inputs may be reduced for certain instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2, or from Level 2 to Level 3.

(4) POOLED SEPARATE ACCOUNTS

The Plan's interest in Pooled Separate Accounts (PSA) invests in a single mutual fund. The fair value of the mutual fund is a publicly quoted pricing input used in determining the net asset value of the pooled separate account, which is not publicly quoted. ASC 820 allows net asset value (NAV) per share to serve as a practical expedient to estimate the fair value of a PSA as long as certain requirements are met. The Plan's PSA's meet those requirements. The PSA's can be redeemed at NAV on a daily basis.

(5) COLLECTIVE INVESTMENT TRUST

Principal Stable Value Fund

This is a stable value collective investment trust (CIT) for which the NAV is based on the contract value. Investments held by a CIT are required to be reported at fair value, however, contract value is the relevant measurement characteristic for that portion of the net assets of a CIT attributable to fully benefit-responsive investment contracts. This is because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined-contribution plans. The fair value of conventional contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contract are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the Trustee, which determines valuations using methodology generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes. ASC 820 allows NAV per share to serve as a practical expedient to estimate the fair value of a CIT as long as certain requirements are met. The Principal Stable Value Fund meets the requirements for the NAV practical expedient. Unfunded commitments typically are found in private equity funds and therefore are not applicable to CITs.

(6) TAX STATUS

The Plan uses a prototype plan document, which received an opinion letter from the IRS, dated March 31, 2014, stating that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS and the prototype has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

(8) RELATED PARTY TRANSACTIONS

As of December 31, 2024 and 2023, the Plan invested in a collective investment trust and pooled separate accounts managed by the Plan's custodian. These party-in-interest transactions are not considered prohibited transactions by statutory exemptions under ERISA regulations.
