### 1. Description of Plan

The following description of the Weiler Corporation Profit Sharing & 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Weiler Corporation (Company) who have attained age eighteen. Employees are immediately eligible to participate in the Plan on the entry date coinciding with or next following their date of hire. Eligibility for the purposes of Company discretionary nonelective contributions requires the completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Profit Sharing & 401(k) Plan Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Advisory Board of Directors.

#### Contributions

Each year, participants may contribute up to 60% of eligible compensation, as defined in the Plan. Effective November 3, 2023, participants are able to make Roth 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another eligible retirement plan. The Plan also provides for additional deferral contributions for payroll periods designated by the Company. In addition, the Plan has an automatic enrollment feature with an initial pre-tax deferral rate of 6%; these contributions are invested in the applicable Fidelity Lifecycle Fund based on the participant's date of birth until changed by the participant. Participants who are automatically enrolled may have their contributions increased by 1% each year on March 1 until a deferral rate of 15% is reached.

The Company's discretionary matching contribution for 2024 was 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The Plan also provides for a Company discretionary nonelective contribution for eligible participants, there was no contribution for 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust as investment options for participants. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of the Company's discretionary nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in the Company's contribution portion of their account, including earnings thereon, with the exception of participants who terminated employment prior to September 20, 2017 whose vesting was based on years of credited service and a graduated vesting schedule, with 100% vesting after completion of six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest based on prevailing interest rates at the time the loan was established. Principal and interest is paid ratably through payroll deductions. If a participant with an outstanding loan balance terminates employment, such loan can continue to be payable in accordance with the provisions of the loan note and plan document.

**Payment of Benefits**

A participant may receive a lump-sum distribution of the vested portion of their account on separation from service with the Company. A participant whose vested balance is \$7,000 or less cannot defer receipt of their distribution. The Plan also provides for the following in-service withdrawals, subject to the Plan's provisions:

- Hardship withdrawals
- Withdrawals after age 59½
- Withdrawals after age 70½
- Withdrawals after normal retirement age
- Withdrawals of vested employer contributions
- Withdrawals of after-tax contributions
- Withdrawals of rollover contributions
- Active Military Distributions

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$187 and \$152, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$1,033 from forfeited nonvested accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-response investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisers and Fidelity Management Trust Company (Trustee). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are included in net appreciation of fair values of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued. Based on that evaluation, no events occurred that required disclosure.

### **3. Information Certified by Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying Schedule H, Line 4i, schedule of assets (held at end of year) as of December 31, 2024

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund and Mutual Funds:* Valued at the daily closing prices as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust:* Valued based on its contract value, which represents deposits, plus credited interest, less withdrawals, charges or expenses (Note 5).

**5. Investment Contract with the Trustee**

The Plan has a fully benefit-responsive investment contract with the Trustee. This contract is a participation agreement for the Fidelity Group Trust for Employee Benefit Plans (Group Trust). Under the terms of this contract, the Trustee is the investment manager and the investment option for the Plan is the Fidelity Advisor Stable Value Portfolio Class III (Stable Value Fund). The Stable Value Fund is a commingled pool of the Group Trust. The beneficial interest of each participating plan is represented by units. The Stable Value Fund's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The Stable Value Fund typically invests in fixed income securities or bond funds, may include derivative instruments such as futures contracts and swap agreements, enters into wrap contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds.

The Trustee maintains an accounting record for the Plan of the amounts allocated to the Stable Value Fund on the Plan's behalf. The amounts allocated include contributions and interest received, withdrawals made, and fees charged. The Trustee is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and can be adjusted periodically, and is usually adjusted monthly or quarterly, but may not be less than 0%. The contract value spot yield credited to participants was 2.15% at December 31, 2024 and 1.83% at December 31, 2023.

The Stable Value Fund meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Trustee, represents contributions made to the Stable Value Fund, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract value of the Stable Value Fund was \$1,648,184 at December 31, 2024 and \$1,877,682 at December 31, 2023. Participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. There are no unfunded commitments at December 31, 2024 and 2023. Generally, there are not any events that could limit the ability of the Plan to transact at contract value. However, withdrawals or investment exchanges prompted by an employer initiated event such as withdrawals resulting from the sale of a division, corporate layoff, early retirement windows, plan termination or partial termination, or change in investment options may be paid at the contract's market value, which may be less than the contract value, or may be subject to a contract charge or penalty. These events are not probable of occurring.

## **6. Administration of Plan Assets**

The Plan's assets are administered under a service agreement with the Trustee. Contributions are held and managed by the Trustee, who invests cash received, interest and dividend income as directed by participant investment elections. The Trustee also makes distributions. Investment related fees paid on a basis point are deducted from the returns on the mutual funds and the collective trust. Fees paid to the Trustee qualify as party-in-interest transactions. The fees paid to the Trustee were \$72,076.

The Service Agreement with the Trustee includes participant revenue credits and revenue credit programs (Revenue Credits). In situations where the recordkeeping revenue received in connection with services exceeds agreed upon compensation, the Trustee can allocate amounts equal to such excess revenue to accounts of eligible participants as negative expenses, participant revenue credit, or deposit amounts equal to such excess revenue in a suspense account, revenue credit program. The total Revenue Credits for 2024 that reduced administrative expenses in the accompanying statement of changes in net assets available for benefits was \$9,539. The balance in the revenue credit program suspense account was \$599 at December 31, 2024 and \$19 at December 31, 2023. The revenue credit program is used for the payment of administrative expenses.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

## **8. Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020 indicating that Plan was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees (Opinion Letter). Although the Plan has been amended since receiving the Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the related trust is tax exempt.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had investments of \$14,401,769 at December 31, 2024 and \$11,807,969 at December 31, 2023, concentrated in two investments.

**10. Reconciliation of Financial Statements to Form 5500**

The Stable Value Fund is required to be reported at fair value in Schedule H of the Form 5500 and is reported at contract value (Note 5) in the financial statements.
