NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

## NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Ascella Technologies Inc. 401K Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan effective February 10, 2003, and restated June 1, 2022, covering eligible employees. The Plan is subject to the provisions of ERISA. All employees of Ascella Technologies Inc. (the "Company") or (the "Plan Sponsor") are immediately eligible to participate in the plan except union employees, nonresident aliens, interns and certain employees covered under 410(b)(6)(c).

### *Contributions*

Each year participants may contribute 100% of their compensation to the Plan not to exceed the maximum allowable IRC 402(g) limit of \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified plans. Roth elective deferrals are permitted under the Plan.

The Company has a safe harbor contribution of 4% of each participant's compensation. Additional discretionary matching contributions and nonelective contribution can be made at the discretion of the Company. The maximum IRC 415 limit for total contributions made on behalf of a participant (deferrals and employer contributions) is \$69,000 for 2024. Catch-up contributions can be made in excess of this limit.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various pooled separate accounts and a stable value fund for participants.

### *Participant Accounts*

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

### *Vesting*

Participants are vested immediately in their contributions, safe harbor contributions and earnings thereon. Vesting in company matching contributions are based is 50% in year one and 100% in year two.

## NOTE 1. DESCRIPTION OF THE PLAN (continued)

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan must bear a reasonable amount of interest. The interest rate for 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions.

### *Payment of Benefits*

On termination of service due to death, disability, retirement or other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, partial withdrawal or installments. In-service withdrawals allowed for hardships and at age 59 ½.

The distributable amount is equal to the value of the participant's vested interest in his or her account. Employees who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of discretionary contributions.

### *Forfeitures*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0 respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2024, employer contributions and administrative expenses were reduced by \$7,878 from forfeited non-vested accounts.

## NOTE 2. SUMMARY OF ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## NOTE 2. SUMMARY OF ACCOUNTING POLICIES (Continued)

### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions*

Contributions from Plan Participants and matching contributions from the Employer are recorded in the year in which employee contributions are withheld from compensation.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

### *Payments of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation (depreciation) of the fair value of investments.

### *Subsequent Events*

The plan has evaluated subsequent events through June 26, 2025 the date of the financial statements were available to be issued.

The following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts (“PSAs”) Invests mainly in stocks, mutual funds, bonds, etc. They are represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles valued using NAV per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAVs of the underlying investments are quoted prices in active markets.

### NOTE 5. NONPARTICIPANTS-DIRECTED INVESTMENTS

The Plan's participants direct all investments. There are no non-participant directed investments as of December 31, 2024 and 2023.

### NOTE 6. AUL STABLE VALUE ACCOUNT

The Plan invests in the AUL Stable Value Account (the “Contract”), a benefit - responsive group annuity contract issued by American United Life Insurance Company. totaling \$1,619,152 December 31, 2024 and \$1,851,462 at December 31, 2023. The Contract is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets but is rather a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned, or the interest credited, on the group annuity contract. The underlying assets consist primarily of corporate bonds, commercial real estate mortgages, mortgage - backed securities and short - term cash equivalents.

The interest crediting rate is determined on an annual basis and is calculated based upon many factors, including current economic and market conditions, the general interest rate environment, and purchases and redemptions by unit holders.

The average market yield earned by the Contract, which is also the actual interest credited to participants in the Contract, for the years ending on December 31, 2024 and 2023 was 1.75% and 1.00% respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with . American United Life Insurance Company. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **NOTE 7. RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by American United Life Insurance Company. American United Life Insurance Company is the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also made direct payments to third party administrators of 20,161. The Plan Sponsor pays directly any other fees related to the plan's operations. The Plan Custodian receives fees from administration and investment management.

### **NOTE 8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the rights under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100 percent vested in their employer contributions.

### **NOTE 9. TAX STATUS**

The IRS has determined and informed the Company by letter November 30, 2020 in which the Internal Service stated that the Plan, is designed, in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 10. RISK AND UNCERTAINTIES**

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
