NOTES TO FINANCIAL STATEMENTS**

Note 1 - Description of Plan

The following description of Electric Services, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement and the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Electric Services, Inc. (the Company or Employer), subject to the eligibility criteria discussed below. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally effective January 1, 1995, and was restated in its entirety as of January 1, 2021.

Eligibility

Employees are eligible to participate in the Plan after completion of one year of service during which the employee is credited with at least 1,000 hours of service and upon attaining the age of 21. Eligible employees may commence participation in the Plan beginning either January 1 or July 1 following the date on which eligibility requirements are met.

Contributions

Participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, up to the limit established by law. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Eligible participants under the Plan who have attained the age of 50 before the close of the Plan year are permitted to make catch-up contributions subject to certain limitations. Each year the Company may make discretionary matching contributions to the Plan. For 2024, the Company's Board of Directors elected to contribute 50% of the first \$10,000 contributed by participants, for a maximum Employer match of \$5,000 per participant, to the Plan. Additionally, the Company may make a discretionary profit-sharing or non-elective contribution to the Plan, allocated to the participants based on a ratio of participant compensation to total compensation of all participants during the year. Except in the event of death, total or permanent disability, or early retirement, participants not employed on the last day of the Plan year are required to complete a minimum of 500 hours of service in order to share in the allocation of the discretionary profit-sharing or non-elective contribution. The Company did not make any profit-sharing or non-elective contributions to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of the Company's other discretionary contributions and Plan earnings and charged with benefit payments and an allocation of the Plan's losses and administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the discretionary Employer matching, profit-sharing, and non-elective contribution allocations is based on

years of service, and is 20% vested after 1 year, 40% vested after 2 years, 60% vested after 3 years, 80% vested after 4 years, and 100% vested after five years. The Plan also provides for the full vesting of all portions of a participant's account upon attaining early retirement age, total and permanent disability, or death.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, and if a participant's account balance is greater than \$5,000, a participant may elect to receive either a lump sum distribution equal to the value of the participant's vested interest in his or her account, or in the form permitted by the investment option contract, if offered by the Plan. If a participant's vested account balance is less than \$5,000, and the participant does not make an election, the Plan will automatically disburse the account balance in cash as soon as feasible after termination. The Plan allows for in-service withdrawals provided the participant is at least 59½ years old and the respective account is fully vested. Hardship withdrawals are allowed from the employee contributions portion of a participant's account up to the lesser of 100% of total employee contributions or the amount of the "immediate and heavy" financial need.

Investment Options

Participants may direct their contributions and their allocation of Employer contributions into various investment options. These options may be changed at any time by participants via telephone or internet.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 2% above the prime rate at the time the loan was granted. Principal and interest are paid ratably through payroll deductions. The period of loan repayment cannot exceed five years from the date of the loan unless it was used to purchase a primary residence, in which case the term may be longer, as determined by the Plan administrator. Participants are allowed to have no more than two loans outstanding at a time.

Forfeitures

Any non-vested amounts remaining after the distribution of a terminated participant's vested account balance are forfeited. Forfeitures may be applied to pay Plan expenses or used to reduce Employer matching contributions or Employer profit-sharing contributions. At December 31, 2024 and 2023, there were \$2,474 and \$10,691 in forfeited amounts available to be applied according to these provisions, respectively. Forfeitures of \$8,235 were used to reduce Plan expenses during the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest, with no allowance for credit losses, as repayment of principal and interest are received primarily through payroll deductions and notes are collateralized by the participant's account balances. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses represent fees paid to the third-party administrator for services rendered in managing the Plan, including contract administration fees and investment advisory fees. Certain transaction fees for disbursements are charged directly to the accounts of the participants who incur those fees. Certain administrative fees are allocated to participants proportionally based on the value of their account balance. Any costs associated with the investment of a participant's account are charged to the participant.

Payment of Benefits

Benefits are recorded when paid.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The guidance establishes three levels of the fair value hierarchy as follows:

Level 1—Inputs to the valuation methodology are quoted prices for identical securities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology are other observable inputs, including quoted prices for similar securities, interest rates, credit risk, etc., that are determined for an asset, either directly or indirectly, based on independent market data.

Level 3—Inputs to the valuation methodology are significant unobservable inputs.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts: The Plan holds units of participation in separate accounts, which are valued daily at their net asset values (NAV). NAV is computed by dividing the proportion of the market value, after deduction of any applicable charges, by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments on these investments. Redemption restrictions include a maximum of two exchange days per calendar month. The underlying investments include the following:

- (a) Target Risk - Seeks to achieve growth of capital and income by providing an optimal mix of a broadly diversified portfolio.
- (b) Fixed Income - Seeks to maximize total return consistent with reasonable risk, investing primarily in net assets in a diversified portfolio of bonds or fixed income instruments of varying maturities.
- (c) Large Cap - Seeks long-term growth of capital, or a combination of growth and income, by investing primarily in stocks of larger, mature companies.
- (d) International - Seeks international diversification by investing in stocks of companies outside of the United States of America.
- (e) Small/Mid Cap - Seeks capital appreciation by investing primarily in stocks of small and medium sized companies.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with the fair value accounting standard, as the Plan's pooled separate accounts are measured at fair value using the unadjusted NAV practical expedient, they are not categorized within the fair value hierarchy. The Plan does not have any Level 1, 2, or 3 financial instruments.

Note 4 - Related-Party and Party-in-Interest Transactions

The Plan’s investments and non-interest-bearing cash are managed by John Hancock. The Plan also pays fees to John Hancock and the Plan’s investment advisor and third-party administrator. These transactions qualify as party-in-interest transactions. Fees paid to these parties-in-interest totaled \$70,033 for the year ended December 31, 2024. Notes receivable from participants also qualify as exempt party-in-interest transactions.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 - Income Tax Status

The Plan utilizes a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Information Certified by John Hancock Life Insurance Company (U.S.A.) (John Hancock)

The following is a summary of the unaudited information regarding the Plan used in the preparation of the Plan’s financial statements and supplemental schedule that was prepared by John Hancock and furnished to the Plan administrator. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024, as of July 11, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.
