**Note 1 - Plan Description**

The following description of the Powell Industries, Inc. Employees Incentive Savings Plan (the Plan) is provided for general information only. Participants should refer to the plan document for more complete information.

**General**

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established December 12, 1960, and has since been amended and restated.

**Plan Administration**

The Plan is administered by a committee (the Fiduciary Committee) which consists of one or more employees appointed by the board of directors of Powell Industries, Inc. (the Company). An employee of the Company is appointed to serve as the plan administrator.

Fidelity Management Trust Company (Fidelity) is the Plan's trustee.

**Eligibility and Contributions**

Eligible employees are immediately eligible to participate in the Plan and may elect to contribute, by payroll deduction, between 1% and 75% of their compensation, as defined in the plan document. In addition, eligible employees who have attained age 50 before the close of the plan year are eligible to make catch-up contributions subject to limitations of the Internal Revenue Code (IRC).

Eligible employees automatically begin deferring 2% of compensation, as defined, unless otherwise instructed by the employee. Eligible employees will have their deferral percentage increased by 1% each year up to a maximum of 15%, unless otherwise instructed by the employee. Participants automatically enrolled in the last six months of the plan year will not have their deferral increased until the second January following the date of their auto enrollment.

The Company contributes an amount equal to 50% of the participant's contribution, including catch-up contributions, not to exceed 7% of the participant's compensation, as defined.

The Company may also contribute additional amounts as determined by the board of directors. These discretionary contributions may be in the form of a profit-sharing contribution or matching contribution. There were no discretionary contributions for the year ended December 31, 2024.

**Participant Accounts**

Participants designate how employee contributions and Company matching contributions are invested among available investment options. Contributions are not permitted to be invested in the Powell Industries, Inc. common stock fund; however, participants may elect at any time to transfer all or a portion of their Powell Industries, Inc. common stock to any of the other investment options offered by the Plan. Separate accounts are maintained for each participant. Investment income or loss is allocated daily to participants based on their respective balances in the funds.

**Voting Rights Attributable to Powell Industries, Inc. Common Stock**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The Fiduciary Committee directs the trustee to vote allocated shares for which no voting instructions are received from participants.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts to the extent that loans issued are no less than \$1,000, with a maximum loan limited to the lesser of \$50,000 or one-half of the participant's vested balance. Loans made pursuant to the plan document bear a reasonable rate of interest which is commensurate with prevailing rates offered by commercial lending institutions at the date of issuance. The loans are generally repaid through payroll deductions. A participant may have a maximum of two loans outstanding at any time, or three loans outstanding provided that one is for the purchase of a principal residence. Loan terms are limited to five years unless for the purchase of a principal residence, which can extend the loan period to ten years.

**Vesting**

Participants are always 100% vested in their contributions, contributions made by the Company, and accumulated earnings thereon.

**Benefit Payments**

Upon termination of service, death or disability, a participant's vested balance may be received by the participant or their beneficiaries, as applicable, as a fixed period installment option, a fixed payment installment option, or a lump-sum payment. If a participant's vested account balance was greater than \$7,000, the participant could choose to leave their vested balance in the Plan and defer distribution until a future date. Upon termination, participants with a vested account balance of \$1,000 or less shall receive an automatic lump-sum distribution from the Plan. For participants who terminate with a vested account balance of more than \$1,000 but less than \$7,000, Fidelity will make a direct rollover into an individual retirement account. As a general rule, distributions are made in cash; however, payment of accounts invested in the Company common stock fund may be made in the form of Company common stock at the participant's election.

Under certain circumstances, participants may withdraw the value of their account while still employed for reasons of financial hardship, upon the attainment of age 59½ and for other such reasons. Upon withdrawal from the Plan or termination of employment, participants may be subject to income taxes on contributions and income earned.

**Note 2 - Summary of Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as the unrealized gains or losses on the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest, with no allowance for credit losses as the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis. In general, notes receivable from participants are considered in default in the calendar quarter following the quarter in which no payment is made, and such defaults are accounted for as distributions based upon the terms of the plan document.

**Benefit Payments**

Benefits paid to participants or beneficiaries are recorded when paid.

**Administrative Expenses**

At the option of the plan administrator, expenses related to the administration of the Plan may be paid by the Company or by the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Fiduciary Committee to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to certain risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the financial statements.

**Subsequent Events**

The Fiduciary Committee evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 14, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by Plan's Trustee**

The Fiduciary Committee has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Fiduciary Committee has obtained certifications from Fidelity that all of the information provided is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. Information included in the financial statements and the related notes to the financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all of the related information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes, and the supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds and Powell Industries, Inc. Common Stock:* These investments are valued daily based upon quoted market prices.

*Common/Collective Trust Fund:* This fund is valued at its net asset value (NAV) as reported by the issuer based on quoted market prices of the underlying investments, when available. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The following information is provided for the investment that uses NAV as a practical expedient as of December 31, 2024 and 2023:

The estimated fair value of the Morley Stable Value Fund as of December 31, 2024 and 2023 was \$19,936,561 and \$23,146,887, respectively. Individual participant redemptions for benefit payments or transfers to another non-competing fund are generally permitted without restriction but may take up to 30 days. Participant-directed transfers to competing investment options, if any, must be held for 90 days before transfer to a competing fund. A twelve-month advance written notice is required for any plan-sponsor directed withdrawals, such as partial or complete plan terminations, terminating the fund as an investment option, etc. The issuer of the fund, at its sole discretion, may choose to disburse the funds in less than twelve months if it determines that such a disbursement is in the best interest of the investment as a whole.

As of December 31, 2024 and 2023, there were no unfunded commitments.

**Note 5 - Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are shares of the Company's common stock. Additionally, the Plan offers mutual funds issued by an affiliate of Fidelity. These transactions qualify as party-in-interest transactions and are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

Fidelity provides certain administrative services to the Plan pursuant to a service agreement between the Company and Fidelity. Fidelity receives revenue from certain Fidelity and non-Fidelity investment products held by the Plan as prescribed in the service agreement. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity exceeds the amount owed to them by the Plan, then the excess is remitted to the Plan on a quarterly basis. Such amounts may be used by the Plan to offset plan-related expenses or allocated to the accounts of participants. The balance held by the Plan in the revenue credit account as of December 31, 2024 and 2023 was approximately \$43,200 and \$48,700, respectively. For the year ended December 31, 2024, approximately \$71,000 of the excess revenue was offset to pay plan related administrative expenses and no amounts were allocated to participant accounts.

**Note 6 - Federal Income Tax**

The pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan document was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter; however, the plan administrator, through its adoption of the pre-approved plan document, believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
