A total of 460 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$25,931,127 as of December 31, 2024, compared to \$25,984,999 as of January 1, 2024. During the plan year, the plan experienced a decrease in its net assets of (\$53,872). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$5,398,340, including employer contributions of \$301,936, employee contributions of \$1,063,112, other contributions of \$14,930 and earnings from investments of \$4,018,362.
