As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from the qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**NOTE 1: DESCRIPTION OF PLAN**

The following description of Aircraft Services Employees' Profit Sharing & 401(k) Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A.) General: The Plan, adopted on January 1, 1998 and subsequently amended, is a participant-directed defined contribution plan established to provide retirement benefits to eligible employees, as defined, of Aircraft Services Group, Inc., Flight Line Aircraft Detailing, LLC and Tri-State Heli Group, LLC (together the "Employer" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B.) Administration: The Company supervises and manages the operations and administration of the Plan. Certain employees of the Company serve as Plan Administrators of the Plan. Fidelity Management Trust Company is the Trustee and Custodian (the "Trustee").

C.) Eligibility: All employees of the Company are eligible to make elective deferral contributions or Roth contributions. There are no age or service requirements. The Plan has an automatic enrollment contribution policy which enrolls all new employees into the Plan at 3% deferral of their eligible salary. Employees must opt out of the automatic deferral if desired. An employee is eligible to receive employer matching contributions if the employee has elected deferral contributions. All employees of the Company are eligible to receive an employer nonelective safe harbor contribution. An employee is also eligible to receive employer profit sharing and other elective contributions if the employee completed 1,000 of service and is employed on the last day of the year.

D.) Contributions: Participants may elect to make elective deferral contributions or Roth contributions to the Plan through payroll deductions of up to 90% of their pre-tax base compensation, subject to certain Internal Revenue Service ("IRS") limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024 and 2023. Participants may make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from a qualified savings plan in which employees participated prior to their employment by the Company.

The Company provides a matching contribution of 20% of the participant's first \$3,600 elective deferral. The Plan requires the Company to contribute a nonelective safe harbor contribution for all employees of 3% of eligible salary. The Plan also permits each individual Company to make a profit-sharing contribution and other elective contributions which will be allocated to each eligible participant as designated by the individual Company. Aircraft Services Group, Inc. has elected to make a profit-sharing contribution of 6% of each eligible employee's salary for the year ended December 31, 2024. The total employer contribution, which consists of the matching contribution, nonelective safe harbor contribution and the profit-sharing contribution, amounted to \$572,068 for the year

ended December 31, 2024. The employer contribution due to the Plan as of December 31, 2024 and 2023 was \$527,196 and \$526,856, respectively.

The participant may direct contributions into any one of the several investments offered by Fidelity Retirement Services.

E.) Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution including rollovers, allocations of the Company's matching, safe harbor or profit-sharing contribution and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

F.) Vesting: Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's matching or profit-sharing portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service or reaching the full retirement age.

G.) Notes receivable from participants: Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The minimum loan a participant may borrow is \$1,000 and the maximum number of loans outstanding at any time is one. Loans must be repaid over a period not extending beyond five years from the date of the loan unless the loan is for the purchase of your principal residence which extends the repayment period to ten years. The loans are secured by the balance in the participant's account. The loan interest rate is determined at the market rate at the time of loan origination, as defined. Principal and interest are paid ratably through payroll deductions.

H.) Payment of benefits: Withdrawals by participants during their employment are permitted with certain restrictions. For termination of service, a participant may receive a lump-sum amount equal to the vested amount of his or her account. Upon reaching the age of 73, Participants are required to take minimum distributions from their vested account balance. The Plan requires an automatic distribution of a participant's account if the vested balance is below \$1,000.

I.) Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$142,369 and \$102,828, respectively. These accounts are used to reduce future employer contributions, subject to the Plan's provisions. During 2024, \$122,289 of these forfeited nonvested accounts were used to reduce employer contributions.

**NOTE 2: SIGNIFICANT ACCOUNTING POLICIES**

A.) Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

B.) Use of estimates: The preparation of the financial statements in accordance with accounting principles generally accepted in the United State of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C.) Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion on fair value of measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

D.) Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

E.) Payment of benefits: Benefits are recorded when paid.

F.) Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the recordkeeping and advisory services are allocated each to participant's account and included in administrative expenses. Administration of notes receivable from participants and other direct expenses are charged directly to the participant's account and are included in administrative expenses.

G.) Subsequent events: The Plan has evaluated subsequent events through July 17, 2025, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology includes:

- Quotes prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their fair net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is signification to the fair value measurement.

**NOTE 4: RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity Trust Management Company who is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$27,601 for the year ended December 31, 2024. Note receivables are due from participants of the Plan which qualify as part-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 5: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 6: TAX STATUS**

The IRS has determined and informed the Company by letter, dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the IRS. Although the Plan has been amended since submitting for the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7: CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and

disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee of the Plan.
