Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the NYSUT Staff 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of the New York State United Teachers (NYSUT) who are regularly scheduled to work more than 910 hours during a year.

Participation in the Plan is voluntary. The Plan provides that employees of NYSUT who are receiving compensation are eligible to participate in the Plan on the first day of the first payroll period after the eligibility requirements are met. The Plan's Board consists of six trustees as follows: three NYSUT management trustees who are designated by the NYSUT Executive Committee, and three trustees designated by one from each of the bargaining units. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute pre-tax and post-tax annual compensation up to Internal Revenue Code limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. NYSUT may make a qualified matching contribution to the Plan on behalf of the participants as a percentage of the employee's contribution. The matching contribution is 100% of the participant's contribution up to 4% of annual compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) NYSUT's contribution, and (b) Plan earnings/losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan currently offers various mutual funds, one stable value collective trust, and one participant-directed brokerage account through a regulated investment company. The stable value collective trust contract is an investment, whose objective is to preserve capital and achieve a competitive level of income over time. Participants may change their investment options daily. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options. For fund investment objectives, risks, charges and expenses, participants should contact the fund manager for a prospectus.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Additionally, participants are also immediately vested in NYSUT's matching contribution portion of their accounts plus actual earnings thereon.

Forfeiture

If a participant terminates employment and is less than 100% vested in their Employer Account, they may forfeit the non-vested portion of their Employer Account. A forfeiture will occur in the Plan Year that the participant receives a distribution of their entire vested account, or if they do not receive a distribution, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and will first be used to pay administrative expenses under the Plan, as directed by the Employer. Any remaining amounts will be used to reduce future Employer contributions payable under the Plan. There were no forfeitures for the years ended December 31, 2024 and 2023.

Notes Receivable from Participants

Generally, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the fair market value of their vested account balance. Generally, loan terms range from 1-5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time longer than 5 but no more than 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined periodically by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Distributions

All distributions from the Plan are subject to the Internal Revenue Code sections governing distributions. A participant is eligible to withdraw funds from the Plan for the following reasons:

1. Termination of employment.
2. Hardships as defined by the Internal Revenue Code.
3. Death.
4. Disability.
5. Attainment of age 59 ½ while actively employed.
6. Withdrawal of rollover contribution.

A participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account in periodic installments or a participant may also request a partial one-time distribution amount.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments and Income Recognition

Investments are stated at fair value based upon quoted market prices for mutual funds. The Plan invests in the Fidelity Managed Income Portfolio ("MIP") stable value common collective trust fund. The Plan's interest in the MIP is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported net asset value. The underlying assets owned by the MIP consist primarily of readily marketable fixed income securities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan provided for various investment options in a variety of investment securities. Investment securities are exposed to various risk, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Other Income

Other income is recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by NYSUT and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in investment income.

3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: registered investment companies, which include mutual funds, are valued at the daily closing price as reported by the fund. The registered investment companies held by the Plan are deemed to be actively traded.

Participant-directed brokerage accounts: participant-directed brokerage accounts may include registered investment companies and certificates of deposit, which are valued based on quoted market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares in the registered investment funds and a stable value collective trust managed by Fidelity Management Trust Company. Plan administrative expenses of \$56,325 and \$54,350 were paid by the Plan to Fidelity Management Trust Company, the trustee of the Plan, for the Plan years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

The Plan received \$222,000 from Fidelity Management Trust Company, the trustee of the Plan, for both the Plan years ending December 31, 2024 and 2023 related to revenue sharing, which is a return of service fees that Fidelity Management Trust Company receives from the Plan's investment funds. These transactions qualify as party-in-interest transactions.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have notes receivable to the Plan qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, NYSUT has the right under the Plan, subject to applicable collective bargaining, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan should terminate, the plan administrator will facilitate the distribution of account balances under the provisions of the Plan and trust agreement until all assets have been distributed to the participants.

7. ADMINISTRATION OF PLAN ASSETS

The Plan has entered into a service agreement with Fidelity Management Trust Company (Fidelity). Under the agreement, Fidelity provides trustee services, including responsibility for the safekeeping of plan assets, compliance with participant direction on investing account balances and preparation of financial information including the annual report on federal Form 5500 and annual tax reporting. Fidelity has no discretion or authority with respect to the investment of plan assets and acts solely as a directed trustee of the contributed funds. Fidelity also provides record keeping and processing services. All related fees are an expense of the Plan or NYSUT.

8. INCOME TAX STATUS

NYSUT has adopted a Fidelity Investments pre-approved plan document that has been updated with required amendments, regulatory changes and other enhancements. Although the Plan has been amended since, Fidelity Investments received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with the appropriate sections of the Internal Revenue Code. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events and transactions through July 10, 2025, the date that the financial statements were available to be issued.
