### Note 1 - Plan Description

The following description of Clark Hill Non-Member Attorneys 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all associate attorneys and other attorneys non-key employees, as defined by the plan document, of Clark Hill PLC (the "Firm"). The Firm is the sponsor of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation, plus any catch-up contributions, subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Participants are eligible to defer, on an after-tax basis through regular payroll deductions, a portion of eligible compensation as Roth 401(k) deductions. Provided requirements are met, withdrawals of contributions and any earnings are tax-free to the participant. A participant's combined pretax and Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law.

The Firm may make a discretionary matching contribution up to 6 percent of participant compensation, as defined by the plan document. During the year ended December 31, 2024, the Plan provided a discretionary match of 50 cents on each dollar deferred by the participant, up to 6 percent of compensation, resulting in a maximum 3 percent match. Discretionary matching contributions for the year ended December 31, 2024 totaled approximately \$1,095,000.

The Firm may make annual discretionary profit-sharing contributions. Participants who were active in the Plan any time during the plan year will be eligible to receive an allocation of the Firm's discretionary contribution. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the discretionary employer matching contribution, and allocations of the Firm's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' contributions, the employer discretionary match contribution, and the employer discretionary profit-sharing contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### **Participant Notes Receivable**

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Participants may have up to two notes receivable outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at market rates.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### ***Party-in-interest Transactions***

Certain administrative expenses of the Plan are paid by the Firm, which qualify as party-in-interest transactions.

#### ***Termination***

While it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include corporate stocks and mutual funds that are publicly traded.

All investments are valued based on quoted market prices reported in active markets, including the self-directed brokerage accounts. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including July 17, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

John Hancock Trust Company LLC (the "Trustee") administers the Plan, holds the Plan's investments and participant notes receivable, other than the self-directed brokerage account, and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the self-directed brokerage account, are based solely on information certified by the Trustee.

The Plan's investments in the self-directed brokerage account totaling \$215,607 and \$89,777 at December 31, 2024 and 2023, respectively, and related investment gain of \$27,027 for 2024 were not certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### **Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### **Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

#### **Common/Collective Trust Funds**

The common/collective trust fund is valued at net asset value (NAV) per share or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment.
