Opinion

Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Wisconsin Bankers Association Insurance Trust Fund (the "Group Insurance Arrangement" or "GIA") provides only general information. Participants should refer their individual employer's plan document for a more complete description of the arrangement's provisions.

General

The GIA and related trust were established for the benefit of multiple employers and their employees. The GIA consists of individual health and welfare benefit plans of the respective employers. The GIA files a single Form 5500 on behalf of all participating employers as provided by the Department of Labor's (DOL) regulations, thus relieving these participating employers of their separate Form 5500 filing obligations. The GIA provides group insurance to Wisconsin Bankers Association (WBA), member banks of the WBA and other banks and federally insured depository institutions and their member associations located in the geographic area consisting of three contiguous states, one of which is Wisconsin, and its affiliates who wish to participate. Any eligible employer may participate in the GIA as an employer for the purpose of funding benefits under a welfare plan within the meaning of Employee Retirement Income Security Act of 1974 (ERISA), sponsored by the employer for the welfare of its eligible employees.

In the event there are no employers making further contributions to the GIA at any point in time or if the Wisconsin Bankers Association Benefits and Insurance Committee (BIC), with the approval of the Trustee (as defined in Note 3), should decide to terminate the GIA, then, except as otherwise provided in Regulations of the Secretary of Labor, the trustee shall apply the GIA to the stated purpose of funding benefits under a welfare plan within the meaning of ERISA, and any balance which cannot be so applied shall be utilized for such purposes as, in the opinion of the BIC, will best fulfill the general purposes thereof.

Contributions

Each participating employer acts as the plan administrator for its employees. The GIA agreement provides that the employers make contributions to the GIA for participants in their plans. The employers' contribution rate is determined annually by the insurance carrier's actuary. Each employer must pay the funding requirements for its plan or share such cost with its employees.

Benefits

The GIA provides medical, dental, vision, life, dependent life, accidental death and dismemberment, and long-term and short-term disability insurance for employees of the WBA and participating employees as described above. The benefits to be provided to the participants under the GIA are provided exclusively by fully insured policies issued to the GIA.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the GIA are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results may differ from these estimates. These estimates are subject to changes, and any changes in estimates are recorded in the year the change is determined.

Cash and Cash Equivalents

The GIA considers all highly liquid investments with original maturities of three months or less, including money market fund investments, to be cash equivalents.

The GIA may, at times, have cash balances on deposit that exceed the Federal Deposit Insurance limitation.

Participating Employers' Contributions

Participating employers are billed monthly for contributions due to the GIA based on premium levels established by the BIC and the Insurers. Any adjustments to coverage provided after the monthly invoice for the period is generated are generally adjusted in the subsequent month.

Premiums Paid and Due to Insurance Company

Premiums paid to the various providers are recorded as premiums paid in the statement of changes in net assets. Premiums due to insurance company are those premiums incurred and payable prior to December 31 but not yet paid, if applicable. Contributions received by the Trust prior to the month for which they apply are reflected as "excess employer contributions" in the accompanying financial statements, if applicable.

Income Taxes

The underlying trust has qualified as a tax-exempt organization under Internal Revenue Code Section 501(c)(9) in accordance with a determination letter from the Internal Revenue Service (IRS) dated April 8, 1977. Amendments were made to the trust document and the exempt status was reconfirmed in a letter from the IRS dated November 27, 1996. The GIA intends to continue to comply with all requirements necessary to maintain its tax-exempt status. The GIA is also generally exempt from state income taxes by virtue of its ongoing exemption from federal income taxes. The GIA is subject to Federal and state income taxes on its investment income, unless certain exceptions apply, or any other unrelated business income.

Income Taxes (Continued)

The GIA's management evaluates tax positions taken by the GIA and recognizes a tax liability if the GIA has taken an uncertain position that more likely than not would not be sustained upon examination by applicable tax authorities. The GIA's management has analyzed the tax positions taken by the GIA and has concluded that as of December 31, 2024 there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 3: Related-Party Transactions and Party-in-Interest Transactions

The Bank of Sun Prairie Plan Department (BOSP), Sun Prairie, Wisconsin, is the Trustee and a fiduciary of the GIA. The trustee is an affiliate member of the WBA. The trustee's fees were \$6,000 for 2024. The trustee has custody over the assets of the GIA. In addition, cash and cash equivalents are managed by BOSP. These transactions qualify as party-in-interest transactions.

On behalf of the GIA, BOSP has contracted with Wisconsin Bankers Association Employee Benefits Corporation (EBC), a wholly owned subsidiary of the WBA, to provide administrative services to the GIA. Administrative service fees under this agreement were \$180,000 for the year ended December 31, 2024.

WBA, EBC and FIPCO (another subsidiary of the WBA), are participating employers of the Plan and have contributed \$60,000 of employer contributions during the year ended December 31, 2024.

The GIA is related by overlapping management to the Wisconsin Bankers Association Insurance Trust - Association Health Plan (AHP). The GIA handles certain administrative functions on behalf of the AHP. As part of their arrangement, the GIA collected contributions from AHP member banks of approximately \$16,613,000, which were used to pay premiums of approximately \$16,347,000 to the insurance carrier as well as administrative fees to insurance providers of approximately \$164,000. The GIA collected management fees amounting to approximately \$164,000 for 2024 for these services.

EBC, on behalf of the GIA, funded an additional cash account to track AHP transactions separately from those of the ITF. The intent of both EBC and the GIA is for those funds to be paid back to EBC. Amounts due to EBC were \$100,000 and \$0 as of December 31, 2024 and 2023, respectively.

The Board of Directors are officers of various financial institutions which are participating members of the GIA. Member contributions collected from these financial institutions amounted to approximately \$119,000 for 2024.

The GIA received insurance commissions from insurance providers based upon the insurance provided to AHP member banks and other WBA member banks. Commissions collected by the GIA amounted to approximately \$213,000 in 2024.

Note 4: Major Participating Members

For the year ended December 31, 2024, the GIA had two member banks which accounted for approximately 48% of the GIA's participating employer contributions (excluding passthrough contributions).
