NOTE 1 – DESCRIPTION OF PLAN

The following description of the Project Employee 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General: The Plan is a defined contribution savings plan pursuant to Section 401(k) of the Internal Revenue Code covering substantially all employees of Hinton Transportation Investments, Inc. (formerly Jomar Investments, Inc.) (the “Company” or “Employer”) and provides for retirement and disability benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan upon attaining the age of 18.

Participant Contributions: A participant generally can make voluntary salary or wage deferral contributions of up to 90% of their eligible compensation, subject to Internal Revenue Service limitations. Participants may also contribute rollover amounts representing distributions from other qualified plans. The amounts deferred shall be contributed by the Company on behalf of the participant into the Plan for allocation to the participant’s employee contribution account. In addition, participants may elect to designate a portion or all of their contributions as Roth 401(k) contributions.

Employer Matching Contributions: The Employer has elected to make safe harbor matching contributions to eligible participants in accordance with statutory requirements. Safe harbor contributions are made to all participants making salary or wage deferrals, except to participants who are highly compensated employees. The safe harbor matching contributions in any Plan year is equal to an amount equal to 100% of the first 3% of compensation contributed to the Plan and 50% of the next 2% of compensation contributed to the Plan.

For highly compensated employees, the Employer may make a basic matching employer contribution in an amount equal to a percentage declared for the contribution period. To be eligible for the match, the participant must be employed by the Employer on the last day of the contribution period, unless an exception for death, disability, or retirement applies.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions and (b) the Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings or account balances, as defined. Each participant shall direct the investment of their individual account balance and future contributions among employer selected funds listed as Permissible Investments, maintained by Fidelity Management Trust Company, as Trustee. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death, and Disability Benefits: Under the Plan, a participant (beneficiary) is entitled to 100% of his or her vested account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their elective contributions to the Plan. Participants are also 100% vested in employer safe harbor matching contributions, which were adopted in 2022. Other employer contributions vest after six years of credited service with graduated vesting of 20% per year.

Forfeitures: Forfeited, non-vested amounts included in net assets available for benefits may be used to pay plan expenses or reduce Employer contributions. Direct fees related to the plan are paid by the Plan participants to the extent not covered by forfeited amounts.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants: Plan participants may apply for loans from their accounts under the Plan, subject to the provisions of the basic plan document. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

Payment of Benefits: On termination of service, a participant shall receive an amount equal to the value of the participant's vested interest in their account as a lump-sum payment.

Administrative Expenses: Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA and its regulations. In the event of plan termination, participants will become 100% vested in their employer contributions.

Hardship Distributions: A participant may, with the consent of the Plan administrator, receive a distribution in order to meet a financial hardship as defined in the Plan.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments, which are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – CERTIFIED INFORMATION – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Self-Directed Brokerage Accounts – Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

Money Market Deposit Account – Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1).

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Transactions during the year with parties-in-interest included administrative services and professional audit fees. The Plan incurred administrative expenses of \$26,490 and audit fees of \$14,469 during the year ended December 31, 2024. Substantially all investments and notes receivable from participants held by the Plan are considered party-in-interest transactions. As of December 31, 2024 and 2023, \$29,763,588 and \$25,166,546, respectively, of Plan investments, and \$512,184 and \$460,595, respectively, of notes receivable from participants were managed by Fidelity Management Trust Company or Fidelity Investments, an affiliate.

NOTE 6 – TAX STATUS

The Plan has adopted a prototype document which received a favorable opinion letter from the IRS dated June 30, 2020. Plans that adopt prototype documents are no longer required to file for an individual determination letter. Although the Plan has been amended from the original adopted prototype document, the plan administrator believes that the Plan is designed and is currently being operated under the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustment to and/or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through July 16, 2025, which was the date that the financial statements were available to be issued and has determined that there are no subsequent events to disclose.
