Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KFM Enterprises 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of KFM Enterprises 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan administrator.

General - The Plan is a defined contribution plan in which eligible employees of KFM Enterprises 401(k) Plan (the "Company") may participate. To participate, the employees must be 18 years of age and have worked 90 days. The plan has adopted an automatic deferral whereas upon eligibility the participant is automatically enrolled into the plan and set up to defer 3% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Company contributes a matching contribution of deferrals up to 50% of deferrals up to 6% of compensation approved by the Plan Sponsor. Participants can elect to contribute up to 90% of their compensation or \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions currently at \$7,500 for the 2024 Plan year. Participants direct the investment of their contributions as well as the Company's contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts as investment options for participants.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's discretionary contribution and Plan earnings. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Employees are immediately vested in their voluntary contributions plus their contributions' earnings. Vesting in the Company contributions of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The non-vested balance is forfeited upon termination of service.

Forfeited Accounts - At December 31, 2024, forfeited nonvested accounts totaled approximately \$22,165. Forfeitures are used by the Company to reduce matching contributions, increase matching contributions or to offset plan expenses.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Related fees are recorded administrative expenses and are expensed when they are incurred. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates which are the prime rate plus 2%. Management considers all loans to be well-collateralized and determined that no allowance was necessary to properly state the receivable balance.

Plan Termination - Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Payment of Benefits - The Plan administrator may elect to make a lump sum distribution to a participant with an account valued at more than \$1,000 but less than \$5,000, upon termination of service. For accounts exceeding \$5,000 the participant may elect to receive the distribution. When determining the value of the account, rollover contributions will not be included. Benefit payments to participants are recorded upon distribution.

Basis of Accounting - The Plan's financial statements are prepared under the accrual method of accounting. Employee contributions are recognized in the period the contributions are withheld. The employer's matching contributions are recognized in the same period that the related employee contributions are withheld.

Investments Valuation and Income Recognition - The value of each separate account is determined at the close of each business day based on market value. The value of the account is expressed in "units". The "unit value" is the dollar value of the entire account divided by the total number of units in the accounts.

A contribution to the account increases the number of units. Withdrawals from the account decrease the number of units. The increase or decrease in the number of units is determined by dividing the amount of the contribution or withdrawal by the unit value for the day the transaction is made. The value of the participant's account on any date is determined by multiplying the number of units held by the unit value at the close of the business day. Since these assets in the accounts are credited to or charged against the account without regard to other income, gains or losses of the issuer.

The fair value of the participation units owned by the Plan in the various trust funds is based on redemption values determined by the trustee. Generally, these values are based on the latest available quoted market prices of the underlying investment of the various funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan Tax Status - On June 30, 2020, the Plan adopted a prototype plan document in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Risks and Uncertainties - Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants' account balances and amounts reported in the statement of net assets available for plan benefits.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

3. INFORMATION CERTIFIED BY JOHN HANCOCK RETIREMENT

The Company has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Ruled and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by John Hancock, the custodian, and a party-in-interest as defined by ERISA, as of December 31, 2024, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule. The Plan’s independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by John Hancock the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

The Company provides certain administrative services at no cost to the Plan.

Notes receivable from participants and the Company’s payment of a portion of the Plan’s expenses are considered party-in-interest transactions and are exempt from the prohibited transaction rule.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled separate accounts: Valued at the NAV of units of the separate account. The NAV, as provided by the custodians, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments on these accounts as of December 31, 2024 and 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
