INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of KOA Speer Electronics, Inc. 401(k) Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of KOA Speer Electronics, Inc. 401(k) Pension Plan's Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of KOA Speer Electronics, Inc. 401(k) Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the KOA Speer Electronics, Inc. 401(k) Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee and employer contributions and covers all full time employees of KOA Speer Electronics, Inc. (the “Company” and “Plan Sponsor”). Employees must be age 18 or older to become eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – The Plan provides the participants with the right to allocate their contributions among several investment alternatives. Participants may contribute up to 100% of their compensation not to exceed the ceiling imposed by the Internal Revenue Service (“IRS”).

The Company matches 100% of the first 3% and 50% of the next 3% of the participant’s contributions (“matching contributions”). The Company also made discretionary contributions which amounted to 7% of the participant’s compensation (“discretionary contributions”) for the year ended December 31, 2024. Total Plan contributions cannot exceed the maximum contribution requirements as defined by Section 415 of the IRC.

Administration – The Plan is administered by the retirement plan committee, whose members are appointed by the Plan Sponsor.

Participant Accounts – Separate accounts are maintained for each participant. Each participant account is credited with the participant contributions and allocations of the Company’s contributions and Plan earnings. Participants allocate contributions among a selection of mutual funds and a stable value fund. Allocations of earnings, losses, and expenses are based on participant account balances, depending on the investment options chosen by the participant.

Vesting and Forfeitures – Participants are immediately vested in their voluntary contributions and actual earnings thereon. Matching contributions and rollover contributions are fully vested immediately. All employer discretionary contributions are fully vested after three years of continuous service.

Any portion of a participant’s account that is not vested in accordance with the Plan shall be forfeited upon the occurrence of the participant’s death or five consecutive one-year breaks in service.

Forfeited nonvested accounts may be used to pay Plan administrative expenses or to reduce matching contributions made by the Plan Sponsor. There were forfeitures of \$778 used to offset Plan administrative expenses during the year ended December 31, 2024. There were no forfeitures utilized during the year ended December 31, 2023. Forfeitures of \$12,821 and \$777 were available to offset future administrative expenses or reduce employer matching contributions at December 31, 2024 and 2023, respectively.

1. PLAN DESCRIPTION (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$10,000 or 50% of their vested account balance. A loan is secured by the balance in the participant’s account and bears interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator. As of December 31, 2024, interest rates ranged from 4.25% to 9.50% and the loans mature through August 2029. Principal and interest are paid ratably through regular payroll deductions over a period not to exceed 60 months. If a loan is used to acquire a dwelling unit, the repayment period may extend beyond five years from the date of the loan.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account balance, or installments over various terms. For termination of service for other reasons, a participant may receive the value of their vested account balance in accordance with Plan provisions.

Administrative Expenses – Costs of administering the Plan are shared by the Plan and the Plan Sponsor for the year ended December 31, 2024.

Plan Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants shall be 100% vested in their accounts as of the effective date of the termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan follows generally accepted accounting standards for determining the fair value of assets and liabilities which are subject to reporting at fair value. The Plan utilizes a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2 and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Mutual funds: Valued based on the quoted market prices available on an active market, which represents net asset values (“NAV”) of the shares held by the Plan at year end.

Stable value fund: The fund primarily holds guaranteed and other similar investment contracts that are fully benefit responsive. The fund is valued based on the NAV of the shares held by the Plan at year-end using NAV contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Within the statement of changes in net assets available for benefits, the Plan presents the net appreciation in fair value of investments, which includes the net unrealized and realized gains and losses on investments that were held or sold during the period.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through July 21, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the stable value fund, which is measured at fair value using the NAV practical expedient. The fair value for the stable value fund is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. INCOME TAX STATUS

The Plan Sponsor has adopted the Ascensus, Inc. Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement (the "Prototype Plan"). The Prototype Plan received an Opinion Letter from the IRS dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.

5. TRANSACTIONS WITH PARTIES IN INTEREST

Ascensus LLC is recordkeeper of the Plan, and therefore qualifies as a party in interest. Fees paid during the year for other services rendered by parties in interest were based on customary and reasonable rates for such services.

6. CERTIFIED INVESTMENT INFORMATION

The following is a summary of unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule. The information was prepared by Ascensus Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The trustee has certified that the information is complete and accurate.
