### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hospice of Southern Illinois 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

#### NOTE A | DESCRIPTION OF PLAN

The following description of the Hospice of Southern Illinois, Inc. 403(b) Plan (Plan) is provided for general information purposes only. Participants should refer to the *Plan Document* for a more complete description of the Plan's provisions, which is available from the plan administrator.

##### *General*

The Plan is a defined contribution plan covering eligible and participating employees of Hospice of Southern Illinois, Inc. (Company). Employees are eligible to participate in elective deferrals and discretionary matching contributions in the Plan upon employment. Employees become eligible to participate in discretionary employer contributions in the Plan when they have attained age 21 and completed one year of service. One year of service is defined as working 1,000 hours during a consecutive 12-month period, and the requirement is not satisfied until the last day of the 12-month period. The initial eligibility period ends on the anniversary of the participant's date of hire with subsequent eligibility periods reverting to a plan year. Participants share in employer contributions beginning on January 1<sup>st</sup> or July 1<sup>st</sup> coinciding with or next following satisfaction of the eligibility requirements for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was most recently amended by adopting a volume submitter 403(b) plan effective November 27, 2023 with Lincoln Financial Service Company, LLC. Effective with this amendment, the Plan allows after-tax deferrals and in-plan Roth conversions from contributions sources that are fully vested. Effective with the November 27, 2023 adoption agreement, an automatic deferral provision was also implemented for all new participants at 1% of eligible compensation.

##### *Contributions*

Participants may defer up to 100% of their compensation not to exceed the applicable calendar year limit under Section 402(g)(1) of the Internal Revenue Code, which was \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may elect an additional deferral of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Plan allows for discretionary matching contributions as approved annually by the Company's Board of Trustees. The Company's Board of Trustees approved a matching contribution of 100% of a participant's elective deferral up to 3% of the participant's eligible compensation, for the Plan years ended December 31, 2024 and 2023. Maximum eligible compensation was \$345,000 and \$330,000 for 2024 and 2023, respectively. Matching contributions in the amount of \$185,515 and \$173,031 were deposited into the Plan during the year ended December 31, 2024 and 2023, respectively.

The Plan also allows for discretionary employer contributions as approved annually by the Company's Board of Trustees. Employer contributions are allocated to eligible participants by the ratio of their compensation to the total compensation for all eligible participants. To share in an allocation of this discretionary contributions, participants must also have 1,000 hours of service during the year. There was no employer contribution approved by the Company's Board of Trustees for 2024 or 2023.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. These options include a stable value annuity account and various mutual funds.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution, discretionary matching and employer contributions, and an allocation of Plan earnings. Allocations of Plan earnings are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately 100% vested in their contributions and earnings thereon.

Vesting in the discretionary matching and employer contributions plus earnings thereon is based on years of continuous service. To earn a year of service the participant must be credited with a minimum of 1,000 hours of service during the Plan year. A participant is 100% vested in this portion of his or her account after six years of service. In the event of death or disability while employed, a participant becomes 100% vested. The non-vested balance of a participant's account is forfeited upon the earlier of a five-year break in service or upon distribution of a participant's vested account balance.

#### *Payment of Benefits*

Upon termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive the value of the vested interest in his or her account as a lump sum or partial payment distributions. A participant may also elect to receive an in-service distribution upon attaining age 59 ½ from the employee deferral portion of their account and age 65 from employer matching and other discretionary employer contributions portion of their account.

#### *Plan Termination*

Although it has not expressed an intention to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### *Forfeitures*

Forfeitures plus any earnings or losses may be used to pay the Plan's administrative expenses or to reduce future employer contributions. The Plan had forfeiture account balances in the amount of \$9,148 and \$0 as of December 31, 2024 and 2023, respectively. Forfeitures totaling \$3,739 and \$10,057 were used to pay the Plan's administrative expenses during 2024 and 2023, respectively.

#### *Subsequent Events*

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 18, 2025 the date the financial statements were available to be issued.

### **NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### *Basis of Accounting*

The Plan prepares its financial statements on the accrual basis of accounting.

#### *Valuation of Investments*

The Stable Value investment fund is recorded at contract value which approximates fair value. All other investments are recorded at fair value as provided by Lincoln Financial Service Company, LLC. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note F for discussion of fair value measurements.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

#### *Payment of Benefits*

Benefit payments to participants are recorded when paid.

#### *Plan Tax Status*

The plan sponsor adopted a volume submitter 403(b) plan document which obtained a favorable opinion letter dated March 31, 2017, in which the Internal Revenue Service stated the form of the Plan was acceptable under the applicable requirements of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not received a determination letter specific to the Plan itself. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles (GAAP) requires Plan management to evaluate tax positions taken and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Ascensus, LLC, as an agent for Ascensus Trust Company, the custodian for the Plan from January 1, 2023 to November 27, 2023 and Lincoln Financial Group Trust Company, Inc., the custodian for the Plan from November 27, 2023 to December 31, 2024, have certified the completeness and accuracy of certain information used by management to prepare the financial statements, supplemental schedule and accompanying notes. Accordingly, this information was not audited. The following is a summary of information which is furnished on behalf of the custodian.

**NOTE D | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Included in investments were the following mutual funds and stable value funds representing approximately 32% and 58% of the total investments at December 31, 2024 and 2023, respectively. A significant decline in the market value of these investments could significantly affect the Plan's net assets available for benefits:

#### NOTE E | RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan incurs expenses related to general administration and record keeping. A portion of these expenses and certain accounting and auditing fees related to the Plan are paid by the Plan Sponsor. Expenses that are directly paid by the Plan Sponsor which are not reimbursed by the Plan are not included in these financial statements. Approximately \$17,200 and \$14,000 of administrative expenses were paid by the plan sponsor on behalf of the plan during 2024 and 2023, respectively. These transactions are party-in-interest transactions as defined by ERISA. Certified Plan investments are managed by Lincoln National Life Insurance Company (Lincoln). Lincoln is a regulated insurance company that is affiliated with Lincoln Financial Group Trust Company, who is the Plan's custodian, and holds the assets of the plan; therefore, these transactions qualify as exempt party-in-interest transactions and are noted as such on the Supplemental Schedule of Assets (Held at End of Year).

#### NOTE F | FAIR VALUE MEASUREMENT

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at net asset value (NAV) of shares held by the Plan at year end.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE G | INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds a fully benefit-responsive investment contract with Lincoln National Life Insurance Company. This contract is an unallocated traditional group fixed annuity contract with a 1% guaranteed minimum interest rate. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings on the underlying investments, less participant withdrawals, and administrative expenses. The value of this account was \$1,265,989 and \$823,572 at December 31, 2024 and 2023, respectively.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity was provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.
