### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Knoxville Zoological Gardens, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held at year end as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - PLAN DESCRIPTION

The following brief description of the Knoxville Zoological Gardens, Inc. 401(k) Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established by Knoxville Zoological Gardens, Inc. (the "Zoo") covering employees of the Zoo who are expected to work more than 1,000 hours per year and who have completed 1 month of service and are age 21 or older (one year of service for Employer Matching and Profit Sharing Contributions). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan. The Retirement Committee and management of the Zoo determine the appropriateness of the Plan's investment offerings and monitor investment performance.

**Contributions** - Each year, participants may contribute up to the maximum amount allowed by law of pretax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Zoo may make a discretionary matching contribution and/or profit-sharing contribution in an amount to be determined annually for individuals who are at least age 21 and have completed one year of service. In 2024, the matching formula was the lesser of 50% of the participant deferral amount or 20% of eligible compensation and there was no profit-sharing contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also make Roth, after-tax contributions as defined in the Plan. Effective February 1, 2024, the Plan contains an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan at 3% of pre-tax compensation.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Zoo's matching contributions, as well as allocations of the Plan earnings. Expense allocations are based on participant earnings or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings on the contributions. Vesting in the Zoo's contribution portion of their accounts is based on years of credited service. A Participant is 100% vested after 6 years of credited service.

**Notes Receivable from Participants** - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's account balance and bear interest at a rate of prime plus 1%. A maximum of one loan may be outstanding at any time. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** - On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) may receive the vested portion of the participant's account. The Plan also permits hardship distributions prior to termination of employment upon meeting certain requirements. A participant who has attained the Plan's normal retirement age and who has not separated from service may also request distribution of his or her account balance. Distributions are made in the form of lump sum payments.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,699 and \$3,465 respectively. Forfeited amounts can be used to reduce employer contributions or Plan expenses. Forfeitures totaling \$400 were used to pay Plan expenses in 2024.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The Plan's financials statements have been prepared using the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are recorded at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value).

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement. Notes receivable from participants are considered to be party-in-interest transactions for which a statutory exemption from the prohibited transaction regulation exists.

**Payment of Benefits** - Benefit payments to participants are recorded when paid.

**Expenses** - Certain expenses incurred by the Plan are paid directly by the Zoo and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events through July 21, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

See Independent Auditor's Report.

**NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)**

- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**NOTE 4 - GUARANTEED INVESTMENT CONTRACTS WITH STANDARD INSURANCE COMPANY**

The Standard Stable Asset Fund III (Fund) is a group annuity contract that offers a full guarantee of principal and interest by the Standard Insurance Company (Issuer). The contracts qualify as fully benefit-responsive, as they meet all of the following criteria:

The investment contract is affected directly between the Fund and the Issuer and prohibits the Fund from assigning or selling the contract or its proceeds to another party without the consent of the Issuer.

The contract issuer is obligated to (i) repay principal and interest, or (ii) apply prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.

The terms of the investment contract require all permitted participant-initiated transactions with the Fund to occur at contract value with no conditions, limits, or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined-contribution plan, such as withdrawals for benefits, loans or transfers to other funds within the Plan.

An event that limits the ability of the Fund to transact at contract value with the Issuer (for example, premature termination of the contract by the Fund, Zoo closings, plan termination, mergers and early retirement incentives) and that also limits the ability of the Fund to transact at contract value with the participants in the Fund must be probably of not occurring.

The Fund itself must allow participants reasonable access to their funds.

**NOTE 4 - GUARANTEED INVESTMENT CONTRACTS WITH STANDARD INSURANCE COMPANY (Continued)**

Investment contracts held in the Fund are recorded at their contract value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events may limit the ability of the Plan to transact at contract value .Such events include termination of the contract, spin-offs, divestitures, layoffs, relocation, partial or total plan termination, retirement incentives programs, and the liberalization of the Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants’ contract values are not affected.

The Plan sponsor was not aware of any events that would have limited the Plan to transact at contract values as of December 31, 2024 and 2023 and through the date of these financial statements. The Plan’s assets at contract value as of December 31, 2024 and 2023 are \$44,066 and \$92,541, respectively.

**NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan has obtained certifications from Fidelity Management Trust Company, the current custodian, and Charles Schwab Trust Bank, the former custodian, that the information in the accompanying financial statements and supplementary schedules, with respect to investments and related investment activity is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The investment information certified by the custodians are presented based on their trust certifications:

**NOTE 6 - RELATED PARTY AND PARTIES-IN-INTEREST**

During 2024, the Plan paid \$26,047 in administrative fees to Fidelity Workplace Services LLC, the current recordkeeper and third-party administrator, and \$1,074 to Charles Schwab Trust Bank, the former custodian, which qualify as party-in-interest transactions. Fees and expenses are charged under each participant’s Account.

As of December 31, 2024 and 2023, outstanding notes receivable from participants were \$11,645 and \$7,721, respectively, which qualify as party-in-interest transactions.

The Plan sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, plan participants would become 100% vested in their accounts.

**NOTE 9 - TAX STATUS**

The Plan adopted a non-standardized pre-approved plan document sponsored by Fidelity Workplace Services LLC. The pre-approved document received its latest determination letter in 2022. Although the Plan has not applied for its own determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan recognize a tax liability if the Plan has taken an uncertain position that more likely than no would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods that are in progress.
