INDEPENDENT AUDITORS' REPORT

To the Benefits Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Chick-fil-A, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. PLAN DESCRIPTION

The following description of the Chick-fil-A, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution multiple employer plan covering eligible employees of Chick-fil-A, Inc. (the Company) and certain affiliated companies (all of which are the Employers or the Participating Employer). The eligibility requirements for participation in the Plan are as follows:

- (a) Eligible employees classified as a regular full-time employee or a project full-time employee and who are not a "Highly Compensated Employee" and not eligible for the Plan as described under subsection (b) below, become a participant in the Plan as soon as practicable following the later of the first date of employment or the date the employee turns age 21.
- (b) Eligible employees: (i) employed by Dwarf House Group, LLC, Trilith Outdoors, LLC or COR Restaurant Services, LLC, or (ii) in a classification other than that as described in subsection (a) above, become a participant in the Plan on the first entry date on or after reaching age 21 and completion of one of the following service requirements: (1) one "Year of Service" (minimum of 1,000 hours of service worked) with an employer, or (2) three (reduces to two effective January 1, 2025) consecutive years of service with a minimum of 500 hours of service worked in each year. The entry dates are January 1st and July 1st. This subsection (b) applies to employees classified as, but not limited to: field event staff, infield staff, interns, part-time, modified part-time and temporary.

Effective January 1, 2024, the Plan's eligibility was amended to provide for the participation of employees who meet the long-term part-time service requirement. In addition, effective April 1, 2024, the Plan was amended to add COR Restaurant Services, LLC as a Participating Employer.

The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company, which serves as the Plan administrator, has sole responsibility for administration of the Plan. Those services are provided without charge to the Plan. The Chick-fil-A, Inc. Benefits Administrative Committee (the BAC) provides for the general administration of the Plan. The Chick-fil-A, Inc. Benefits Investment Committee establishes and carries out the investment policies of the Plan. The Company delegates full authority to amend the Plan to the BAC and the Board of Directors.

Contributions

Contributions to the Plan are made by both participants and the Employer. Employer match contributions to the Plan are made concurrently with participants' contributions and are invested among the funds in the same proportion as the participants' contributions. Employer match true-up contributions, and discretionary Employer contributions, if any, are made annually following the end of the plan year.

The Employer matching contribution is a safe harbor contribution and is calculated as 100% of eligible compensation (as defined in the Plan) up to 5% and is vested immediately. A Participating Employer may also elect to make discretionary Employer contributions to the Plan, which if made, are allocated in accordance with the Plan document.

Participants may elect to contribute up to 50% of their eligible compensation (as defined in the Plan) as pretax deferrals, Roth contributions and/or after-tax contributions, subject to certain Internal Revenue Code (IRC) and Plan limitations. The Plan also includes an automatic enrollment feature, applicable to certain employees, that automatically enrolls the employee in the Plan at a rate of 5% pretax deferrals, unless the employee elects otherwise. Participants who are at least age 50 may also make catch-up contributions to the Plan.

In addition, a participant who is actively employed by a Participating Employer may contribute amounts representing distributions from another qualified plan or annuity plan as defined in the Plan document.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions and Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment

Participants direct the investment of their contributions into various investment options offered by the Plan or to an individual brokerage account, which allows participant directed investments in individual stocks and mutual funds. Employer contributions are automatically invested in accordance with the participants' allocation.

Vesting

Participants are immediately 100% vested in their own contributions and the employer matching contributions. Participants vest in discretionary Employer contributions based upon years of service. Vesting for discretionary Employer contributions is ratably at 20% a year after two years of service with full vesting after six years.

Payment of Benefits

A participant's benefits may be distributed the year in which the participant terminates employment, retires, dies, or becomes permanently disabled. Distributions must begin no later than the year following the year in which the terminated participant attains the required beginning date under IRC Section 401(a)(9). Benefits can be distributed in a lump-sum payment, in installments or in a combination of the two. In the event of a hardship, as defined by the Plan, participants may withdraw an amount not to exceed all their salary reductions. The Plan also allows the withdrawal of all or a portion of the participant's rollover contribution account, and participants are allowed to transfer all or a portion of fully vested amounts, subject to certain limitations, to a Roth conversion account within the Plan.

Administrative Expenses

The costs of administering the Plan are paid by the Participating Employer. These costs include legal, accounting and administrative fees.

Income Tax Status

The Plan obtained a favorable determination letter dated October 15, 2009, in which the Internal Revenue Service (IRS) stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrators believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America (GAAP) requires Plan management to evaluate uncertain tax positions taken by the Plan. The Plan administrators are not aware of any uncertain tax positions taken or expected to be taken.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will remain 100% vested in their accounts, and no contributions would thereafter be made to the Plan. The Plan would be appropriately amended to provide for allocation of the remaining assets for the purpose of paying benefits provided in the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include investments in common stocks, mutual funds, and common collective trust funds which invest in various types of investment securities and in various companies within various markets. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the levels of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants'

account balances and the amounts reported in the Plan's financial statements and supplemental schedules.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized gains and losses on investments.

Payment of Benefits

Benefit distributions to participants are recorded when paid by the Plan.

Corrective Distribution Payable

Amounts payable to participants for contributions in excess of the IRC limits are recorded as a liability.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are observable as of the reporting date. These inputs include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock (held in self-directed brokerage accounts (SDBA)): Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of the common collective trust. The NAV, as provided by the Fidelity Management Trust Company, the trustee of the Plan, is used as a practical expedient to estimate fair value. The NAV is based on the fair market value of the underlying investments held by the fund less its liabilities. Participant-directed redemptions have no restrictions and there are no unfunded commitments.

Money market and interest-bearing cash (held in SDBA): Valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by the trustee; therefore, these transactions qualify as party-in-interest transactions. In addition, fees are paid to Fidelity Workplace Services LLC, recordkeeper of the Plan. Fees of \$201,758 were paid to Fidelity entities during 2024.

6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

In 2023, the Company remitted certain contributions totaling \$4,223,822, to the trustee later than required DOL regulations. These transactions constitute prohibited transactions as defined by ERISA. The Plan Sponsor corrected the participant accounts and credited participants with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

7. SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 9, 2025, which is the date the financial statements were available to be issued and have determined that there are no subsequent events that require disclosure under FASB ASC 855, *Subsequent Events*.
