Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of WinShape Foundation, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION

The following description of the WinShape Foundation, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution single employer plan covering eligible employees of WinShape Foundation, Inc. (the Company) and certain affiliate companies (all of which are the Employers or the Participating Employers). The eligibility requirements for participation in the Plan are as follows:

- (a) Eligible employees classified as a full-time employee, who are not a "Highly Compensated Employee" and who are not eligible for the Plan as described under subsection (b) below, become a participant in the Plan as soon as practicable following the later of the first date of employment or the date the employee turns age 21.
- (b) Eligible employees in a classification other than that as described in subsection (a) above, become a participant in the Plan on the first entry date on or after reaching age 21 and completion of one of the following service requirements : (1) one "Year of Service" (minimum of 1,000 hours of service worked) with an employer, or (2) three (reduces to two effective January 1, 2025) consecutive years of service with a minimum of 500 hours of service worked in each year. The entry dates are January 1st and July 1st. This subsection (b) applies to employees classified as, but not limited to: interns, part-time and temporary.

The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company, which serves as the Plan administrator, has sole responsibility for administration of the Plan. Those services are provided without charge to the Plan. The WinShape Foundation, Inc. Benefits Administrative Committee (the BAC) provides for the general administration of the Plan. The WinShape Foundation, Inc. Benefits Investment Committee establishes and carries out the investment policies of the Plan. The Company delegates full authority to amend the Plan to the BAC and the Board of Directors.

Contributions

Contributions to the Plan are made by both participants and the Employers. Employer contributions to the Plan are made concurrently with participants' contributions and are invested among the funds in the same proportion as the participants' contributions.

The safe harbor nonelective contributions are made by Employers on behalf of each eligible participant equal to 3% of the eligible participant's compensation (as defined in the Plan) during the year. In addition to the safe harbor nonelective contributions, an Employer may make discretionary Employer contributions based on a percentage of the participants' eligible compensation determined by the Employer. In 2024, the Participating Employers made a discretionary Employer contribution of 7% of eligible compensation.

Participants may elect to contribute up to 50% of their eligible compensation (as defined in the Plan) as pretax deferrals and/or Roth contributions, subject to certain Internal Revenue Code (IRC). The Plan also includes an automatic enrollment feature that automatically enrolls the employee in the Plan at a rate of 5% pretax deferrals, unless the employee elects otherwise. Participants who are at least age 50 may also make catch-up contributions to the Plan.

In addition, a participant who is actively employed by a Participating Employer may contribute amounts representing distributions from another qualified plan or annuity plan as defined in the Plan document.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings, charged with withdrawals and an allocation of Plan losses and administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions into various investments options offered by the Plan. Employer contributions are automatically invested in accordance with the participants' allocation.

Vesting

Participants are immediately 100% vested in their own contributions and all Employer contributions.

Payment of Benefits

A participant's benefits may be distributed the year in which the participant terminates employment, retires, dies or becomes permanently disabled. Distributions must begin no later than the year following the year in which the terminated participant attains the required beginning date under IRC Section 401(a)(9). Benefits may be distributed in a lump-sum payment. In the event of a hardship as defined by the Plan, participants may withdraw up to 100% of employee contributions. The Plan document was amended to allow withdrawal of all or a portion of the participant's rollover contribution account.

Administrative Expenses

The costs of administering the Plan are paid by the Participating Employer. These costs include legal, accounting and administrative fees.

Income Tax Status

The Plan obtained a favorable determination letter dated April 28, 2009, in which the Internal Revenue Service (IRS) stated that the Plan was in compliance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (GAAP) require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdiction. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan Termination

Although it has not expressed any intent to do so, the Company has the rights under the Plan to discontinue its contributions at any time and terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts, and no contributions would, thereafter, be made to the Plan. The Plan would be appropriately amended to provide for allocation of the remaining assets for the purpose of paying benefits provided in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with GAAP.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include a common trust and mutual funds, which invest in various types of investment securities and in various companies within various markets. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements and supplemental schedule.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are observable as of the reporting date. These inputs include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of the common collective trust funds. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair market value of the underlying investments held by the fund less its liabilities. Participant-directed redemptions have no restrictions and there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by the Trustee and; therefore, these transactions qualify as party-in-interest transactions. In addition, fees are paid to Fidelity Workplace Services, LLC, the recordkeeper of the Plan. Fees of \$11,796 were paid to Fidelity entities during 2024.

6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

In 2023, the Company remitted certain contributions totaling \$418,634, to the trustee later than required DOL regulations. These transactions constitute prohibited transactions as defined by ERISA. The Plan Sponsor corrected participant accounts and credited participants with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

7. SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 9, 2025, which is the date the financial statements were available to be issued and has determined there are no subsequent events that require disclosure under FASB ASC 855, *Subsequent Events*.
