We have performed audits of the financial statements of Bob Evans Restaurants, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Bob Evans Restaurants, LLC 401(k) Retirement Plan (the "Plan") provides general information about the Plan's provisions. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution retirement plan that enables substantially all employees of Bob Evans Restaurants, LLC (the "Company") who have at least 30 days of service to defer a percentage of their wages as a contribution to the Plan, with a portion matched by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2017, Bob Evans Farms, Inc. and Affiliates sold its Bob Evans Restaurants business to Bob Evans Restaurants, LLC, a Delaware limited liability company formed by affiliates of Golden Gate Capital Opportunity Fund, L.P., and divested from the restaurant segment. The newly formed company, Bob Evans Restaurants, LLC, created its own 401(k) plan. Plan assets of employees who transferred to Bob Evans Restaurants, LLC were transferred to the Plan in 2017.

Contributions

Each year, participants may contribute up to 75 percent of pretax or after-tax annual compensation but no more than the limit set by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified plans. The Plan also provides for a discretionary company contribution that is determined annually by the Bob Evans Restaurants, LLC 401(k) Retirement Plan investment committee as a company match. This amount cannot exceed the maximum amount deductible for federal income tax purposes. Matching contributions are made in proportion to the participants' deferred compensation. All contributions are subject to certain limitations of the Internal Revenue Code (the "Code").

Upon enrollment, a participant may direct employee and employer match contributions into various investment options offered by the Plan.

Administration

The Company has appointed an investment committee (the "Committee") to manage the operation and administration of the Plan. The Company has contracted with Empower Annuity Insurance Company and Empower Trust Company, LLC, as the custodians, and Empower Annuity Insurance Company, as the third-party administrator (collectively, Empower), to process and maintain the records of participant data.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings and charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, the former employer base contributions, and former profit-sharing contributions, plus actual earnings thereon. Vesting in the company match portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants are 25 percent vested after two years, then ratably graduating to 100 percent vested after five years of credited service.

Note 1 - Plan Description (Continued)

Benefit Payments

Net assets available for benefits are allocated among the participating employees on the basis of their account balances. Benefits are determined based on the contributions provided by, and allocated to, employees, as described above, and the employees' allocable share of the income and expenses of the Plan. Benefits are generally payable upon the employee's death, retirement, disability, or termination. Benefits can be paid through lump-sum distributions and annuity distributions, depending on the employee's elections.

Participants may also request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

As of December 31, 2024 and 2023, there was \$52,568 and \$56,528, respectively, of nonvested forfeited accounts included in net assets available for benefits that may be used to reduce future employer contributions and to pay for certain plan expenses. The Plan used forfeitures of \$94,646 during the year ended December 31, 2024 to reduce employer contributions. The Plan used forfeitures of \$78,000 during the year ended December 31, 2024 to offset plan expenses.

Party-in-interest Transactions

Certain plan investments are managed by Empower. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempted from the prohibition of party-in-interest transactions under ERISA.

Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100 percent vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Administrative Expenses

Various administrative costs are paid by the Plan's participants.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except the unallocated investment contract, in accordance with Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*. The unallocated investment contract is a group annuity contract with Empower Annuity Insurance Company (EAIC) that invests in the general assets of EAIC. EAIC considers this contract to be fully benefit responsive, and the contract is stated at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts and common/collective trust fund are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are stated at quoted market prices determined in active markets. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date. Interest income is recorded as earned, and dividend income is recorded as of the ex-dividend date. Net realized and unrealized gains or losses on investments include the Plan's gains and losses on investments bought and sold and investments held during the year.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 7, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Empower Trust Company, LLC and Empower Annuity Insurance Company (collectively, the "Custodians") hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax exempt.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Unallocated Investment Contract

In May 2017, the Plan entered into a fully benefit-responsive unallocated investment contract, Guaranteed Income Fund (GIF), with Empower Annuity Insurance Company. Amounts contributed to the contract are deposited in EAIC's general account. Payment obligations and the fulfillment of any guarantees specified in the group annuity contract are insurance claims supported by the full faith and credit of EAIC.

The concept of a value other than contract value does not apply to this product even upon discontinuance of the contract, in which case contract value would be paid no later than 90 days from the date the sponsor provides notice to discontinue. There are no specific securities in the general account that back the liabilities of this annuity contract. The Plan owns a promise from EAIC to pay interest at crediting rates that are announced in advance and guaranteed for a specified period of time, as outlined in the group annuity contract. Interest crediting rates are reviewed on a semiannual basis for resetting.

Note 6 - Unallocated Investment Contract (Continued)

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract is 1.50 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. In addition, there are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
