### 1. DESCRIPTION OF PLAN:

The following description of the English Language Institute in China 403(b) Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a 403(b) defined contribution plan covering employees of English Language Institute/China (the Company). The Plan was established on January 1, 2000, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The retirement plan committee is responsible for oversight of the Plan.

#### CONTRIBUTIONS

All employees working 20 hours or more per week, or working less than 20 hours a week currently but were previously full-time, are eligible to make contributions to the Plan.

Each year, participants may contribute from 1% up to a maximum of 100% of annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes discretionary matching contributions for all participants, excluding overseas-based employees, of 100% of the participants' first 5% of compensation deferred and 50% of each additional percentage an employee defers up to 13% of compensation. Employer matching contributions are remitted in the following calendar year. Employees must be employed as of the end of the Plan year being matched in order to receive the employer match. Contributions to the Plan are subject to certain limitations in accordance with federal income tax regulations.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) the Plan earnings and charged with an allocation of the Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are immediately vested in their voluntary contributions, all contributions made by the Company, plus actual earnings thereon.

1. DESCRIPTION OF PLAN, continued:

### PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or (annual or monthly) installments over an agreed upon period as defined. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

2. SIGNIFICANT ACCOUNTING POLICIES:

### BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual basis of accounting.

### ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from the estimates that were assumed in preparing the financial statements.

### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements, and Note 5 for a discussion on the fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### PAYMENTS OF BENEFITS

Benefits are recorded when paid.

### ADMINISTRATIVE EXPENSES

The Plan paid recordkeeping and investment management fees of \$39,195 during the year ended December 31, 2024. All other administrative expenses, such as consulting and accounting fees, were paid by the Company. Certain employees of the Company perform administrative services on behalf of the Plan and are not compensated by the Plan for these services.

### 4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

As of December 31 2024 and 2023, all investments held at fair value in the accompanying statements of net assets available for benefits consisted of Level 1 mutual funds. The fair value of the mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

5. INVESTMENT CONTRACTS WITH INSURANCE COMPANIES:

The Plan has entered into benefit-responsive investment contracts with Western National (Western). Western maintains the contributions in general accounts. Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the benefit-responsive investment contracts as of December 31, 2024 and 2023, was \$900,965 and \$875,074 respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Western. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by Empower. The prototype plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, which states that the document satisfies the applicable provisions of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PARTIES-IN-INTEREST:

Certain investments for the Plan are shares of mutual funds managed by Fidelity and Empower. These entities perform recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid to these entities by the Plan for recordkeeping services amounted to \$9,748 for the year ended December 31, 2024. Additional fees related to investment advisory services of \$29,447 were paid to other parties-in-interest.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through July 1, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
