## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. Description of the plan**

The following description of the Health Care Logistics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended.

**General**

The Plan is a defined contribution plan covering substantially all employees of Health Care Logistics, Inc. (the “Employer”) who are at least 18 years of age and have completed six months of employment.

**Administration**

The Employer’s Health Care Logistics 401k Committee (the “Committee”) is the Plan administrator and is responsible for the general operation and administration of the Plan.

Empower Trust Company, LLC (“ETC”) is the trustee and holds the Plan’s investments, Empower Annuity Insurance Company of America (“EAICA”) is the insurance company and holds the annuity contract, and Empower Retirement, LLC is the third party recordkeeper.

Merrill Lynch, Pierce, Fenner & Smith Incorporated (“Merrill”) is the Plan’s investment advisor and provides education and Plan services.

**Contributions**

*Employer contributions:*

The Employer provides a safe harbor matching contribution of 100% of the first 3% of the participant’s voluntary contribution and 50% of the next 2% on a payroll period basis. The Employer may also provide an additional discretionary employer matching contribution. There were no additional discretionary employer matching contribution for the years ending December 31, 2024 and 2023, respectively.

The Employer may also provide a discretionary employer contribution, to be allocated in the ratio of a participant’s annual compensation for the Plan period to the total annual compensation of all participants. The annual compensation of each participant taken into account under the Plan is limited to the maximum amount permitted under Section 401(a)(17) of the Internal Revenue Code (the “Code”). There were no discretionary contributions for the years ending December 31, 2024 and 2023, respectively.

*Participant’s voluntary contributions:*

A participant may elect to make a voluntary tax-deferred contribution or Roth contribution of 1% to 100% of their compensation up to the maximum permitted under Section 402(g) of the Code adjusted annually. Section 401(k) of the Code may limit this voluntary tax-deferred contribution.

A newly eligible employee hired on or after April 1, 2023, who has not made an election otherwise, will be enrolled in the voluntary contribution portion of the Plan at a rate of 5%. If a newly eligible employee was hired prior to April 1, 2023, who had not made an election otherwise, they were enrolled in the voluntary contribution portion of the Plan at a rate of 3%. The amount will auto escalate by 1% each January 1 to a maximum of 10%.

*Participant's catch-up contributions:*

Participants who attain age fifty prior to the Plan year-end are eligible to make catch-up contributions, in an amount equal to the maximum allowable under the Code.

**Investment options**

Both Employer and participant contributions are participant directed into various investment options offered by the Plan. The Employer periodically reviews and may make changes to the investment choices available in order to ensure the funds offered are meeting the investment objectives and the financial goals of the participants.

The Plan's investment options offered as of December 31, 2024 include mutual funds, general account product of EAICA, and actively managed investment portfolios consisting of set percentage mixes of certain of the offered mutual funds.

If a participant makes no investment election, all contributions made into such participant's account are invested in the Plan's qualified default investment alternative ("QDIA"). The Plan's QDIA is the actively managed investment portfolio based on the participant's age.

**Participant accounts**

Each participant's account is credited with the participant's and Employer's contributions and allocated investment earnings and administrative expenses. Allocations are based on the participant's account balances or earnings. The benefit to which a participant is entitled is equal to the vested balance in the participant's account.

**Payment of benefits**

The full value of a participant's account becomes payable upon retirement, disability, or death. Upon termination of employment for any reason other than death, participants' vested account balances become payable. Terminated participants with vested balances exceeding the Plan's defined threshold may keep their accounts invested in the Plan. Participants who have reached the age specified in the Plan document are required to take minimum annual distributions in accordance with Section 401(a)(9) of the Internal Revenue Code.

Participants with vested account balances within the thresholds defined in the Plan document, who have not elected to receive a distribution or roll it over to an eligible retirement plan, will have their balances

automatically rolled over to an individual retirement account ("IRA") with a properly accredited and regulated financial institution. All benefits will be paid as a lump-sum distribution. Participants have the option of having their benefit paid directly to an eligible retirement plan specified by the participant.

A participant may request a distribution at any time of their rollover contributions. In addition, a participant, upon reaching age 59½, may withdraw up to 100% of their pre-tax deferrals and Roth deferrals. Additionally, a participant upon reaching age 65 and who is 100% vested may withdraw up to 100% of their account balance. A participant may also request a hardship distribution due to an immediate and heavy financial need based on the terms of the Plan.

**Vesting**

A participant is fully and immediately vested for voluntary, catch-up, rollover, and safe harbor matching contributions. For Employer discretionary and non-safe harbor matching contributions, a participant is credited with a year of vesting service for each Plan year that they are credited with at least 1,000 hours of service.

A summary of vesting percentages for Employer discretionary and non-safe harbor matching contributions are as follows:

**Forfeitures**

Forfeitures are used to offset the Employer's required contributions and may also be applied to reduce plan expenses. Forfeitures utilized to reduce Employer contributions and pay reasonable Plan expenses totaled \$8,848 and \$0 for the years ended December 31, 2024, and 2023, respectively. As of December 31, 2024, the Plan had no unutilized forfeitures, compared to \$2,166 as of December 31, 2023.

**Suspense amounts**

Employer contributions made in excess of allocated amounts are held in a suspense account to offset future required contributions. No amounts were utilized during the years ended December 31, 2024, and 2023. As of December 31, 2024, and 2023, the Plan held \$663 and \$654, respectively, in the suspense account. These balances represent unallocated amounts.

**Amounts allocated to participants withdrawn from the plan**

As of December 31, 2024 and 2023, there were \$0 and \$113,687, respectively, of amounts allocated but not yet paid to participants withdrawn from the Plan.

**Expenses**

A distribution fee for termination or in-service withdrawals are deducted from participants' accounts. In addition, a participant annual fee of 25 basis points charged quarterly on their average account value and is deducted from participants' accounts for recordkeeping. A participant who elects to have their investments managed for them are charge a tiered fee of between 8.75 to 16.25 basis points quarterly based on their average account value. These expenses are reported in the financial statements as administrative expenses. The managed account program ceased in November 2024.

Brokerage fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be.

Other administrative expenses if so elected by the Employer will be paid out of revenue share (see Note 2).

Any additional Plan expenses are paid by the Employer.

**2. Summary of accounting policies**

**Basis of presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting, including investment valuation and income recognition.

**Estimates**

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States, which requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from these estimates.

**Risks**

The Plan provides for the various investment options as described in Notes 1, 4, and 5. Any investment is exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. These risks could result in a material effect on participants' account balances and the amounts reported in the

statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Net appreciation in fair value of investments**

Net realized and unrealized appreciation (depreciation) are recorded in the accompanying statements of changes in net assets available for benefits as net appreciation in fair value of investments.

**Benefit payments**

Benefits are recorded when paid.

**Contributions**

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition**

Plan investments are reported at either fair value or contract value. See Note 4 for further details on fair value measurements and disclosures and for additional information on the Plan's fixed annuity contract, refer to Note 5.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Revenue share**

Revenue sharing and sub-transfer fees received are credited to an administrative account and used to offset administrative fees charged directly to participants. These fees are reported in the Plan's financial statements as part of investment earnings and, when utilized, as administrative expenses.

For the year ended December 31, 2024, the Plan received \$65,471 in fee income and applied \$45,291 toward expenses. For the year ended December 31, 2023, the Plan received \$57,670 in fee income and applied \$37,504 toward expenses.

Additionally, \$14,065 and \$49,801 of revenue sharing was reallocated pro rata to participants based on their account balances during the years ended December 31, 2024, and 2023, respectively.

As of December 31, 2024, and 2023, the Plan held \$11,347 and \$5,232, respectively, in the administrative account. These balances represent unallocated amounts.

**Subsequent events**

Management evaluated subsequent events for the Plan through June 27, 2025, the date the financial statements were available to be issued.

**3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and earnings on investments for the years ended December 31, 2024 and 2023, respectively, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by ETC, and EAICA.

**4. Fair value measurements**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the quoted market price (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully benefit-responsive investment contracts**

Investment in the Empower Annuity Insurance Company of America (“EAICA”) fixed-annuity contract (the “Empower Contract”) is fully benefit-responsive and is recorded at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The crediting rate is based on a formula established by the Empower Contract, but may not be less than 0.00% and is reviewed quarterly for resetting.

For the years ended December 31, 2024 and 2023, the Plan earned both an average and actual yield of 1.41% and 1.23%, respectively, in relation to the Empower Contract.

The Plan’s ability to receive amounts due in accordance with this fully benefit-responsive investment contract is dependent on EAICA’s ability to meet its financial obligations. EAICA’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with EAICA, the contract issuer. Examples of such events include 1) premature termination of the contract, 2) changes to the Plan's prohibition on competing investment options, and 3) bankruptcy of EAICA, the contract issuer.

The fully benefit-responsive investment contract is subject to early termination penalties that may be significant. There are no reserves against contract value for credit risk of EAICA or other matters.

**6. Tax status**

On November 14, 2022, the Internal Revenue Service stated that the non-standardized pre-approved plan adopted by the Employer, as then designed, qualifies under Code Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Plan termination**

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

**8. Related party and parties-in-interest**

The Employer provides certain administrative services to the Plan at no charge. These are exempt party-in-interest transactions. The Plan also pays the investment advisor's, trustee's, and third party record keeper's fees and these transactions are exempt party-in-interest transactions.
