INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Morphic Therapeutic 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Morpnic Therapeutic 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 through February 28, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Morpnic Therapeutic 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

Emphasis of Matter – Plan Merger

As further discussed in Note 7 to the financial statements, the Plan sponsor approved of a plan merger effective February 28, 2025 due to an acquisition of the Plan sponsor. All plan assets and participant balances were transferred from the Plan to the acquirer's 401(k) Plan on that date.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Morphic Therapeutic 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF PLAN

The following description of Morphic Therapeutic 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General –

The Plan is a defined contribution plan covering substantially all employees of Morphic Therapeutic Inc (the Company) as defined in the Plan agreement. Interns and part-time employees scheduled to work less than 24 hours per week are excluded from participating in the Plan. Effective January 1, 2024, pursuant to the Setting Every Community Up for Retirement Enhancement (SECURE) Act 1.0, long-term, part-time (LTPT) employees who work at least 500 hours during three consecutive 12-month periods became eligible to make elective deferrals in the Plan. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2025, all contributions and participant activity in the Plan ceased and all participants in the Plan became participants in The Lilly Employee 401(k) Plan, sponsored by Eli Lilly and Company, on that date. On February 28, 2025, all Plan assets were merged into The Lilly Employee 401(k) Plan. As a result, \$19,254,217 in plan assets were transferred out of the Plan during the period from January 1, 2025 to February 28, 2025, which is noted as a transfer out of Plan on the accompanying Statement of Changes in Net Assets Available for Benefits.

Contributions –

Each year, participants may contribute up to 90% of their eligible compensation, as defined in the Plan agreement, subject to the maximum amount allowed by the Code. Both pre-tax and Roth contributions are permitted under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution equal to 100% of participant deferrals, up to 4% of each participant's eligible compensation contributed to the Plan, plus 50% of participant deferrals that exceed 4% of eligible compensation up to 6% of eligible compensation. During the period from January 1, 2025 to February 28, 2025, there were no safe harbor matching contributions as all contributions and participant activity in the Plan ceased as of January 1, 2025 and all participants in the Plan became participants in The Lilly Employee 401(k) Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts –

Each participant's account is credited with the participant's contribution, the Plan's safe harbor matching contribution, and actual earnings thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting –

Participants are immediately vested in their contributions, safe harbor matching contributions, and rollovers, plus actual earnings thereon.

Notes Receivable from Participants –

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans are required to be repaid within 5 years unless the loan is to be used for the purchase of a primary residence in which case the plan administrator may permit a loan term up to 10 years. Participants may only have 1 loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits –

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum payment, installment payments or partial payments in an amount equal to the value of the participant's vested interest in their account either in a distribution or a rollover. A participant may withdraw from their rollover account at any time. In-service withdrawals from the participant's account are available upon reaching age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$5,000, the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from a participant's vested account balance, with a minimum amount of \$500, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

Forfeitures –

Since participants are immediately vested in all contributions, forfeitures generally result only from excess Company matching contributions forfeited from participants' accounts upon identification. Forfeitures may be used to pay Plan administrative expenses or reduce future Company contributions. At February 28, 2025 and December 31, 2024, there were no unallocated forfeitures. During the period from January 1, 2025 to February 28, 2025, no forfeitures were used to pay Plan administrative expenses or to reduce Company contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition –

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 28, 2025 and December 31, 2024. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits –

Benefits are recorded when paid.

Administrative Expenses –

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The Plan participates in a Revenue Capture Program (RCP) with the trustee. Under the terms of the revenue sharing agreement, any excess revenues received that exceed administrative expenses for the plan year may be allocated to the accounts of participants on a pro rata basis. For the period from January 1, 2025 to February 28, 2025 no RCP amounts were used to pay plan expenses. As of February 28, 2025 and December 31, 2024, there was no balance in the RCP account.

Date of Management's Review –

The Plan has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are defined as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and December 31, 2024.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. FAIR VALUE MEASUREMENTS (Continued)

Common collective trust:

Valued at the NAV of units in the collective trust fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the collective trust fund in order to ensure that securities liquidation will be carried out in an orderly business manner. There were no unfunded commitments as of February 28, 2025 and December 31, 2024.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2024. There were no Plan assets at February 28, 2025.

4. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held as of February 28, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2025 to February 28, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

6. TAX STATUS

The Plan has adopted a volume submitter profit sharing plan and relies on the volume submitter plan sponsor's favorable opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained up on examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN MERGER

Effective February 28, 2025, the Plan merged with and into The Lilly Employee 401(k) Plan. All employees and existing participant account balances were transferred to The Lilly Employee 401(k) Plan on that date.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also participates in a revenue sharing agreement with the trustee. This revenue is used to offset certain amounts owed to the trustee for its administrative services to the Plan. Any excess revenues remaining may be allocated to the accounts of participants.

Notes receivable from participants also qualify as party-in-interest transactions.
