Opinion

Notes to the financial statements

Note 1: Description of Plan

The following description of the Wisconsin Bankers Association Insurance Trust Fund - Association Health Plan (the "Trust") provides only general information. Participants should refer to the plan document for a more complete description of the Trust's provisions.

The Trust provides a fully insured health insurance program to 37 member banks covering approximately 2,000 participants as of December 31, 2024, and 38 member banks covering approximately 1,850 participants as of December 31, 2023. The programs offered to participating member banks cover medical benefits under premium based contracts with United HealthCare Services. Billings to member banks are handled by a third-party administrator and premiums are then remitted to the insurance company who provides the benefits. The Trust records these premiums as income and expense in accordance with generally accepted accounting principles. The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Trust offers benefits to the participating member banks and their covered employees. Any eligible employer may participate in the Trust as an employer for the purpose of funding benefits under a welfare plan within the meaning of ERISA, sponsored by the employer for the benefit of its eligible employees.

Although it has not taken any steps to do so, the Trust's management has the right to amend and terminate the Trust with a written instrument with the approval of the Board of Directors of the Wisconsin Bankers Association Benefits and Insurance Committee, subject to the provisions set forth in ERISA. In the event of the termination of the Trust, any remaining funds shall be used for the benefit of the covered employees on the basis of objective and reasonable standards. In no event shall any of the Trust's funds revert to or be recoverable by the participating member banks.

Participant eligibility for any month is dependent on the participant being an employee or qualified retiree of a member of the Trust. Each member bank can set their own eligibility requirements for their employees or retirees (if applicable).

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Trust are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results may differ from these estimates. These estimates are subject to changes, and any changes in estimates are recorded in the year the change is determined.

Members' Contributions

Members are billed monthly for contributions due to the Trust based on their share of the premiums owed on participation of their covered employees in the Trust's health program. Contributions received by the Trust prior to the month for which they apply are reflected as "excess member contributions" in the accompanying financial statements, if applicable. Any adjustments to coverage provided after the monthly invoice for the period is generated are generally adjusted in the subsequent month.

Premiums Paid and Due to Insurance Company

Premiums paid are based on contracts with the insurance provider. Premiums due to insurance company are those premiums incurred and payable under the contract prior to December 31 but not yet paid, if applicable.

Income Taxes

The underlying trust has qualified as a tax-exempt organization under Internal Revenue Code Section 501(c)(9). The Trust intends to continue to comply with all requirements necessary to maintain its tax-exempt status. The Trust is also exempt from state income taxes by virtue of its ongoing exemption from federal income taxes.

The Trust's management evaluates tax positions taken by the Trust and recognizes a tax liability if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by applicable tax authorities. The Trust's management has analyzed the tax positions taken by the Trust and has concluded that as of December 31, 2024 there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 3: Related-Party Transactions and Party-in-Interest Transactions

The Trust is related by overlapping management to the Wisconsin Bankers Association Insurance Trust Fund (WBA ITF). The WBA ITF handles certain administrative functions on behalf of the Trust. The Trust paid the WBA ITF administrative fees amounting to approximately \$164,000 for 2024.

The Board of Directors are officers of various financial institutions which are participating members of the Trust. Member contributions collected from these financial institutions amounted to approximately \$1,404,000 for 2024.

Note 4: Major Participating Members

For the year ended December 31, 2024, the Trust had one member bank which accounted for 10% of the Trust's member contributions. No amounts were due from this member bank at December 31, 2024.

Note 5: Subsequent Events

The Trust has evaluated subsequent events through June 23, 2025, which is the date the financial statements were available to be issued.
