Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Emeriti Retiree Health Plan for Rose-Hulman Institute of Technology, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Emeriti Retiree Health Plan for Rose-Hulman Institute of Technology's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Emeriti Retiree Health Plan for Rose-Hulman Institute of Technology's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Emeriti Retiree Health Plan for Rose-Hulman Institute of Technology's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of the Emeriti Retiree Health Plan for Rose-Hulman Institute of Technology (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Rose-Hulman Institute of Technology (Institute) covering all eligible employees, as defined in the Plan agreement, who are at least 21 years of age. Employees hired on a seasonal basis, employees not regularly scheduled to perform at least 30 hours of service per week and certain other employees, as defined in the Plan agreement, are excluded from participation in the Plan. The Plan was established July 1, 2014.

The Plan reimburses participants for the cost of eligible medical expenses, as set forth in the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Teachers Insurance and Annuity Association of America (TIAA) served as custodian and recordkeeper of the Plan and TIAA Trust, N.A. served as the trustee of the Plan prior to December 17, 2024.

Effective December 17, 2024, assets were transferred to Alta Trust Company (Alta) as the new trustee of the Plan. As of this date, OneBridge Benefits Inc. (OneBridge) serves as the third party administrator. The conversion initiated a blackout period where participants were unable to request a medical reimbursement or direct or diversify the assets held in their accounts until OneBridge and Alta were able to complete the conversion. Participant contributions continued to be made through payroll, and employer contributions continued to be calculated until these funds were deposited with OneBridge and Alta during 2025, and invested in funds as requested by each participant.

Contributions

Eligible employees may voluntarily contribute a portion of their after-tax annual compensation, as defined by the Plan. The Institute begins making employer contributions to the Plan on behalf of each eligible employee as soon as administratively feasible after the employee attains one year of continuous service. Employees who are 40 years of age and have completed one year of continuous service as of July 1, 2014 are not eligible for the employer contribution unless they elect in writing to waive all rights to the healthcare benefits under the Institute's Early Retirement Plan. The Institute's contribution is based on an annual flat dollar amount for each eligible participant, adjusted annually at the discretion of Plan management. The Institute will cease making employer contributions to a participant's account as of the date when the employee ceases to be employed by the Institute.

In addition, the Institute contributes a stipend to a certain group of retirees to be used for medical insurance premiums. The Institute's contribution is based on a monthly flat dollar amount for each eligible retiree, adjusted annually as determined by Plan management.

Prior to December 17, 2024, retirees would contribute after-tax dollars to the Plan for any additional amounts required to fund their premiums for coverage offered under the Plan. With the transition to OneBridge during December 2024, the after-tax retiree contributions are no longer considered Plan contributions in accordance with the amended Plan Document.

Contributions are held in two separate Voluntary Employees' Beneficiary Association (VEBA) trusts, which is a special type of trust where the earnings on contributions are not taxed. These trusts are separated into one for employees and one for employers.

Participant Investment Account Options

Investment account options available include various mutual funds and a money market fund. Each participant has the option of directing his contributions into any of the investment accounts selected by the Institute and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Institute's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions and earnings thereon. Vesting in the Institute's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 5 years of continuous service. Employer and employee contributions and earnings are preserved and available for reimbursement of future medical expenses. The residual balance (if any) remaining after a participant and any eligible dependents are deceased, is forfeited to the Plan.

Forfeited employer contributions are used to reduce the Institute's future contributions to the Plan. In 2024 and 2023, employer contributions were reduced by \$27,981 and \$16,586 from forfeited nonvested accounts, respectively. The balance of forfeited nonvested accounts was not material at December 31, 2024 and 2023.

Retirement Eligibility and Benefits

A participant who is employed by the Institute meets the requirements for retirement eligibility under the Plan upon attaining age 55 having performed at least 15 years of continuous service or attaining age 65 having performed at least 5 years of continuous service.

Upon meeting the requirements for retirement eligibility under the Plan, participants are reimbursed for allowable medical expenses, including premiums for health insurance coverage, for themselves, spouses, domestic partners and those individuals appropriately designated as dependents.

In addition, participants who have performed at least 5 years of continuous service are eligible for reimbursement benefits from their vested account balance upon termination.

Plan Termination

Although it has not expressed any intent to do so, subject to the terms of its participation in the Emeriti program, the Institute reserves the right to discontinue employer contributions, eliminate any form of benefit, or terminate the Plan at any time subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds and the money market fund are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are recorded at amortized cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan obtained its latest determination letters on March 15, 2017, for the employer VEBA and June 22, 2017, for the employee VEBA, in which the Internal Revenue Service stated that the Plan and related trusts, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and Alta Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 investments include mutual funds and the money market fund. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 investments held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. In addition, The Emeriti Consortium for Retirement Health Solutions, the Savitz Organization, and OneBridge provide certain administrative services to the Plan. The Plan paid administrative fees to the custodian and for other administrative services of \$6,318 and \$5,166 in 2024 and 2023, respectively.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Subsequent events have been evaluated through May 28, 2025, which is the date the financial statements were available to be issued.
