## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Presbyterian Senior Living Defined Contribution Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Presbyterian Senior Living Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Information Required by ERISA**

The supplemental information noted in the table of contents, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF THE PLAN

The following description of the Presbyterian Senior Living Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of PHI (d/b/a Presbyterian Senior Living) (the Company) who have completed one year of service and are age twenty-one or older. Eligible employees include those employed at the Company's controlled affiliates accepted under the Plan: Presbyterian Homes, Inc., Presbyterian Homes in the Presbytery of Huntingdon, Quincy Retirement Community, The Long Community, Presbyterian Senior Living Services, Inc. (d/b/a Glen Meadows Retirement Community), Presbyterian Senior Living Housing Management Corporation, and Cathedral Village. The Plan provides retirement benefits to eligible employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees of the Company is responsible for oversight of the Plan. The Company's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

Effective January 1, 2024, the Plan was amended to freeze all contributions and participation in the Plan. Therefore, no further contributions shall be made by the employer under the Plan, no additional employee shall participate under the Plan, and all plan accounts are 100% vested and nonforfeitable.

#### ***Contributions***

Participant deferral contributions are not allowed. Prior to January 1, 2024, the Company could make a discretionary employer contribution to the Plan, determined by the Board of Trustees. Discretionary employer contributions were allocated in the ratio that the participant's eligible compensation bore to the total eligible compensation of all participants, as defined in the Plan document. Participants may contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans (rollover). There were no rollover contributions in 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers managed portfolio options, various individual mutual funds, and a money market deposit account as investment options for participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with allocations of the Company's employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific

participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

As previously noted, the Plan was amended effective January 1, 2024, to freeze participation and employer contributions under the Plan, and to provide that all participants with an account balance as of the freeze date are 100% vested in their accounts under the Plan.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or for termination of service for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document. In-service distributions are allowed for participants that have reached the age of 59½, subject to the Plan's provisions. The Plan generally requires distributions of account balances less than \$5,000 without the participant's consent. If no election is made by the participant and their balance is greater than \$1,000, funds will automatically rollover into an individual retirement account.

In accordance with the SECURE 2.0 Act, the Plan elected to increase the mandatory distribution amount from \$5,000 to \$7,000 effective January 1, 2024. The Company has not yet amended the plan to reflect provisions outlined in the SECURE 2.0 Act as of the report date; however, the Plan is operating in compliance with the Act's regulations and will be formally amended in 2025.

### ***Forfeitures***

At December 31, 2023, forfeited nonvested accounts totaled \$11,941. These accounts are used to reduce discretionary employer contributions or reallocated once per year among the eligible active participants at the end of each allocation date in which such forfeitures occur. The Company used \$11,941 to reduce the 2023 discretionary employer contribution paid to the Plan in 2024.

During 2024, the Company made a contribution of \$3,104 to restore the accounts of rehired participants, whose accounts had previously been forfeited. As of December 31, 2024, there were no forfeited nonvested accounts.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee and investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan, such as administrative expenses for trustee, recordkeeping, and investment management services are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Subsequent Events***

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued. See Note 9.

## **3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting

Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market deposit account:* Valued at cost plus accrued interest, which approximates fair value.

Certain Plan investments are in a money market deposit account managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to Charles Schwab Trust Bank amounted to \$6,797 for the year ended December 31, 2024.

Conrad Siegel Investment Advisors, Inc., a wholly owned subsidiary of Conrad Siegel Actuaries (Conrad Siegel), is the Plan's investment advisor and recordkeeper. Therefore, these transactions qualify as party in interest transactions. Direct fees paid from the Plan to Conrad Siegel for investment advisory and recordkeeping services amounted to \$122,899 for the year ended December 31, 2024.

Charles Schwab Trust Bank also received revenue from mutual fund service providers for services Charles Schwab Trust Bank provides to the funds. The revenue is used to offset certain amounts owed to Charles Schwab Trust Bank for its administrative services to the Plan. If the revenue received by Charles Schwab Trust Bank from such mutual fund service providers exceeds the amount owed under their agreement, Charles Schwab Trust Bank remits the excess to the Plan's trust as soon as administratively feasible. Such amounts are allocated to participant accounts as investment income. During 2024, excess amounts reallocated to participant accounts amounted to \$761. That amount is included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits. The Plan or the Company may make a payment to Charles Schwab Trust Bank for administrative expenses not covered by revenue sharing.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### **7. TAX STATUS**

The Company has adopted a pre-approved plan provided by Conrad M. Seigel, Inc. The pre-approved plan received an opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. In addition, the opinion letter stated that an employer who adopts the pre-approved plan may rely on the opinion letter with respect to the qualification of its own plan under the Internal Revenue Code (IRC). Although the Plan has been amended since the pre-approved plan received the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and related trust is tax-exempt.

## **NOTES TO FINANCIAL STATEMENTS**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. SUBSEQUENT EVENT**

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. Plan management is evaluating these provisions and will update the Plan's governance and operations.
