

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

### 1. Description of Plan

The following brief description of the TTX Company Thrift Plan for Maintenance and Production Employees (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a Section 401(k) defined contribution plan sponsored by TTX Company (the "Company" or "we") covering all non-salaried employees at the Jacksonville, Mira Loma, North Augusta, and Slaton repair shops and union employees below the level of Supervisor in the Field Maintenance Operations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code.

#### **Eligibility**

Covered employees become eligible to participate in the Plan as of the first day of the payroll period next succeeding his or her date of hire.

#### **Contributions**

Contributions to a participant's account, which are not to exceed the annual contribution limit set by the Internal Revenue Code, arise from the following:

- (a) **Participant Contributions.** A participant's contributions are recognized when deducted from their paychecks. Participants' individual contributions are made through salary deductions and may range from 1% to 99% of eligible compensation. Contributions may be made on a pre-tax basis after-tax basis according to the provisions of the Plan document. Contributions may also include Roth Contributions.
- (b) **Company Matching.** Company matching contributions are recognized at the same time as participant contributions. The Company contributes 50% of the first 6% of eligible compensation that a participant contributes to the Plan.
- (c) **Company Direct Contributions.** Effective June 1, 2021, the Company makes and recognizes direct contributions of 3% of participants' eligible compensation for each payroll period.
- (d) **Automatic Contributions.** Any employee who is eligible to participate in the Plan and has not made a participation election within 30 days after enrollment materials are provided shall be treated as if they elected to have an automatic pre-tax contribution of 3%. Until the participant elects otherwise, the specified pre-tax contribution percentage shall increase by an additional 1% of the participant's compensation as of the beginning of each subsequent plan year, subject to a maximum automatic contribution of 10%.
- (e) **Rollover Contributions.** If a participant participated in a previous employer's qualified plan before joining the Company, he or she can transfer or "roll over" all or part of the eligible money to the Plan. Additionally, an eligible participant may elect to roll over lump sum distributions from the TTX Company Pension Plan. A participant's rollover account is always 100% vested under the Plan and is credited with net investment earnings or losses based on the investment funds chosen. Rollovers are not eligible for Company matching.

## **TTX Company Thrift Plan for Maintenance and Production Employees Notes to Financial Statements**

To comply with the Internal Revenue Code requirement that the Plan be nondiscriminatory in nature, the Plan must pass certain tests annually. If a participant is found to have contributed amounts in excess of amounts allowed, the excess contribution is returned to the participant as a corrective distribution. The testing population includes non-union employees only; the Plan is deemed to pass nondiscrimination testing for all union groups.

### **Participant Accounts**

The benefit to which a participant is entitled is the participant's vested account balance less outstanding loans, if any.

### **Investment Options**

Participants direct the investment of their account balance into various investment options offered by the Plan. Participants may select any of the Plan's investment options in multiples of 1% and may change their investment elections at any point in time. If participants are automatically enrolled, contributions are invested in an investment fund determined by the TTX Company Pension and Benefit Committee ("Committee") until changed by the participant.

### **Vesting**

Participants become 40% vested in Company contributions after two years of service and evenly thereafter, becoming fully vested after five years of service. Participants become fully vested in otherwise unvested Company contributions upon retirement after age 60 or upon termination due to death, disability (as defined in the Plan), or reduction in work force. Participants are always fully vested in their personal contributions plus actual earnings thereon.

### **Administration of the Plan**

The Committee administers the Plan. Vanguard Fiduciary Trust Company ("Trustee") is the trustee for all Plan assets other than those assets invested in a pooled separate account group annuity contract, the VOYA Intermediate Stable Value Fund ("VOYA ISVF"), provided by VOYA Retirement Insurance and Annuity Company ("VRIAC"). The Company, on behalf of the Plan, is the holder of this contract. The guarantee provided by the contract is based on the claims-paying ability of VRIAC supported by the full faith and credit of VRIAC. The recordkeeper for the Plan is the Vanguard Group.

### **Administrative Expenses**

The Company pays the fees and expenses of plan-level matters such as accounting, legal, compliance, and investment advisory services. Plan participants pay fees for loans and distributions. Recordkeeping fees are charged against participants' investment earnings.

### **Notes Receivable from Participants**

Subject to such rules and limitations as may be established from time to time, participants are allowed to borrow 50% of their vested account balance up to \$50,000. The interest rate on a loan is fixed at the applicable prime rate in effect on the date of the loan. Loan repayments are made by payroll deduction, typically over a period of five years for general-purpose loans or thirty years for a home purchase, at the election of the participant. As of December 31, 2024, participant loans have maturities through 2053, at Interest rates ranging from 3.25% to 8.5%.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

## Notes to Financial Statements

### Payment of Benefits

Upon termination of employment, a participant may elect to receive a lump-sum distribution equal to his or her vested account balance less outstanding loans, if any. Vested balances less than \$5,000 are automatically distributed within 60 days after employment is terminated. A participant may elect to receive a partial distribution of his or her vested account balance.

### Interplan Transfers

Employees may be transferred within the Company, which may result in a transfer of assets between the Plan and the TTX Company Thrift Plan. Such asset transfers are shown as Interplan transfers in the Statement of Changes in Net Assets Available for Benefits.

### Plan Transfers

During 2023, the TTX Company Cash Balance Pension Plan was liquidated, and \$2,576,082 surplus funds were transferred to the Plan. In 2024, \$56,255 of surplus funds were used to fund employer contributions. As of December 31, 2024, all surplus funds were used.

### Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their account balances.

## 2. Summary of Significant Accounting Policies

### Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the VOYA ISVF, which is stated at contract value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 6 and 7.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of year.

### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. For reporting on Form 5500, if a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded. See Note 9.

## Notes to Financial Statements

### Benefits Payments

The Plan accounts for withdrawals when paid. For reporting on Form 5500, withdrawals are recorded in the period such amounts are authorized to be paid. Such treatment may result in a difference between the Plan's Form 5500 and the accompanying financial statements. There was no such difference in 2024 or 2023.

### Forfeiture of Benefits

Forfeiture of the non-vested portion of Company contributions is determined and recognized at the time of a participant's termination of employment. Forfeitures are utilized, upon the Committee's sole discretion, to reduce Company contributions in future periods or to pay for Plan administration expenses. Amounts forfeited during 2024 were \$257,646. Forfeited amounts applied as Company contributions in 2024 were \$250,202. At December 31, 2024 and 2023, forfeiture balances were \$20,049 and \$10,410.

### 3. Certified Investment Information

The following data disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee:

- Investments at fair value as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Interest income, dividend income and interest from notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- Net appreciation in fair value of investments of \$7,081,207, excluding \$51,718 of deposited, noncash checks and \$467 of miscellaneous income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- All investment balances and classification disclosed in Note 6, excluding the level of investments
- Form 5500, Schedule H, Part IV, Line 4i, - Schedule of Assets (Held at End of Year) excluding the VOYA ISVF as of December 31, 2024

### 4. Tax Status

The Plan has a determination letter, dated February 1, 2016, from the Internal Revenue Service stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan continues to be designed and operating in compliance with the applicable requirements of the Internal Revenue Code.

## TTX Company Thrift Plan for Maintenance and Production Employees Notes to Financial Statements

We have analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the Plan is no longer subject to income tax examinations for years prior to 2021.

### 5. Risks and Uncertainties

The Plan provides for various investment options in funds that invest in combinations of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks such as interest rate, economic, market, credit, currency and political. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### 6. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are classified according to a three-level hierarchy based on management's judgment about the reliability of the inputs used in the fair value measurement. Level 1 inputs are quoted prices available in active markets for identical assets or liabilities. Level 2 inputs are observable, either directly or indirectly, and include quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Level 3 inputs are unobservable, meaning they are not supported by data outside the reporting entity. Fair value measurements classified as Level 3 typically rely on the use of pricing models and discounted cash flow methodologies where significant management judgment is required. The fair value measurement level within the fair value hierarchy is determined by the lowest level of any input that is significant to the fair value measurement. The valuation techniques used strive to maximize the use of observable inputs and minimize the use of unobservable inputs. Investments in mutual funds are valued at the net asset values ("NAV") of shares held at year end. Mutual funds have a quoted market price in an active market and are considered Level 1 inputs.

### 7. Contract Value Investments

The Plan includes assets invested in a fully benefit-responsive group annuity contract, the VOYA ISVF, provided by VRIAC, which is included in the Plan at contract value. The VOYA ISVF generally provides daily market liquidity to the Plan. In extraordinary conditions, however, VRIAC may choose to impose restrictions on daily transactions. The ability of the VOYA ISVF to be fully participant-responsive to daily requests is also dependent on the claims-paying ability of VRIAC. In addition, if this contract is discontinued, for whatever reason, the determination and distribution of the separate account balances would be made per the terms of the contract.

### 8. Party-in-Interest Transactions

The Plan invests in shares of mutual funds managed by an affiliate of the Trustee. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rule. Notes receivable from participants also qualify as party-in-interest transactions.

### 9. Reconciliation of Financial Statements to the Form 5500
