INDEPENDENT AUDITOR'S REPORT

To the Participants and Management of
Neotiss High Performance Tube Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Neotiss High Performance Tube Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Neotiss High Performance Tube Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(c)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103.5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Neotiss High Performance Tube Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a cash or deferred arrangement under 401(k) of the IRC and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is also intended to be a 404(c) Plan. Under a 404(c) Plan, an employee may select the investments for all or a portion of the account under the Plan.

Plan Sponsor, Administration and Spin-off. In 2016, Neotiss, Inc. (the Company) was spun-off from Vallourec North America. Coincident with the spin-off, Neotiss, Inc. established this Plan, the Neotiss High Performance Tube Retirement Savings Plan. Effective July 1, 2016, (the Transfer Date) the participant account balances and assets related to participating Neotiss, Inc. employees were transferred to the Plan.

The Plan is administered by the Neotiss, Inc. 401(k) Fiduciary Committee. T. Rowe Price Retirement Plan Services, Inc. serves as the record keeper and T. Rowe Price Trust Company serves as trustee of the plan.

Eligibility and Contributions. All full-time employees who are 18 years of age or older are eligible to participate in the Plan. A participant may elect to contribute up to 100% of his or her compensation in any plan year subject to maximum deferral amounts set forth in the Internal Revenue Code. Roth deferrals are also permitted. A Roth Deferral is an elective deferral the participant irrevocably designates as a Roth deferral and is subject to income tax when contributed to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan sponsor provides a Safe Harbor Non-Qualified Automatic Contribution Arrangement matching contribution equal to 100% match for the first 3% of compensation contributed and if applicable, a 50% match for the next 3% compensation contributed as defined in the plan document. The Plan sponsor may also provide a discretionary, qualified non-elective contribution. Employer contributions are invested in accordance with the participant’s election.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. The employee’s deferrals, rollovers and employer’s actual deferral percentage (ADP) Safe Harbor Non-elective contributions are fully vested at all times.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants. Participants may borrow from their vested fund accounts as described in the Plan document.

Investment Options. The Plan's investment options are managed by T. Rowe Price Trust Company, the trustee of the Plan. Upon enrollment in the Plan, a participant may direct employee contributions in 1% increments in any of the available funds managed by T. Rowe Price Trust Company.

Payment of Benefits. On termination of service due to death, disability or retirement the vested balance is paid in a single sum if the participant's vested account totals \$5,000 or less. If the participant's vested balance exceeds \$5,000 he or she may elect to have the vested account paid in either a single payment or in a series of payments over a period of time based on options chosen by the participant. Additional guidelines may apply based on the participant's age, vested balance and current or prior marital status. Benefit payments are expensed when paid.

Forfeited Accounts. Forfeitures of participant non-vested account may first be used to pay Plan expenses, and then to reduce future employer contributions. There were no forfeitures during the Plan years ended December 31, 2024 and 2023.

Administrative Expenses. The Plan permits the payment of the Plan expenses to be made from the Plan assets. If the Company does not pay these expenses, then the expenses paid using the Plan's assets will be allocated among the participant accounts.

Plan Termination. Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets must be used for the exclusive benefits of the participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as reported by the trustee, T. Rowe Price Trust Company. Shares of mutual funds and pooled separate accounts are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains and losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments in registered investment companies (mutual funds) are valued at amounts representing the net asset values of shares held by the Plan at year end as determined by T. Rowe Price Retirement Plan Services, Inc.

Notes Receivable from Participants

Loan terms range from one to five years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 4.25% to 9.5% on all outstanding loans. Principal and interest are paid ratably through bi-weekly payroll deductions. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Accordingly, no allowance for loan losses is considered necessary.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions

There were no excess contributions by Plan participants during the plan years ended December 31, 2024 and 2023.

NOTE 3 - CERTIFIED FINANCIAL DATA

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, information certified by the Plan's custodian, T. Rowe Price Retirement Plan Services, Inc. as of December 31, 2024 and 2023 and for the years then ended, was not audited, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 consists of unadjusted quoted prices in active markets for identical assets or liabilities, and has the highest priority.
- Level 2 consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by the T. Rowe Price Retirement Plan Services, Inc. T. Rowe Price Retirement Plan Services also provides recordkeeping services to the Plan. Therefore, transactions relating to these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management and administration services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

NOTE 6 – TAX STATUS

The Plan is using a prototype plan approved by the Internal Revenue Service (IRS) and accordingly, has neither applied for nor received a determination letter from the IRS. The Employer believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management believes there are no uncertain tax positions requiring recognition in the financial statements.

NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS

As of December 31, 2024, there were \$1,376,325 in payments that had been requested to be paid to participants who were no longer employees of the plan sponsor.

NOTE 8 – SUBSEQUENT EVENTS

The plan administrator evaluated events and transactions subsequent to December 31, 2024, through the date of the independent auditor's report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The plan administrator has not identified any items requiring disclosure.
