**Basis for Opinion**

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due, or which may become due, to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of DeNoon Lumber Company, LLC Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of the DeNoon Lumber Company, LLC (the “Company”) who have completed one year of service. A year of service is defined as a 12-month period immediately following the employee’s date of hire, during which an employee is credited with at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the Company. The Company has responsibility for the day-to-day operations of the Plan. The Company maintains the Plan records, provides forms necessary to request a distribution from the Plan, and directs the payment of vested benefits when required under the Plan.

Participant Accounts

Under the Plan provisions, each participant's account is credited with the participant's contribution, the Company's contribution, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon units accumulated by each participant's account. Units are apportioned based upon participant earnings. The benefit to which each participant is entitled is that which can be provided from the participant's vested account.

Contributions

If an employee has satisfied the conditions for participating in the Plan, the participants will be able to make salary deferrals to the Plan. Participants must complete a salary deferral election requesting that a portion of their compensation be contributed to the Plan instead of being paid as wages. The employee contributions are permitted to be in the form of pre-tax deferrals or Roth deferrals.

In addition, eligible participants making deferrals to the Plan, employed on the last day of the plan year, and have worked 1,000 hours during the plan year will be able to receive a discretionary employer matching contribution. The employer will decide each year how much, if any, to make as a matching contribution. The matching contribution will be determined as a percentage of any salary deferrals made during each payroll period or as a uniform dollar amount. At December 31, 2024 and 2023, the employer contribution receivable was \$352,565 and \$357,824, respectively.

Vesting

Employees are immediately vested in their salary deferrals plus earnings thereon. An employee’s “vested percentage” for certain employer contributions is based on vesting years of service. Employees will have complete ownership interest in employer contributions upon the completion of 6 years of vesting service. Prior to the completion of 6 years of vesting service, employees will become vested as follows: 0 percent for less than 2 years; 20 percent after 2 years; 40 percent after 3 years; 60 percent after 4 years; 80 percent after 5 years; and 100 percent after 6 years.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with the prime rate plus 1.0 percent at time of origination. Principal and interest are paid ratably through biweekly payroll deductions.

Payments of Benefits

Upon termination of service, participants whose accounts do not exceed \$5,000 will be eligible to receive a lump-sum amount equal to the vested value of his or her account. Participants whose vested account balance at the time of termination exceeds \$5,000 may elect to receive a lump-sum amount equal to the vested value of his or her account or a joint and survivor annuity payment.

Forfeitures

If a participant terminates employment before being fully vested, the non-vested portion of the terminated participant's account balance that remains in the Plan is forfeited. Forfeitures of participant's nonvested accounts are used to pay Plan expenses or to reduce future employer contributions. At December 31, 2024 and 2023, the balance in the forfeiture account was \$19,002 and \$12,799, respectively. For the Plan year ended December 31, 2024, \$5,503 was used to reduce the Plan administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

NOTE 3 – INVESTMENTS

The Plan investments are administered by Voya Retirement Insurance and Annuity Company (VRIAC) (the “Custodian”). The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the Custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the Custodian that information provided to the Plan Administrator by the Custodian related to the following investments is complete and accurate. Accordingly, as permitted by CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator elected to have an ERISA Section 103(a)(3)(c) audit and instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedule, related to investments:

VOYA Retirement Insurance and Annuity Company also certified to the accuracy of \$78,604 of interest and dividend income and \$2,846,941 of net appreciation in fair value of investments for the year ended December 31, 2024.

NOTE 4 – GUARANTEED ANNUITY INSURANCE CONTRACT

The Plan entered into a benefit-responsive investment contract with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value as reported by VRIAC. As previously described, the guaranteed investment contract is considered not fully benefit responsive since the group annuity contract may have the potential to restrict certain transfers and withdrawals. There are no reserves for credit risk of the contract issuer or otherwise.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts.

NOTE 6 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Custodian by letter dated August 11, 2020, that the Plan, a prototype money purchase pension plan, and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts that are managed by the Trustee of the Plan. Therefore, related transactions qualify as party-in-interest transactions.

The Company absorbs certain costs incurred in relation to the administration of the Plan. Such costs pertain to accounting matters absorbed by the Plan Sponsor in the amount of \$7,000 for the year ended December 31, 2024. There were no legal matters to note. In addition, the investment products are fixed and variable annuity contracts that are offered by VRIAC.

NOTE 8 – FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan discloses the fair value of its financial instruments. Financial instruments are defined as cash, evidence of ownership in an entity, or a contract that creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. If a quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument. The fixed and variable rate annuity contracts and contribution receivables would be considered financial instruments. At December 31, 2024, the carrying amount of these financial instruments approximates fair values.

NOTE 9– FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described as follows:

- *Level I:* Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.
- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- *Level III:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

NOTE 9– FAIR VALUE MEASUREMENTS (Continued)

Pooled Separate: The unit value is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants and are reflected in the unit value.

Group Annuity Contract: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract as calculated by the annuity provider.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 11 – SUBSEQUENT EVENTS

Management has reviewed events occurring through July 17, 2025, the date that the financial statements were issued, and no subsequent events have occurred requiring disclosure.
