The Plan Administrator and Participants of 403(B) Thrift Plan of Carter Burden Network, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(B) Thrift Plan of Carter Burden Network, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

Effective July 1, 2008, The Carter Burden Network, Inc. (the "Employer") adopted the 403(B) Thrift Plan of Carter Burden Network, Inc. (the "Plan"). The following description of the Plan and summary of major Plan provisions provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Employer is the sponsor of the Plan and the insurance company is Mutual of America Life Insurance Company ("MOA"). The insurance company manages the investments of the Plan. Employees are eligible to participate in the Plan on their date of hire.

Salary Reduction Contributions

Each payroll period, participants may contribute pre-tax, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible employees are automatically enrolled in the Plan with 1% being deducted from the employees' pay. Employees have the option of not participating by accessing their account online and completing a change in enrollment form to decrease or increase their contribution rate or to not participate.

Employer Matching Contributions

The Plan provides employer matching contributions to all active, contributing participants based on 50% of their contributions to the Plan, and not to exceed 50% match of the first 4% of their salary. Participants must complete one year of service to receive employer matching contribution. Part time employees are eligible after the latter of 1,000 hours of employment or 12 months of employment to receive employer matching contribution.

Employer Base Contributions

The Plan provides a 3% employer base contributions to all eligible employees whether contributing or not, based on their eligible compensation (as defined in the Plan) not to exceed the IRC annual limit. Participants must complete one year of service to receive employer base contribution. Part time employees are eligible after the latter of 1,000 hours of employment or 12 months of employment to receive employer base contribution.

Participant Accounts

Each participant's account is credited with Employer and participant contributions and the investment earnings thereon. The contributions are allocated among the investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (*continued*)

Vesting

Each participant is fully vested in his or her own contributions and earnings at all times. A participant is fully vested in Employer contributions after completing three years of vesting service with no partial vesting. A participant is also fully vested upon attainment of age 65, upon death or if they become totally and permanently disabled.

Forfeitures

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participant's account balance will be forfeited as of the termination date. Any forfeiture not restored may be used by the Plan first to pay certain Plan expenses and any amount remaining will be used to reduce future Employer contributions. If a participant is reemployed before incurring five consecutive one year breaks-in-service, the forfeited portion of his accounts, determined as of the date the accounts were distributed shall be restored from the forfeitures.

At December 31, 2024 and 2023, forfeited account balances held in nonparticipant directed accounts were \$46. No amounts were used to pay Plan expenses and \$8,464 was used to reduce Employer contributions during 2024.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the available investment options sponsored by the Plan.

Loans to a Participant/Collateralized Assets

Participants may borrow from MOA and use their Plan account balance (invested in the guaranteed interest contract) as collateral. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balance or \$50,000. The loan bears interest at a rate commensurate with local prevailing rates at the time the funds are borrowed as determined by MOA. Loan terms range from 1 to 5 years; however, terms may be extended up to 10 years for the purchase of a primary residence. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside the Plan. Therefore, the loans are not shown on the statements of net assets available for benefits. As of December 31, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$144,053 and \$43,283.

Of these loan balances, there were none in default as of December 31, 2024 and 2023. At December 31, 2024, the loans had an interest rate of 5.85% with maturities through 2027.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant is entitled to receive a distribution in the amount equal to the total value of the participant's vested account balance.

Hardship withdrawals are allowed, but cannot exceed the amount of the immediate need, including amounts necessary to pay any federal, state or local income taxes or penalties reasonably anticipated to result from the withdrawal.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the insurance company general account, which is stated at contract value. Separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The insurance company general account is valued at contract value, which represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation

The Plan administrator has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

4. Investments

Insurance Company General Account

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America Life Insurance Co. (“Mutual of America”). Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00%. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The principal and previously credited interest is guaranteed by Mutual of America. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), Standard and Poor’s (A as of December 2022), and Fitch (BBB+ as of April 2025).

The Mutual of America Interest Accumulation Account represents 26% of the Plan’s net assets available for benefits at December 31, 2024 and 2023.

4. Investments (*continued*)

Separate Accounts

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan's separate accounts include various asset classes which are: equity funds, fixed income funds, growth funds, money market funds, balanced funds, bond funds, asset allocation funds, and retirement funds.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant accounts will become 100% vested in any unvested Employer contributions allocated to their accounts.

6. Tax Status

The Employer has adopted an IRS approved volume submitter plan that received an Internal Revenue Service ("IRS") opinion letter dated March 31, 2017. The Plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest

All investments of the Plan are managed by MOA, the asset holder and record-keeper of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals, and no costs are charged to the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements, and future effects of the Plan's net assets available for benefits cannot be predicted.
