Note 1. Description of Plan

The following description of the Goya Foods, Inc. Retirement & 401(k) Savings Plan (Plan) provides general information only. Participants should refer to the summary plan description and plan document for more complete information.

General

The Plan was established on January 1, 2007 and amended and restated effectively April 27, 2021. The Plan was amended to reflect the Bipartisan Budget Act of 2018, and Code Sections 401(k) and 401(m) 2019 Final Hardship Regulations as well as the adoption of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act. The Plan is a defined contribution plan that consists of non-union employees of Goya Foods, Inc., its subsidiaries, and participating affiliated employers (collectively, the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company are eligible to participate in the Plan on the date closest to the Plan's entry dates and upon the attainment of 18 years of age, subject to the exclusions noted in the plan document. The Plan's entry dates are January 1, April 1, July 1, and October 1.

Contributions

The Plan provides eligible employees with an opportunity to make elective salary deferral contributions to the Plan, subject to the limitations of the Internal Revenue Code (IRC).

The Plan was amended effective November 3, 2023 to permit eligible employees to make Roth contributions.

Eligible employees are automatically enrolled in the Plan on the first entry date following their hire date at a pre-tax deferral percentage of 2%. Employees may elect not to participate in the Plan. Employees will automatically have their pre-tax deferral percentage increased by 1% to 3% in the first payroll in January after six months of participating in the Plan.

The Company is required to make on a payroll period basis, a safe harbor matching contribution equal to 100% of participants' elective salary deferral contributions up to 3% of eligible compensation and 50% of participants' elective salary deferral contributions that exceed 3% of eligible compensation not to exceed 5%.

The Company can also make a discretionary matching contribution for each eligible participant in accordance with the provisions contained in the plan document. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

In addition to the safe harbor matching contribution, the Company can make discretionary non-elective contributions in accordance with the provisions contained in the plan document. Employees are eligible for such contributions after one year of service, during which they must complete 1,000 hours of service and be employed on the last day of the year. There were no non-elective contributions for the years ended December 31, 2024 and 2023.

Vesting

Participants are fully vested in their own contributions and safe harbor matching contributions immediately and are fully vested in the Company's employer matching and non-elective contributions after completing three years of service.

Participant Accounts

Each participant's account is credited with their participant contributions, employer contributions, and earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Forfeitures

The portion of a terminated participant's account balance which is not vested is forfeited and remains in the Plan. The Plan provides for terminated employees who resume employment within five years to have any forfeited amounts reinstated ("reinstatement period") if the employee repays the full amount of the distribution attributable to vested employer contributions prior to the end of the reinstatement period. Plan participants' forfeitures may be used to pay plan expenses for the plan year in which the forfeitures are to be allocated or to reduce the Company's safe harbor matching, discretionary matching, and non-elective contributions for the plan year. Forfeitures of \$6,775 and \$1,079 were applied in conjunction with the payment of plan expenses for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to reduce employer contributions for the years ended December 31, 2024 and 2023. Forfeitures for the years ended December 31, 2024 and 2023 were \$4,130 and \$5,957, respectively. Amounts remaining in the forfeiture account as of December 31, 2024 and 2023 were \$19,867 and \$18,045, respectively.

Payment of Benefits

A participant's vested interest in his or her account balance is distributable generally upon termination, disability, retirement, or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan.

Under certain conditions, a contributing participant could make withdrawals from the vested portion of his or her account balance prior to termination of employment by filing a withdrawal form. Two types of withdrawals are available to participants: regular and hardship. Regular withdrawals are available to participants over the age of 59 ½. Hardship withdrawals, as defined by the Internal Revenue Code ("IRC"), may be granted to participants under the age of 59 ½ without penalty. Effective April 1, 2019, hardship withdrawals are permitted from employee contributions only.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Administrative expenses consist of fees for recordkeeping, investment management, advisory, and audit services.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Investment Information Certified by the Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used December 31, 2024 and 2023:

Common collective trusts: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which represents the net asset value. Participant-directed redemptions can be made on any business day and do not have a redemption notice period. There are no unfunded commitments.

Mutual funds: Stated at fair value based on unadjusted quoted prices in an active market for each share held by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party Transactions

Certain Plan investments are managed by Fidelity and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$130,213 and \$121,682 for the years ended December 31, 2024 and 2023. Fees paid to the Plan's investment advisor and auditor also qualify as party-in-interest transactions. Fees paid for investment advisory services amounted to \$0 and \$20,879 for the years ended December 31, 2024 and 2023, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer reserves the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan's investments include mutual funds and a common collective trust that invests in various investment securities. Such securities are subject to various risks that affect the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities it is at least reasonably possible that the changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 9. Subsequent Events

Subsequent events have been evaluated through July 18, 2025, which is the date the financial statements were available to be issued.
