NOTE A - DESCRIPTION OF THE PLAN

The following description of the International Management Consultants, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for all eligible employees of the Company, as defined in the Plan document. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants could elect to defer any amount of their salary up to the maximum contribution allowed by law, which is \$23,000 in 2024. Certain eligible employees can make additional catch-up elective deferrals of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company made a discretionary matching contribution as determined by the Company, which was 100% of each participant's contribution, up to a maximum of 10% of participant's compensation. The cash discretionary matching contribution made for the year ended December 31, 2024 was \$1,045,249.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses). The investment of each participant's account is directed by the individual participant.

Vesting

According to the Plan document, participants are 100% vested in their own contributions plus actual earnings after 1,000 hours of service. Participants become vested in matching contributions under a "3-year cliff vesting schedule" meaning once a participant has completed 3 years of service, they will be 100% vested.

Payment of Benefits

On termination, due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of not more than the participant's assumed life expectancy. However, if the participant's vested benefit does not exceed \$5,000, it will be distributed as a lump-sum as soon as practicable. In addition, in-service distributions may be made to a participant who has not separated from service from the Company and has attained age 59 1/2.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate established by determining the rate a commercial lender would charge for a similar loan. The interest rate on outstanding loans at December 31, 2024 and 2023, ranged from 4.25% to 9.50%. Loans must be repaid by the participant within five years unless the loan is used to acquire a participant's primary residence. Loans used to acquire a primary residence may exceed five years. Principal and interest are paid ratably through payroll deductions.

Administrative Costs

Certain administrative costs of the Plan are paid by the Company.

Forfeitures

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan. Forfeitures will be applied to reduce employer contributions. Unallocated forfeitures at December 31, 2024 and 2023, were \$8,805 and \$29,245, respectively. For the year ended December 31, 2024, \$35,133 was allocated to reduce the employer's contribution.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, Company matching contributions and any discretionary profit-sharing contributions are recorded when received and are not accrued. In addition, participant loans are included on the statements of net assets available for benefits which is a modification from the cash basis of accounting as well as reporting investments to fair value. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments in mutual funds are stated at fair value. Shares of registered investment companies are valued at quoted market prices. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits – modified cash basis and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principle market is open and available to any participant in the Plan.

Purchases and sales of the registered investment company shares are recorded at end of day net asset value. Dividends are recorded as of the record date.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Management has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.

NOTE C - RELIANCE ON CUSTODIAN'S REPORT

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Ascensus Trust Company, the custodian of the Plan for the year ending December 31, 2024, and 2023, other than comparing such information to that contained in the financial statements and supplemental schedule.

NOTE D - FAIR VALUE MEASUREMENTS

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

Level 1 inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE G - TAX STATUS

The Plan participates in a plan sponsored by The Vanguard Group. The Vanguard Group has received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The Plan has been amended since receiving the letter, but the Plan Administrator believes the Plan is still in compliance with IRS requirements. The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any action or series of events that have occurred that might adversely affect the Plan's qualified status.

In accordance with the modified cash basis of accounting, plan management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - PARTY IN INTEREST TRANSACTIONS

Certain investments of the Plan are managed by the custodian. In addition, the Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions allowable under ERISA guidelines.

NOTE I - RISKS AND UNCERTAINTIES

Investments of the Plan are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect investment assets reported in participant account balances and in the statements of net assets available for benefits--modified cash basis.
