### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Mascoma Bank 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

## Notes to Financial Statements

December 31, 2024 and 2023

### 1. Description of Plan

The Mascoma Bank 401(k) Profit Sharing Plan (the Plan) was established by the Board of Directors of Mascoma Bank (the Bank) and became effective on January 1, 1988. The following description of the Plan provides only general information. Participants should refer to the Plan provisions for more information. As of January 1, 2007, the Bank elected to implement the safe harbor provisions of Section 401(k)(12) and 401(m)(11) of the Internal Revenue Code (IRC) of 1986.

#### General

The Plan is a defined contribution plan covering eligible employees of the Bank. Employees are eligible to join the Plan upon attaining age 18 and completing 90 days of service. The Plan provides for automatic enrollment of all employees upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Bank has appointed the People Resources Committee of the Bank's Board of Directors as plan trustee. The Plan is administered by an employee of the Bank who was appointed by the trustee.

#### Contributions

Contributions to the Plan are made by both participants and the Bank. Eligible employees may elect to contribute any amount from 1% to 100% of their eligible compensation up to a maximum amount allowable under federal tax regulations. Newly hired employees are automatically enrolled to defer 5% of eligible compensation. Participants can elect a different percentage or elect not to make elective deferral contributions to the Plan. The Bank contributes a match calculated as follows: 100% of the first 3% of participant's eligible compensation, and 50% of the next 2% of a participant's eligible compensation. The Plan also allows for a discretionary, nonelective contribution of 5% to eligible participants, without regard to the number of years of service. The Plan permits Roth elective deferrals.

#### Participant Accounts

Each participant's account is credited with the contributions of the participant and the Bank, and allocations of Plan earnings and administrative credits, and charged with an allocation of administrative expenses and Plan losses. Allocations are based primarily on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

If employment is terminated for reasons other than death, disability or retirement, participants are entitled to receive only their vested percentage of their account balance.

Participants have a fully vested and nonforfeitable interest in elective deferrals, qualified nonelective contributions, employer matching contributions, and rollover contributions, plus actual earnings thereon. The vesting schedule for the discretionary nonelective contributions and earnings thereon for the three-year cliff vesting are as follows:

**Participant Withdrawals**

The Plan provides for participants to withdraw their funds at any time upon attainment of the normal retirement age (65 years old) as stated in the Plan document. Such withdrawals are based on the amount in the participant's accounts as of the valuation date coinciding with or immediately after the participant's retirement date. The Plan also provides for withdrawals in the event of death, disability, hardship, termination or early retirement. The Plan allows for withdrawals upon early retirement at age 55 and completion of ten years of service. The Plan allows for in-service withdrawals once the participant reaches age 59<sup>1</sup>/<sub>2</sub>. The Plan provides for automatic distribution to terminated participants of their entire vested balance which does not exceed \$5,000.

**Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balance, subject to Internal Revenue Service (IRS) limitations. The minimum loan amount is \$1,000 and a participant may only have two loans outstanding at one time. Loans are repaid, with interest, through payroll deductions, normally within five years. All loans bear interest at a rate reasonable at the time of application, considering the purpose of the loan and the rate being charged by representative banks in the local area for a similar loan, unless T. Rowe Price Trust Company (T. Rowe Price) or the Bank sets forth a different method for determining loan interest rates in its loan procedures.

**Administrative Expenses**

Substantially all administrative expenses are paid by the Plan.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

#### Investments

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of the common/collective trust are valued at the underlying net asset value (NAV) of the units held by the Plan at year-end. The common/collective trust seeks to provide stability of principal while earning income consistent with money market rates over the long term. See Note 7 for a discussion of fair value measurement.

Common/collective trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. Advanced written notice of either 12 or 30 months may be required in certain circumstances.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Forfeitures

Forfeitures are used to first pay Plan expenses and then to reduce employer contributions. There were no unallocated forfeitures at December 31, 2024 and 2023.

### **Subsequent Events**

Management has considered transactions or events occurring through July 15, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Tax Status**

The Plan obtained its latest advisory letter on August 19, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **4. Information Prepared and Certified by Trustee**

The investments, notes receivable from participants, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by T. Rowe Price Trust Company (T. Rowe Price) as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

### **5. Party-in-Interest**

Certain Plan investments are shares of registered investment companies managed by T. Rowe Price. Additionally, as of December 31, 2024, the Plan's common/collective trust investment is a contract with T. Rowe Price. T. Rowe Price is the trustee as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions.

The Plan had a revenue sharing account in 2024, whereby the Plan received \$109,493 from an investment fund provider to offset fees for services provided to the Plan. The amounts received were recorded as other income. Administrative expenses of \$64,754 were paid to service providers, including T. Rowe Price. These transactions qualify as party-in-interest transactions.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

### 7. Fair Value Measurement

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the quoted NAV of units held by the Plan at year-end.

*Common/collective trust:* Valued using the market approach based on the NAV of the units held by the Plan at year-end. The NAV is provided by the trustee and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
