

**NOTE 1 – DESCRIPTION OF PLAN**

Chickasaw Nation Industries, Inc. sponsors the Chickasaw Nation Industries, Inc. 401(k) Plan (the Plan). The Plan allows for other employers to adopt its provisions. Chickasaw Nation Industries, Inc. and the participating employers are hereinafter collectively referred to as the Company or Employer. The Plan was effective January 1, 2003 and was amended and restated effective February 12, 2024, to affect recent plan amendments and to comply with current laws and regulations. The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established for the benefit of the Company's employees, except for:

- Union employees covered by a collective bargaining agreement, unless their collective bargaining agreement specifically states that the Union employees can participate in the Plan;
- Nonresident aliens with no U.S. source income;
- Leased employees;
- Employees of any Controlled Group Employer (or affiliated service group employer) that does not affirmatively adopt the Plan;
- Noncorporate employees of the Company who are not considered overhead;
- Noncommercial employees who are not considered corporate overhead;
- Nongeneral and nonadministrative employees of a participating employer who are not considered overhead; and
- Intermediary Pool Program Managers who do not manage two or more contracts or groups of employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the CNI Retirement Committee, which is a committee appointed by the Company's Board of Directors. Lincoln Financial Group Trust Company, Inc. serves as the trustee of the Plan, processes and maintains records of the participant data, and holds the Plan's assets.

Eligibility: All non-excluded employees of the Company are immediately eligible to participate in the Plan on their date of hire.

Effective January 1, 2024, the Plan amended the definition of eligible employees to exclude Collectively Bargained Employees, Non-resident aliens with no U.S. source income, Leased Employees, as well as to exclude all employees of participating employers except the following: (1) LLC Managers and above, including Senior Vice Presidents, (2) Employees of CNI Government, LLC, (3) Employees of CNI Commercial, LLC, and (4) Employees of Chickasaw Nation Industries, Inc.

Contributions: Participants may contribute up to 80% of their compensation, as defined in the Plan document, as either pretax, Roth, or after-tax deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, effective January 1, 2024, a participant may elect to covert all or any portion of their non-Roth vested account balance to an In-Plan Roth conversion account. Participants may also contribute amounts representing distributions from other qualified plans as rollover contributions.

Eligible employees are automatically enrolled in the Plan with a 5% deferral rate. The Plan provides an employee a 60 day opt out period before becoming subject to the automatic contribution arrangement. Eligible employees who do not wish to participate in the Plan may affirmatively elect to opt out, or they may elect a different deferral percentage.

The Plan also provides for Employer safe-harbor matching contributions equal to 100% of deferrals up to 5% of a participant's eligible compensation. Employer matching contributions are based on deferrals made each payroll period.

Additional amounts may be contributed by the Employer under the Plan's nonelective provisions at the discretion of the Company's Board of Directors. Allocations of Employer nonelective contributions are based on the proportion of each participant's compensation to the total of all participants' eligible compensation. No Employer nonelective contributions were made for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Internal Revenue Code (IRC).

Participant Accounts: Each participant's account is credited with the participant's contributions, Employer safe-harbor matching contributions, and an allocation of (a) Employer nonelective contributions and (b) Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are vested immediately in their contributions and Employer contributions, plus actual earnings thereon.

Notes Receivable From Participants: Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of the highest outstanding loan balance during the preceding 12-month period over the participant's outstanding loan balance as of the date such loan is made, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is based on prime rate plus 1% on the date of origination. Participants may only have one loan outstanding at any given time. Terms range from one to five years or up to ten years for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000. Automatic distributions made without the participant's consent are rolled into an individual retirement account designated by Lincoln Financial Group Trust Company, Inc. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 70½ before January 1, 2020, or age 72, if age 70½ is reached on or after January 1, 2020. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

The required beginning age for distributions was increased to age 73 for participants born between 1951 and 1959, effective January 1, 2023. Additionally, Roth account balances are now exempt from lifetime RMDs, aligning with Roth IRA treatment. In addition, the Plan increased the involuntary distribution threshold from \$5,000 to \$7,000 for automatic rollovers without participant consent, effective April 1, 2024.

Forfeitures: Forfeitures may be used to restore participant balances previously forfeited, to reduce Employer contributions, to pay Plan administrative expenses, or may be reallocated to participants in the order determined by the Plan administrator at its sole discretion.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 18, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit responsive investment contract, are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional annuity benefit responsive investment contract with Lincoln National Life Insurance Company (Lincoln National). This contract meets the fully benefit responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Lincoln National is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Lincoln National but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract is dependent on Lincoln National's ability to meet its financial obligations. Lincoln National's ability to meet its contractual obligations may be affected by future economic and regulatory developments. No event will result in the Plan not being able to receive contract value over a five-year installment period.

Any of the following events can trigger termination by Lincoln National, resulting in the Plan not being able to receive immediate contract value:

- Any charges billed to the contract owner that have not been paid to Lincoln National within 30 days;
- The Plan ceases to meet the requirements of the Code for purchasers of this contract;
- At any time following the end of the third contract year, the contract owner's account balance is less than \$15,000;
- At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000;

- The contract owner fails to furnish requested information or other documentation;
- Lincoln National discovers any misrepresentation of material information;
- Lincoln National discontinues offering this contract form to the public; and
- The Plan terminates its recordkeeping agreement with Lincoln Financial Group Trust Company, Inc.

Upon occurrence of any of these events, a market value adjustment or other withdrawal restriction may apply. The Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurrence.

**NOTE 6 – PARTY IN INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds an unallocated investment contract with Lincoln National Life Insurance Company, which is an affiliate of Lincoln Financial Group Trust Company, Inc. Lincoln Financial Group Trust Company, Inc. and its affiliates are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The IRS issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
