Notes to Financial Statements

1. Description of the Plan

The following brief description of the High Point University Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of High Point University (the “University” or “Employer”). The Plan provides for both elective and mandatory employee contributions. All employees of the University, except for students enrolled and attending classes offered by the University, are immediately eligible to make elective employee contributions. Those employees completing 1,000 hours of service in a consecutive 12-month period and having attained age 21 are required to make mandatory employee contributions. Employees may receive credit for hours worked at other institutions of higher education for meeting the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

The Plan requires eligible employees to contribute 5% of eligible compensation. Participants may also elect to make additional pre-tax or after-tax (“Roth”) contributions not to exceed limits established by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). Participants who have attained age 50 are eligible to make catch-up contributions. The University may make matching contributions of 100% up to 8% of eligible participant compensation, which it did during 2024 and 2023.

Participant Accounts

Participants may direct the investment of their account balances into various investment options offered by the Plan. Each participant account is credited with the participant’s and University’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their account balance plus actual earnings thereon. Vesting in the University’s contributions, plus any earnings thereon, is based upon years of service according to the following schedule:

<u>Years of Continuous Service</u>	<u>Vesting Percentage</u>
Less than 3	0%
3	100%

Benefit Payments

Upon termination of service, a participant or beneficiary can elect to receive an amount equal to the value of the participant’s vested account in the form of a lump-sum distribution or certain annuity options. Participants who have reached age 59½ may receive in-service distributions of their elective contribution balance. Withdrawals of elective contributions may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

Forfeitures

Forfeitures from non-vested participant accounts are used to reduce future University contributions and administrative expenses of the Plan. During 2024 and 2023, forfeitures of approximately \$346,000 and \$327,000 were used to offset University contributions and administrative fees. As of both December 31, 2024 and 2023, there were approximately \$10,000 of forfeited non-vested accounts available to offset future University contributions.

1. Description of the Plan (Concluded)

Notes Receivable from Participants

Participants may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are generally up to five years and only one loan may be outstanding at a time. The notes are secured by the vested account balance in the participant's account and bear interest at the prime rate plus 1% at the date of application. Principal and interest are paid by participants directly to the Plan.

Administrative Expenses

The Plan absorbs substantially all expenses of the Plan, including trustee and asset fees. Distribution and loan fees are paid out of affected participant accounts. Fees incidental to the administration of the Plan are paid by the University.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan's investment in the TIAA Traditional Account is stated at contract value which equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals, and net of any transfers.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amount of changes in net assets available for benefits during the period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through July 22, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The University has adopted a prototype plan document sponsored by TIAA within the meaning of the Internal Revenue Code ("IRC") Section 403. The IRS has determined and informed TIAA by a letter dated August 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Board of Trustees of the University reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participant accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Certain investments of the Plan are managed by TIAA-CREF, which also serves as the recordkeeper of the Plan. Administrative and investment fees paid by the Plan to TIAA-CREF and bundled service providers were approximately \$443,000 and \$349,000 in 2024 and 2023.

Fees paid to CBIZ Investment Advisory Services, LLC for administrative services were approximately \$91,000 and \$73,000 in 2024 and 2023.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds (including those held in self-directed accounts): Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Registered investment companies: Valued at the NAV of shares held by the Plan at year-end. The NAV is generally valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investment, including matrix pricing. Each unit value is determined daily and is classified within Level 1 of the valuation hierarchy.

Real estate separate account: The TIAA Real Estate Account is an insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. Its value is principally derived from the market value of the underlying holdings which are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. The account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Each unit value is determined daily and is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Investments at Contract Value

Investments at contract value are comprised of the TIAA Traditional Account which is a fixed rate annuity contract that is fully and unconditionally guaranteed and backed by the claims-paying ability of TIAA. The TIAA Traditional Account provides a guarantee of principal plus a guaranteed minimum rate of interest as declared for each year. The declared interest rate was 5.25% and 6.00% at December 31, 2024 and 2023, respectively.

When the investment is converted to an annuity based upon life expectancy, the present value of the stream of payments is equal to the balance at conversion. The TIAA Traditional Account is not available for sale or transfer on any securities exchange and is stated at contract value which equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals, and net of any transfers.
