## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee  
C & D Lumber Company Employees Retirement Plan  
Riddle, Oregon

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C & D Lumber Company Employees Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 25, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the year then ended November 25, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C & D Lumber Company Employees Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 25, 2024 and December 31, 2023, and for the year ended November 25, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of C & D Lumber Company Employees Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Basis of Accounting**

As discussed in Notes 1 & 2 to the financial statements, the governing body of C & D Lumber Company Employees Retirement Plan approved a plan of liquidation on June 10, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of C & D Lumber Company Employees Retirement Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule as listed in the accompanying table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of C & D Lumber Company (Company) Employee Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a self-directed, defined contribution profit sharing plan with an elective section 401(k) salary reduction option. All eligible employees are able to participate in the Plan, with respect to making salary reduction contributions and receive the employer discretionary match, after completing six months and 500 hours of service. Eligible employees qualify to participate in the profit sharing portion of the Plan after completing twelve consecutive months of employment and 1000 hours of service with the Company. To participate in employer profit sharing contributions, an employee must be employed by the Company on the last day of the year. The Plan maintains monthly entry dates of the first day of each month. The profit sharing plan was established in 1969, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent qualified retirement plan legislation. The Plan Sponsor adopted a provision to terminate the plan effective June 10, 2024 and the Plan was officially liquidated as of November 25, 2024.

Contributions

Participants may elect to voluntarily contribute to the Plan for their own benefit. Participant voluntary contributions are elective and permit participants' contributions to be funded through salary reductions under the Section 401(k) provisions of the Plan. Participant contributions can be pre-tax or Roth deferrals, or both. The Plan provides for an automatic 4% pre-tax salary reduction deferral for newly-eligible participants, unless they make a positive election to waive the deferral or change the deferral options.

Contributions from the Company are made at the discretion of the Company's Board of Directors. The discretionary employer match is determined annually and is contributed with each payroll deferral. The employer profit sharing contribution is determined annually and contributed in one annual amount, as applicable.

The Company elected not to make profit sharing contributions for the year ended November 25, 2024 and December 31, 2023. The Company provided an employer match of 50% of the first 4% of deferrals for the years ended November 25, 2024 and December 31, 2023.

Participants are limited in their Section 401(k) contributions by discrimination testing of Section 401(k) of the Internal Revenue Code. The maximum Section 401(k) contribution amount, per participant, was \$23,000 and \$22,500 for 2024 and 2023 respectively. However, for participants age 50 and above, additional "catch-up" contributions were allowed, up to \$7,500 and \$7,500 for 2024 and 2023 respectively, for a total annual amount of \$30,500 and \$30,000 for 2024 and 2023 respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer discretionary matching contribution, and an allocation of (a) the Company's profit sharing contribution and (b) Plan earnings, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company's profit sharing and matching contributions to their accounts plus the earnings thereon based on years of continuous service. A participant is 100% vested after six years of credited service, based on a graded vesting schedule. Effective June 10, 2024, the date of termination, all participants were immediately vested in the Company's profit sharing and matching contributions.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Investment Options

Upon enrollment in the Plan, each participant elects to self-direct the investment of their entire account balance in 1% increments, which are limited to any of the investment funds offered by and entrusted to the custodian. Participants may change their investment options daily.

Participants Loans

Under the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of 50% of the participant's vested account balance or \$50,000, determined immediately before the loan and reduced by the amount of any unpaid principal on any other loans secured by the vested portion of the account. Loan transactions are treated as a transfer from (to) the investment funds to (from) the Loans to Participants account. Interest earned is recorded in the Interest on Participant Loans account. Loans are made for terms not to exceed 5 years, unless for the purchase of a primary residence, for which the loan term may be up to 30 years. A participant may not have more than two loans outstanding at any time.

Loans are secured by the balance of a participant's vested account balance, and bear a reasonable rate of interest determined by the Administrator after reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Any Plan benefits are paid from net assets available for benefits. The benefit to which a participant is entitled is the benefit that can be provided by the accumulation of contributions from the employer including earnings; forfeitures from partially vested former participants and income thereon, including net realized and unrealized investment gains and losses allocated to such participant's account; and if a participant has elected to make voluntary contributions, the value of their separate voluntary account including earnings.

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump-sum amount, installments, or an annuity contract. For termination of service due to other reasons, a participant receives the value of the vested interest in his or her account as a lump-sum distribution.

Participants may receive in-service distributions from their fully-vested accounts upon attainment of age 59 ½. The Plan also allows withdrawal from elective deferral and rollover accounts on account of hardship.

Forfeited Accounts

Forfeitures of unvested employer contributions are to be used to pay for plan expenses and any remaining forfeitures can be used to reduce future employer contributions. Forfeited non-vested accounts totaled \$0 as of November 25, 2024 and \$61, as of December 31, 2023. Earnings on forfeitures for the year ended November 25, 2024 and December 31, 2023 were \$213 and \$65 respectively. Forfeitures totaling \$20,159 and \$9,084 were used to offset Plan expenses during the years ended November 25, 2024 and December 31, 2023, respectively.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

As noted above, effective June 10, 2024, the Retirement Committee elected to terminate the Plan. The Plan was terminated as a standard termination and the Plan has changed its basis of accounting from the ongoing plan basis, used in presenting the December 31, 2023, financial statements, to the liquidation basis used in presenting the November 25, 2024, financial statements in accordance with Generally Accepted Accounting Principles (GAAP). The liquidation basis of accounting is a basis of accounting under GAAP for terminating plans.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various mutual fund options that have different investment strategies. These mutual funds are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income are recorded on the accrual basis of accounting. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of November 25, 2024 and December 31, 2023.

Payment of Benefits

Benefits are recorded when paid. At November 25, 2024 and December 31, 2023, there were no benefits which had been requested but not yet paid.

Administrative Expenses

The Plan's accounting and legal expenses are paid with accounts forfeited during the year. In the event these expenses exceed the forfeited accounts, the Company will pay the balance. Third-party administrator fees and investment fees are allocated to individual participant accounts as asset management charges. Loan origination fees, loan maintenance fees and fees for distributions are paid directly by the individual participants. For fees paid directly by the Plan Sponsor see Note 4.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 25, 2024 December 31, 2023.

- *Money Market and Mutual funds:* Valued at the net asset value of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The fees paid directly by the plan sponsor on the Plan’s behalf totaled \$34,240 and \$23,315 in 2024 and 2023 respectively. These fees covered the cost of the Plan’s third-party administration and audit services, which are considered parties-in-interest.

**NOTE 5 – TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – INFORMATION CERTIFIED BY CUSTODIAN**

The plan administrator has elected the method of compliance as permitted by Section 29 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the custodian of the plan, has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of November 25, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended November 25, 2024.
- Investments reflected on the schedule of assets (held at year end).
