## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kulzer, LLC 401(k) Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Notes to Financial Statements

---

#### Note 1. Plan Description

The following description of Kulzer, LLC 401(k) Savings and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established effective July 1, 2013, by Kulzer, LLC (the Company) and is a defined contribution plan covering substantially all employees of the Company who are not a member of a unit of employees covered by a collective bargaining agreement, a leased employee or a non-resident alien. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a portion of their pre-tax and/or post-tax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to provide safe-harbor contributions and, therefore, is required to match up to 5% of participating employees' compensation depending on the employee's contribution percentage. Company contributions are invested into the various investment options in a manner that is consistent with participant contributions. Contributions are subject to certain limitations.

The Company may also make a discretionary profit-sharing contribution. Participants must be employed at the end of the plan year and have completed 1,000 hours of service to be eligible for the employer discretionary profit-sharing contribution allocation. Employer contributions are subject to certain limitations. No discretionary profit-sharing contributions were contributed by the Company in 2024.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, (b) Plan earnings, and (c) forfeitures of terminated participant's non-vested accounts (if applicable) and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in nonelective safe harbor company matching contributions and their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions is based on years of service with the Company, as defined in the Plan Agreement, based on the following schedule: less than 2 years—0%, 2 years—20%, 3 years—40%, 4 years—60%, 5 years—80%, 6 years—100%. Participants are immediately vested in the discretionary profit-sharing contributions at the time of death or disability.

**Payment of benefits:** On termination of service due to death, disability, retirement, or other reasons, participants receive a single lump-sum payment in an amount equal to the value of the participant's vested account. Benefit payments are recorded when paid.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the third-party administrator. Principal and interest are paid ratably through payroll deductions.

#### Note 1. Plan Description (Continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant loans are reclassified as distributions based upon the terms of the Plan document.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Forfeited accounts:** If a participant is not fully vested on his or her termination date, the non-vested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions. At December 31, 2024 and 2023, forfeitures of non-vested balances were not material.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with the accounting principles generally accepted in the United States of America.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Guaranteed investment account:** Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### Note 2. Significant Accounting Policies (Continued)

**Fair value measurements:** The accounting standards board establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

**Pooled separate accounts:** Valued at the total of the net asset value (NAV), as a practical expedient, of shares of mutual funds and cash held by the account at year-end. The Plan's interest in the pooled separate accounts is valued based on the information reported by the investment advisor.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosed through July 17, 2025, the date the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

#### **Note 5. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **Note 6. Party-in-Interest Transactions**

All Plan investments are managed by Standard. Standard is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the trustee of the Plan for the year ended December 31, 2024, totaled approximately \$10,000.

#### **Note 7. Income Tax Status and Uncertain Tax Positions**

The Plan adopted a volume submitter plan sponsored by Standard Retirement Services, Inc. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan's Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

#### **Note 8. Guaranteed Investment Contract With Standard Insurance Company (Standard)**

The Plan entered into a fully benefit-responsive contract with Standard. Standard maintains the contributions in a general account. While Standard declares rates periodically and backs the principal and interest, any guarantees are subject to the claims paying ability of the insurance company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value fund issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. At December 31, 2024 and 2023, the value was \$1,768,557 and \$1,489,577, respectively.

As described in Note 2, because the stable value fund contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note 8. Guaranteed Investment Contract With Standard Insurance Company (Standard) (Continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The stable value fund contract has a portfolio investment rate design in which all deposits in the particular investment choice are credited with the same interest rate on a daily basis. The effective credited interest rate is set quarterly and is effective on January 1, April 1, July 1, and October 1. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (2) changes to Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The stable value fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
