### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Basin Electric Power Cooperative WY/NE Union 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Basin Electric Power Cooperative WY/NE Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Basin Electric Power Cooperative WY/NE Union 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Basin Electric Power Cooperative WY/NE Union 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. DESCRIPTION OF PLAN**

The following description of the Basin Electric Power Cooperative WY/NE Union 401K Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**—Basin Electric Power Cooperative (the Cooperative) established the Plan and serves as the Plan Administrator. The Plan is a defined contribution plan established under the provisions of section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Cooperative. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ERISA.

The Investment Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Participant Eligibility**—Eligible employees include all Cooperative employees assigned to the Laramie River Station and Laramie River Transmission System Maintenance covered by a collective bargaining agreement. Eligible employees may become participants in the Plan on the date of employment with the Cooperative. However, Cooperative matching contributions will not commence for a participant until the first day of the month coincident with or following the date that the participant has completed one full year of eligibility service (as defined by the Plan). A full year/month of service is defined as 1,000/84 or more hours during the first year/month of employment. To become a participant, employees must also be either represented by or be a member of Local Union 612, International Brotherhood of Electrical Workers, which has a collective bargaining agreement with Basin Electric Power Cooperative. The employee is not eligible if they are a student intern, tour guide, security guard, leased employee, or are classified as other than an employee of the Cooperative and subsequently determined to have been an employee.

**Contributions**—Participants may make two types of contributions under the Plan – pre-tax 401(k) contributions and Roth 401(k) contributions. Roth 401(k) contributions are made on an after-tax basis. Participants may choose to make pre-tax 401(k) contributions or Roth 401(k) contributions, or both. Eligible employees may contribute an amount up to 80% of compensation as defined by the Plan, limited by requirements of the IRC. Participants may also roll over distributions from other qualified defined benefit or defined contribution plans.

The Cooperative provides a 1% Fixed Employer Contribution on behalf of each participant. For participants hired before June 1, 2006, the Cooperative provided matching contributions to the Plan equal to 100% of the participant's contribution up to a maximum of 4%. For participants hired after June 1, 2006, the Cooperative provides matching Contributions to the Plan equal to two times the participant's contribution up to a maximum of 7%. The matching contribution amount is based on years of employment, with the maximum match received after 4 years of employment. If age 50 or older at any time during the calendar year, the participant may make additional contributions called catch-up contributions. Catch-up contributions may be designated as pre-tax 401(k) contributions or Roth 401(k) contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled to contribute to the Plan on the first payday following at least 30 days of employment unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a Target Retirement Fund until changed by the participant.

The Plan allows participants to convert previous pre-tax contributions to Roth contributions.

Certain terms in the collective bargaining agreement between the Company and Local Union 612, International Brotherhood of Electrical Workers, became effective March 1, 2024. One such term was the change in availability of pension plan benefits. Effective March 1, 2024, any new employees will not be eligible for pension plan benefits. Rather, the new employees shall be considered a "Qualified Employee for Enhanced Matching Contributions" under the Plan.

**Participant Accounts**—Individual accounts are maintained for each Plan participant to reflect the participant's share of the Plan's investment income (loss), employer contributions, the participant's contributions, and administrative expenses.

**Vesting**—Participants are fully vested in their account balances at all times.

**Participant Notes Receivable**—Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer between the investment fund and the loan fund. Currently, loans must be repaid within sixty months unless the purpose of the loan is for the purchase of a primary residence, in which case the repayment period may be up to ten years. Prior to 2006, the Plan allowed loans for the purchase of a primary residence with a repayment period of up to 30 years. No more than two loans may be outstanding at any time. All loans bear interest at 1% over prime. Principal and interest are paid ratably through semi-monthly payroll deductions. Participants do have the option to make advanced principal payments directly to Vanguard.

**Benefits**—Upon termination of service, death, disability, hardship, attainment of age 59½, or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's account. The Plan allows for the participant or their beneficiary to choose the benefit in a single lump sum of cash of all or a portion of the participant's account, a series of cash installment payments, or to defer receipt of benefits to a later date. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Withdrawals for hardship may only be made from the 401(k) contribution, Roth 401(k) contribution, and catch-up contribution accounts.

**Investment Options**—Participants may direct contributions, including Cooperative matching contributions, with Vanguard Fiduciary Trust Company (the Trustee). A total of thirty-two fund options are available. Participants may change their investment elections daily within the restrictions set by Vanguard.

**Transfers in/out of Plan**—Transfers in or out of the Plan represent balances of participants moving to or from the Basin Electric Power Cooperative 401K Plan, the Basin Electric Power Cooperative ND/SD Union 401K Plan and/or the Dakota Gasification Company 401K Plan under the control of the Plan Administrator.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**—The accompanying financial statements are prepared on the accrual basis of accounting.

**Assets Measured at Fair Value**—Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. The standard applies to reported balances that are required or permitted to be measured at fair value.

ASC 820 emphasizes that fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, ASC 820 establishes a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Levels 1 and 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Level 1 inputs utilize observable market data in active markets for identical assets or liabilities. Level 2 inputs consist of observable market data, other than that included in Level 1, that is either directly or indirectly observable. Level 3 inputs consist of unobservable market data which are typically based on an entity's own assumptions of what a market participant would use in pricing an asset or liability as there is little, if any, related market activity. In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The Plan Administrator's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Shares of mutual funds of registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds (including money market mutual funds) held by the Plan are open-ended mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts are valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

**Income (Loss) Recognition**—The net appreciation (depreciation) in fair value of investments consists of the realized gains (losses) and the unrealized appreciation (depreciation) in fair value of investments during the year. Realized gains (losses) on sales of investments are computed based on the difference between the sales price and the fair value of the investments as of the beginning of the year or cost if purchased during the year. Unrealized appreciation (depreciation) is computed based on changes in the fair value of investments between years.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

**Participant Notes Receivable**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables are reclassified as distributions based upon the terms of the Plan document.

**Contributions**—Participant contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**—Benefits are recorded when paid.

**Use of Estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses**—Administrative costs of mutual funds, loan processing fees, purchase fees and redemption fees are paid directly from fund earnings or by the participants investing in those funds subject to such fees. These investment related expenses are included in net appreciation (depreciation) of fair value of

investments presented in the accompanying statements of changes in net assets available for benefits. The Cooperative pays all other administrative expenses of the Plan which are excluded from these financial statements.

**Risks and Uncertainties**—The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**3. SUMMARY OF INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

**4. INVESTMENTS**

The Trustee holds the Plan's investments and executes transactions therein. The classification of investment earnings reported in the Statements of Changes in Net Assets Available for Benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**5. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Cooperative by a letter dated May 8, 2017, that the Plan was designed in accordance with the applicable regulations of the IRC. Subsequent to this issuance of the determination letter, the Plan was amended. However, the Cooperative and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no Plan audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although the Cooperative has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. Upon termination of the Plan, all assets of the Plan would be distributed among participants in accordance with Plan provisions.

**7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The registered investment company mutual funds and common/collective trust funds are managed by the Trustee. Transactions related to these funds thereby qualify as party-in-interest transactions; however, the DOL has issued prohibited transaction exemptions indicating that these types of transactions are to be considered exempt party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investments activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**8. SUBSEQUENT EVENTS**

The Plan Administrator considered events for recognition or disclosure in the financial statements that occurred subsequent to December 31, 2024 through July 11, 2025, the date the financial statements were available for issuance.
