### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Centennial Plastics, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

---

The following brief description of the Centennial Plastics, Inc. Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Centennial Plastics, Inc. (the Company).

Employees are eligible to make pre-tax and after-tax Roth salary reduction contributions and receive employer safe harbor match and discretionary matching contributions after attaining age 21 and completing 60 days of service. To be eligible for discretionary profit-sharing contributions employees must be age 21 and have completed one year of service with the Company in which they worked at least 1,000 hours. Eligible employees become participants on the first day of the month following the date on which entry requirements were fulfilled for salary reduction and safe harbor match contributions. The entry date for discretionary profit-sharing contributions is the first day of the Plan year quarter following the date on which eligibility requirements are satisfied. Employees must be employed on the last day of the Plan year or have completed 501 hours of service during the applicable Plan year to share in an allocation of discretionary profit-sharing contributions. Employees are automatically enrolled at a deferral rate of 6% unless the Company is informed otherwise.

#### ***Effective Date***

The effective date of the Plan was January 1, 2001, and was last restated July 15, 2022.

#### ***Contributions***

Participants may make salary contributions up to 100% of annual eligible compensation as defined by the Plan, subject to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions.

The Company contributes safe harbor matching contributions equal to 100% of participants' salary reduction contributions not exceeding 1% of eligible compensation, plus 50% of salary reduction contributions in excess of 1% up to 6% of eligible compensation. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's safe harbor and discretionary match and profit-sharing contributions, b) Plan earnings or losses, and c) forfeitures of terminated participants' non-vested accounts; and charged with an allocation of administrative expenses. The Company's safe harbor and discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon each eligible participant's compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal).

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary match, profit-sharing, and safe harbor matching contributions credited to participants' accounts is based on years of continuous service. A participant is 50% vested after one year of service and vesting increases 25% per year until a participant is 100% vested after three years of service for discretionary match and profit-sharing contributions. Company safe harbor matching contributions are subject to a 2-year cliff vesting schedule. A participant becomes 100% vested in Company contributions at normal retirement age, death, or disability.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive their distribution as a lump sum, equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. Forfeited non-vested accounts may be applied to safe harbor match contributions, reallocated as additional discretionary contributions or used to reduce Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15 and \$2,289, respectively. Forfeited non-vested accounts in the amounts of \$2,906 and \$4,512 were applied to safe harbor matching contributions and Plan expenses for the years ended December 31, 2024 and 2023, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Administrative Expenses***

Administrative expenses included in the accompanying financial statements represent recordkeeping fees, third party advisor fees, custodial fees, and fees specifically incurred by or attributable to individual participants that are paid from the applicable participants' accounts. Certain investment advisory fees are covered through a revenue sharing agreement with Principal. The Company provides certain administrative and accounting services to the Plan at no cost. Audit and legal fees paid directly by the Company are excluded from these financial statements.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and plan sponsor have considered such events or transactions through July 9, 2025, noting no items requiring disclosure.

**3. Information Certified by Principal**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the certifying entity to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Pooled separate accounts (PSAs) invest mainly in stocks, single mutual funds, and fixed securities. The majority of the underlying securities have observable level 1 pricing inputs. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, the Plan believes that these investments have a "readily determinable fair value". Because it is valued similarly to mutual funds, the Plan believes its PSAs should be level 1 assets to allow for consistent disclosure. PSAs typically can be redeemed on a daily basis. Unfunded commitments typically are found in private equity funds and therefore are not applicable to PSAs.

*Common Collective Trusts:* Valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of underlying investments held by the trust less its liabilities. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or

disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

#### 7. Related Party Transactions

---

Certain plan investments are pooled separate accounts and common collective trusts managed by Principal. Principal acts as the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.
