## INDEPENDENT AUDITOR'S REPORT

To the 401(k) Staff Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

## Southern Poverty Law Center, Inc. 401(k) Retirement Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the Southern Poverty Law Center, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Refer to Plan documents for a more complete description of the Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Southern Poverty Law Center, Inc. (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”). This Plan does not cover employees who are students, interns, law clerks, and leased employees. Effective March 1, 2022, the Plan was amended to cover employees who are fellows. The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Staff Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Vanguard Fiduciary Trust Company (Vanguard), the trustee and qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Committee and provides certain recordkeeping services. Vanguard also performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees are immediately eligible to participate in the Plan upon hire provided they are not excluded from the Plan.

#### ***Contributions***

Each year, participants may contribute up to 100% of their 401(k) eligible compensation, as defined in the Plan, in pre-tax and after-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a matching contribution equal to 100% of the salary reductions up to 4% of compensation, a 3% safe harbor provision and a discretionary profit-sharing contribution to be determined annually. For 2024, the discretionary profit-sharing contributions are 3%. Safe harbor matching and profit-sharing contributions are allocated to participants based on compensation.

During the year ended December 31, 2024, the Company made a \$1,374,078 profit sharing contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## Southern Poverty Law Center, Inc. 401(k) Retirement Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Company's safe harbor contributions, the Company's discretionary contributions (if any), and allocations of the Plan earnings. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their pretax and after-tax contributions, safe harbor contributions, plus the actual earnings thereon. For employees hired prior to January 1, 2006, they are immediately vested in their matching contributions and profit-sharing contributions plus actual earnings thereon. For employees hired after January 1, 2006, they are 100% vested in the Company's matching and profit-sharing contributions after completing three years of service.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. General purpose loans are repayable through payroll deduction over periods ranging up to 60 months. Principal residence loans are repayable through payroll deductions over periods ranging up to 120 months. The interest rates range from 4.25% to 9.50% on all notes receivable from participants outstanding at December 31, 2024. Principal and interest are paid ratably through payroll deductions. A participant may have one loan outstanding at any given time. The loans are secured by the balance in the participant's account.

#### ***Benefits Payments***

A participant is entitled to a distribution of 100% of his or her account balance upon retirement, death, or disability. Upon termination of service for any other reason, the participant will receive the value of the vested portion of their account in a lump sum amount. A participant who is 59 1/2 years old or older may also take a distribution. All these participants may roll over the amount to another qualified plan, IRA or 403(b) plan so long as they meet all appropriate requirements. Effective May 1, 2019, participants may also elect to receive distribution in installment payments. Involuntary cash out distributions are made to terminated participants with balances of \$1,000 or less.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$333,137 and \$49,596, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2024, employer contributions were reduced by \$100,000 from forfeited nonvested accounts.

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Vanguard.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Excess Contribution Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, July 17, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### **Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Investment income and interest income from notes receivable information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**Note 5: TAX STATUS**

The Plan adopted a non-standardized form of a pre-approved plan sponsored by the Vanguard Group. Vanguard received an opinion letter from the IRS, dated June 30, 2020, as to the pre-approved plan's qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Vanguard. Vanguard is the trustee and record-keeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan invests in shares of mutual funds managed by an affiliate of the Trustee; therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in value of investments, as they are paid through revenue sharing, rather than a direct payment. Other amounts paid directly by the Plan to the Trustee for administrative fees, which were not covered by revenue sharing amounted to \$19,572 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
